





Kuwait suspends expats' driving license transactions indefinitely

Interior ministry mulls raft of measures to control traffic

KUWAIT: All transactions related to foreign residents' driving licenses in Kuwait have been suspended until further notice as per the orders of Interior Ministry Undersecretary Lt Gen Sheikh Faisal Al-Nawaf Al-Sabah, Al-Jarida daily reported vesterday. Nearly 700,000 driving licenses are registered to expatriates in the interior ministry's database.

Al-Jarida daily had reported on Tuesday that the interior ministry has placed a block on around 247,000 driving licenses of expatriate residents as instructed by Sheikh Faisal Al-Nawaf, and tied their issuance to meeting certain conditions. Security sources said the block prevents renewal of the license until after updating the applicant's data at the Public Authority for Manpower, especially with regards to salary, academic qualification and job description.

It is also expected the traffic department will ask all residents to replace their licenses at the start of the new year. Sheikh Faisal met senior officials and insisted on filtering the driving licenses of expats and make sure they meet the stipulations for issuance.

Meanwhile, another report raised concerns about whether the interior ministry can face the challenge of renewing an estimated one million driving licenses if all holders of old licenses are asked to replace them with the new one (with the electronic chip). "Replacing this large number of licenses requires huge numbers of employees, in addition to large stocks of magnetic cards," sources quoted by Al-Rai daily said. The interior ministry refused to comment on the reports when contacted for confirmation by Kuwait Times.

These measures come as local authorities scramble to find quick solutions to the country's debilitating traffic

jams' problem. On Monday, MP Abdullah Al-Turaiji submitted a proposal to the National Assembly calling to restrict vehicle ownership by expatriates to only two and impose extra fees on any additional vehicles, saying the proposal aims at reducing traffic jams.

Turaiji's proposal calls on the interior ministry to take the necessary measures to restrict the number of vehicles foreign residents can own for personal use to only two "to counter the illegal trade in vehicles, reduce traffic jams" and "ensure there are enough spaces for the use of Kuwaiti citizens at commercial

malls, markets and public places".

The proposal states that if residents want to own more than two vehicles, they should apply to the traffic department, and if approved, they must pay extra fees for additional vehicles. The lawmaker said there are scores of dilapidated vehicles on Kuwaiti roads owned by expatriates, causing traffic jams, chaos and accidents. He added that these vehicles are normally parked in public squares and car parks of schools, mosques and commercial malls, and efforts by the Municipality have failed to resolve this problem.

DUBAI: The United Nations cultural agency yesterday added Bahrain's Fjiri musical performance, which commemorates the history of pearl diving, to its list of "intangible" heritage. "Dating back to the late 19th century, it was traditionally performed by pearl divers and pearling crews to express the hardships faced at sea," UNESCO said on its website. "The performers sit in a circle, singing and playing different types of drums, finger chimes and a jahl, a clay pot used as an instrument," it added. — AFP

Hamilton knighted after heartbreak

WINDSOR: Lewis Hamilton has been knighted in recognition of a glittering career in Formula 1 just days after he controversially lost out on a record eighth title. Hamilton was appointed a knight by the Prince of Wales during a Windsor Castle investiture ceremony yesterday, but he declined to speak to reporters afterwards. He was joined by his mother Carmen Lockhart and was all smiles as they posed for pictures in the castle's quadrangle.

Biggest global debt increase

WASHINGTON: Global debt rose to \$226 trillion in 2020 after seeing its biggest yearly increase since World War II, with richer nations doing most of the borrowing, the IMF said yesterday. Global debt now stands at 256 percent of GDP, a high level that countries across the world will have to consider as they seek to revitalize their economies from the COVID-19 downturn while dealing with new variants such as Omicron. — AFP

Queen meets **Oman Sultan**

LONDON: Queen Elizabeth II yesterday made a rare public appearance, hosting Oman's Sultan Haitham bin Tareq and his wife, Sayyida Ahad bint Abdullah, at Windsor Castle. The 95year-old monarch has cut back on her engagements since an overnight hospital stay in October that raised fears for her health and prompted doctors to

Buckingham Palace confirmed in a statement that she met the Sultan, 66, at her historic residence west of London, without giving further details. The two heads of state, and Sayyida Ahad, 51, were pictured smiling and shaking hands. The Gulf state ruler, a former culture and heritage minister who studied at Oxford University, came to power after the death of his cousin, Sultan Qaboos, last year. He had been the Arab world's longest-serving ruler.

Queen Elizabeth II next year marks her 70th year on the throne - a record in British history. The monarch moved to Windsor in March last year and effectively self-isolated from the coronavirus pandemic with her husband, Prince Philip, because of their age. Philip died aged 99 in April after a month-long stay in hospital with a heart condition. The Queen resumed duties after his funeral and the official mourning period.

But since her hospital stay, at which she underwent unspecified tests, she has only been undertaking what palace officials said were light duties, including online meetings. Britain is facing a new wave of infections from the Omicron strain of the virus, prompting the government to impose new restrictions and warnings about social gatherings.

Armed with drones, Turkey explores arms sales to Africa

ISTANBUL: Armed with battle-tested drones, Turkish President Recep Tayyip Erdogan has been deepening defense ties with African countries ahead of a major gathering of the continent's leaders in Istanbul. The two-day Turkey-Africa partnership summit starting Friday comes fast on the heels of a top-level business forum in October that focused on investment and trade. The next phase of this fast-blossoming relationship is security, experts say, with a host of African leaders looking to buy up

military hardware at cheaper prices and with fewer strings attached.

Leaders and top ministers from 39 countries including 13 presidents - have confirmed attendance, with Erdogan set to make a speech on Saturday. Ankara already has a military base in Somalia, and Morocco and Tunisia reportedly took their first delivery of Turkish combat drones in September. Angola became the latest to express an interest in unmanned aerial vehicles (UAVs) during Erdogan's first visit to the southern African country in October.

Turkey in August also signed a military cooperation pledge with Ethiopian Prime Minister Abiy Ahmed, who has been embroiled in a war with Tigrayan rebels for the past year. "The most important sector is the defense sector because this is a new asset.

In Bethlehem, **Omicron ruins** Xmas boom

BETHLEHEM: After collecting dust for nearly two years, the 228 rooms at Bethlehem's Ararat Hotel were scrubbed last month in anticipation of a post-lockdown Christmas boom, hopes that have again been dashed by the coronavirus. A large Christmas tree and decorations did little to brighten a deserted lobby. Like other hotels in Bethlehem, the Ararat has no guests, with the tree offering cheer to

no one but the seven out of 105 employees who have not been fired.

"We were expecting 70 percent occupancy for Christmas but all overseas reservations have been cancelled," said Augustine Shomali, a manager at the hotel. The people of Bethlehem - a Palestinian city in the occupied West Bank considered the place of Christ's birth according to Christian tradition - are used to welcoming an influx of tourists each December.

After a near-total pandemic lockdown last year, Bethlehem began to hope for a joyous Christmas when the Zionist entity, which controls all access points to the city,

French lawmaker to visit Kuwaiti parliament: Envoy

MP Amelia Lakrafi to meet Speaker Marzouq Al-Ghanem today

KUWAIT: Ambassador of France to Kuwait Claire Le Flecher announced the arrival of French MP Amelia Lakrafi, who will meet National Assembly Speaker Marzouq Al-Ghanem today. "Today we are happy to receive our French MP Amelia Lakrafi to strengthen our parliamentary cooperation," she said during a press conference yesterday. "We believe Kuwait has strong parliamentary traditions and we value their traditions highly. With her visit, we are going to explore how the two parliaments can cooperate to strengthen our ties. Lakrafi is an advocate of women's rights and is scheduled to meet some Kuwaiti women. The Middle East region is her region of focus. She will also meet French school and institute officials," Le Flecher said.

"Within the framework of my mandate, I want to work on strengthening the attractiveness and influence of French companies in Kuwait. The upcoming signing of an MoU between French businesses and Kuwait Direct Investment Authority will promote investment between the two countries. We also wish to develop the working relationship with major Kuwaiti investors and financial players, both public and private," she said.

The ambassador also mentioned strengthening military cooperation between France and Kuwait, recalling the participation in the 1990-1991 Gulf War of 15,000 French troops to liberate Kuwait

from Iraqi occupation. "Our military ties continue, and I would like to reinforce and develop them further, especially over training and exercises with the national guard and national police. I will also focus on strengthening intelligence-sharing. In early 2022, we shall complete the delivery of Caracal helicopters, and have scheduled military exercises at the end of 2022," she said.



Strong friendship

The envoy, who was speaking in her first meeting with reports since assuming her post in Kuwait, also spoke about her encounter with HH the Crown Prince when she presented her credentials. "I presented my credentials to HH the Crown Prince recently. Now I can represent my country and the French people at any official function since I am

now fully recognized and authorized to do so. I was honored to present my credentials to HH the Crown Prince. I was the first ambassador he received (after HH the Amir delegated some of his powers to his deputy). We spoke about comprehensive cooperation between our two countries," Le Flecher said.

"He mentioned our strong friendship and cooperation and invited President Macron on a state visit to Kuwait. I went back to France recently to convey the message to our president. It was received by authorities in France positively and they'll be working on the schedule considering some factors, including the upcoming election in April and May, France taking the helm of the EU from Jan 2022 plus the current coronavirus situation in Europe. These factors may slow the process, but he is more than willing to come over," she emphasized.

The envoy highlighted her country's 2022 action plan, especially on celebrating 60 years of diplomatic ties with Kuwait. "I am lucky, because this year we are also celebrating our 60th year of friendship. This is a very special year for both of us. On August 28, 1961, France was one of the first countries in the world to recognize Kuwait. France has a multidisciplinary presence in Kuwait - we have the embassy, economic services, businesses and cultural and educational institutes. All these are just some of the tools which help strengthen bilateral relations between France and Kuwait," Le Flecher said.

"I wish to continue the strategic dialogue in Kuwait that we started, this time on the ministerial level. I hope it will push through, but we are all aware of the current coronavirus situation all over the world and in Europe. Migration, security, health, defense, trade, investment and development, Francophone, education, and culture are all on the agenda. We are positive that after the dialogue, a number of agreements will be signed,"

Indian PM Modi to visit Kuwait in Jan: Report

NEW DELHI: Indian Prime Minister Narendra Modi is planning a visit to Kuwait in the first week of January, the Economic Times reported. This will be first PM level visit from India to Kuwait in 40 years, notwithstanding the fact Kuwait is one of India's key oil suppliers and hosts a big diaspora in the region. Enhancing Kuwaiti investments to India and putting in a place a defense partnership is on the cards for the visit. Modi had visited all other five Gulf states since 2015 except Kuwait, and the trip is expected to upgrade ties to the next level. Approximately one million Indians are based in Kuwait; the largest expatriate community in Kuwait. The year 2020-21 marked the 60th anniversary of establishment of diplomatic relations between two countries. India has been a natural trading partner of Kuwait and until 1961, the Indian Rupee was the legal tender in Kuwait.

India has consistently been among the top ten trading partners of Kuwait and bilateral trade for FY 2020-2021 stood at \$ 6.27 billion. Kuwait remains a reliable supplier of crude oil and LPG to India, officials informed. So far, Kuwaiti investments in India are over \$ 5.5 billion, majority of which is by Kuwait Investment Authority (KIA), which has been invested in companies like GMR Infrastructure Ltd, Interglobe Aviation's (Indigo Airlines) IPO, Bombay Stock Exchange and Power Grid Corporation of India Ltd. KIA wants to exponentially enhance its presence in India across sectors, officials indicated.

Ties received a boost when Kuwait emerged as the biggest supplier of liquid medical oxygen during the second COVID wave here in April-May. The Kuwaiti Cabinet issued a statement in support of India and sent liquid medical oxygen to India over many cycles of an air and sea bridge. Earlier, an Indian medical team travelled aboard a special aircraft from India to Kuwait in April 2020 to help fight COVID-19 in Kuwait.

In June, external affairs minister S Jaishankar visited Kuwait and called on the prime minister to deliver a letter from Modi to the Amir of Kuwait. During the visit a MoU for 'Cooperation in the Recruitment of Domestic Workers' was signed and it was decided to hold a joint Ministerial meet of Foreign and Commerce Ministers. Last year, then Indian petroleum and natural gas and steel minister Dharmendra Pradhan visited Kuwait to offer condolences on the demise of the late Amir of Kuwait Sheikh Sabah Al-Ahmad Al-Jaber Al-Sabah — a trip that helped to upgrade ties.

Turkey has pushed this sector a lot, especially drones," Federico Donelli, an international relations researcher at the University of Genoa, told AFP.

Russia has been the dominant player on the African arms market, accounting for 49 percent of the continent's imports between 2015 and 2019, according to the Stockholm International Peace Research Institute (SIPRI). But interest in Turkish weaponry is peaking. The TB2 Bayraktar model is in high demand after it was credited with swinging the fate of conflicts in Libya and Azerbaijan's breakaway region of Nagorno-Karabakh in the past few years.

The drones are made by the private Baykar company, run by one of Erdogan's sons-in-law. "Everywhere I go in Africa, everyone asks about UAVs," Erdogan boasted after a visit to Angola, Nigeria and Togo in October. Some of the closest scrutiny has focused on Turkey's ties with Ethiopia, where a brutal conflict has killed thousands, displaced more than two million and driven hundreds of thousands into famine-like conditions, according to UN estimates.

A Western source said Turkey sent an undisclosed number of combat drones in support of Abiy's campaign earlier this year, but that Ankara has since responded to international pressure and halted the sales. "Ethiopia can buy these drones from whoever they want," Turkey's foreign ministry spokesman said in October, neither confirming or denying the sales.

Official Turkish data does not break down the details of military sales to individual countries, only giving the total sales amount for each month. These have soared spectacularly in the past year. Turkish defense and aviation exports to Ethiopia rose to \$94.6 million between January and November from around \$235,000 in the same period last year, according to figures published by the Turkish Exporters Assembly. Sales to Angola, Chad and Morocco experienced similar jumps.

Turkey's drones first made international headlines after Ankara signed two deals with the UN-recognized Libyan government covering maritime and security in 2019. It then swarmed the conflict zone with drones, stalling an advance by rebel eastern forces backed by Turkey's regional rivals and paving the way for a truce. Turkey cemented its drones' reputation last year by helping Azerbaijan recapture most of the land it lost to separatist ethnic Armenian forces in disputed Nagorno-Karabakh nearly three decades ago.

"Now Turkey with drones has more cards to play when they have to bargain with other countries," researcher Donelli said. "This is a very good bargaining chip for Turkey." The head of Turkey's Foreign Economic Relations Board - the NGO that hosted the October forum in Istanbul - insisted the growing relationship was not just about weapons. "We care about the defense sector and our relations with Africa," the board's head Nail Olpak told AFP.

"But I would like to emphasize that if we see the defense sector only as weapons, rockets, guns, tanks and rifles, it would be wrong."

He highlighted Turkish mine-clearing vehicles in Togo, which qualify as defence industry sales. Donelli agreed, referring to Togo's plans to improve its army with the support of Turkey through training and armored vehicles, weapons and other kinds of equipment. — AFP

Europe ramps up COVID vaccine drive for children

The push to immunize children has gained fresh urgency from concerns over the rapid spread of the heavily mutated Omicron variant of the virus, which was first identified in southern Africa late last month. "Many people sold their businesses," she said, adding that in the absence of any government assistance, owners and employees were facing debt and lawsuits.

"Two years ago, Bethlehem was a capital," said Hazboun, I used to close the shop at 9:00 pm. And now it's completely destroyed. This lockdown is a disaster." Bethlehem has survived past crises, notably waves of unrest during the Zionist aggression that have also dampened tourism, and Shomali said residents were surviving on hope. Asked if he has hope for next Christmas, Shomali answered "Next Christmas? I have hope for Easter." — AFP

Kuwait's Amir receives Crown Prince after GCC Summit in Riyadh

Crown Prince thanks Saudi monarch for warm hospitality

KUWAIT: His Highness the Amir Sheikh Nawaf Al-Ahmad Al-Jaber Al-Sabah received yesterday His Highness the Crown Prince Sheikh Mishal Al-Ahmad Al-Jaber Al-Sabah following the latter's return from Saudi Arabia, where he headed the Kuwaiti delegation to the 42nd GCC Summit in Riyadh. His Highness the Crown Prince briefed His Highness the Amir on the results of the summit that reflected the historical deep-rooted ties between the GCC countries and people, and keenness on boosting joint cooperation and unity between them to meet their mutual aspirations and enhance security and stability of the region.

Meanwhile, His Highness the Crown Prince sent a letter of gratitude to Saudi Arabia's King Salman bin Abdulaziz Al-Saud for the warm reception he and his accompanying delegation had experienced during his participation in the GCC Summit on Tuesday. He hailed the important decisions taken by the GCC leaders to cement joint action and achieve the aspirations of Gulf peoples. He also wished King Salman everlasting wellbeing and wished Saudi Arabia and its people more progress and prosperity. His Highness Sheikh Mishal sent a similar letter to Saudi Arabia's Crown Prince, Deputy Prime Minister and Defense Minister Prince Mohammad bin Salman bin Abdulaziz Al-Saud.

Joint march

The Riyadh Declaration, adopted by the 42nd Summit of the Supreme Council of the Gulf Cooperation Council on Tuesday, stressed the GCC leaders' resolve to press ahead with the march of joint action out of deep sense of responsibility towards the peoples of the GCC countries. In realization of the noble visions and aspirations for the

prosperity of the GCC member countries, the GCC leaders agreed on a number of principles and policies for upgrading the strategic cooperation and economic and developmental integration, according to the Declaration.

The consensus among the GCC leaders, stemming from the deep-rooted brotherly relationship, the joint, shared objective and common destiny, builds on the outcomes of Al-Ula GCC Summit, held in last January. Al-Ula Summit stressed commitment to collective action to promote coordination, collaboration and integration among the GCC states with a view to realizing the noble aims for which the GCC was founded in 1981 and the vision of Saudi King Salman bin Abdulaziz for implementation of the decisions made by the 36th GCC summit of December 2015. The GCC leaders highlighted the need to implement accurately the vision of Saudi King and further strengthen the pillars of economic unity and integrate the defense and security systems in order to promote stability of the GCC states and realize the aspirations of their peoples, the Declaration reads.

Aggression on all

The second article of the joint defense treaty provides that the GCC states consider aggression on any of them is tantamount to aggression on all of them, which requires collective response, the document reminds. The GCC leaders underscored the importance of concerted efforts and integrated policies to crystalize a joint foreign policy that could serve the common aspirations and interests of the GCC peoples and keep the GCC states away from regional or international conflicts. They agreed to coordinate the policies of the GCC states

towards sustainable development, mitigate the impacts of climate change on the GCC economies, and realize objectives of the initiative for recycling carbon dioxide unveiled by Saudi Arabia while presiding over G20 summit.

The leaders agreed to instruct the competent departments to work out the necessary mechanisms for employing the best practices for environment protection and draw on the Saudi Green Initiative and the Middle East Green Initiative, announced by Saudi Crown Prince Mohammad bin Salman. They highlighted the need to follow up on the implementation of GCC strategy for diversified economy, maximize benefit from the economic potentials and double the volume of joint investments. They stressed the need to continue the combat against

the coronavirus pandemic through coordinated policies and joint action with a view to minimizing the impacts of the pandemic on the socio-economic development in the GCC countries.

They also stressed the importance of promoting the role of women in economic development and putting in full play the role of youth in the business and finance sectors. They urged promoting the joint action in the areas of digitalization, modern information technology and cybersecurity and encouraging the private sector, particularly the SMEs, to play greater role in economy, the Declaration went on. They instructed the relevant committees and departments to arrange the necessary programs to put into action the decision reached in the GCC summit, it added. —KUNA

GCC urges Iraq to complete borders' demarcation with Kuwait

RIYADH: The Gulf Cooperation Council called on Iraq to exert its utmost efforts, alongside the United Nations, in completing the demarcation of its maritime borders with Kuwait. In their final communique after the 42nd GCC Summit, Arab Gulf leaders reiterated support for Security Council Resolution number 2107, regarding the referral of the file of POWs and missing persons, Kuwait's property and national archives to the United Nations mission. They expressed hope for Iraq to continue to cooperate in order to ensure progress is achieved on these matters. Separately, they underlined the importance of preserving Iraq's territorial integrity, sovereignty, Arab-Islamic identity, social fabric and national unity and supporting its efforts to confront terrorist groups and armed militias in order to consolidate state sovereignty and the rule of law. Meanwhile, the GCC Cooperation Council reaffirmed commitment to its principled stance on Iran's continued occupation of the three UAE islands of Greater and Lesser Tunbs and Abu Musa in the Arabian Gulf. The final communique stresses that the GCC leaders maintain their principled supportive stance of the UAE right to sovereignty over the three islands.

On relations with the Islamic Republic of Iran, the GCC Supreme Council reaffirms commitment to the basic principles of the UN Charter and the rules of international law, including neighborliness, respect to sovereignty of states, non-interference in the domestic affairs of one another, solving differences through peaceful means, discarding sectarianism, and refraining from using or threatening to use force. The Supreme Council is looking forward to Iran playing a positive role under its new administration so as to alleviate the tensions, build trust with the GCC member countries, according to the communique. The Supreme Council expresses worry about the escalation of Iranian moves to destabilize security in the region, and denounces Iran's continued interferences in the domestic affairs of the GCC counties and the region at large.

Kuwait FM touts Gulf Summit as promoting cooperation

KUWAIT: Kuwaiti Foreign Minister and Minister of State for Cabinet Affairs Sheikh Dr Ahmad Nasser Al-Mohammad Al-Sabah Wednesday underlined the significance of the 42nd GCC Summit to promoting joint Gulf action and firmly looking forward to the bloc's fifth decade for sustainable accomplishments and promising future. Sheikh Ahmad Al-Nasser, in a tweet, thanked the leadership, government and people of the Kingdom of Saudi Arabia for warm welcome and proper arrangements and preparations for the summit.

Separately, Foreign Minister Sheikh Dr Ahmad received yesterday the outgoing Ambassador of Japan to Kuwait Takaoka Masato. The Foreign Minister, during his meeting with Masato, praised the diplomat's efforts and contributions to boosting the close ties between both friendly countries.

ing the close ties between both friendly countries.

In other news, Sheikh Dr Ahmad has acclaimed the strong fraternal bonds that link Kuwait and Egypt, and their peoples. Addressing via videoconference a function held Tuesday by the Kuwaiti embassy in Cairo to mark the 60th anniversary of the Kuwaiti-Egyptian diplomatic relations, the minister said that relations between the two Arab nations, which date back to the 19th century, were based on mutual giving and sacrificing. He highlighted Egypt's contribu-

The Supreme Council reiterated denunciation of Iran's persistence in fomenting sectarianism and instability through provision of finances and arms, including ballistic missiles and drones, to terrorist groups and militias, which jeopardizes civilian lives and international navigation. Regarding the nuclear program of Iran, the communique says the GCC states stand ready to play an active and effective role in addressing this dossier in conformity with the common interests and in respect to sovereignty, neighborliness, the international legitimacy and the relevant UN resolutions. The communique stresses the need of GCC states' taking part in the multilateral talks on the Iranian nuclear program as well as any regional oi international talks relating to security, safety and stability in the Gulf region. It urges closer cooperation and coordination with friendly countries to address Iran's behavior, which destabilizes the region and supports extremist sectarian groups, as well as Iran's drone and ballistic missile programs which pose risk to the international shipping routes and the safety of oil facilities in some sisterly countries.

The GCC Supreme Council condemns Iran for failure to meet its international obligations and exceeding the level of uranium enrichment to above the grade of peaceful uses. It urges Iran to back down on this stem and cooperate fully with the International Atomic Energy Agency. The communique stresses the importance of protecting the maritime safety and water corridors in the Gulf region and standing firm against any activities that could put in jeopardy the security and stability of the region, or international navigation or the oil facilities of the GCC states.

Meanwhile, the Gulf states meeting underlined the "centrality" of the Palestinian cause and support for Palestinian sovereignty over all territories occupied since June 1967 and the establishment of an independent Palestinian state with East Jerusalem as a capital. The six-nation Gulf Cooperation Council bloc stressed the need to guarantee the rights of

tions to a variety of domains in Kuwait including education, culture and arts.

Sheikh Ahmad hailed relation with Egypt as a role model for successful international relations. He noted that the two countries agreed in 1995 on forming a joint committee to ameliorate cooperation in all domains. He recalled sacrifices of Kuwait and Egypt to defend the territories of each other. On economic cooperation, the Kuwaiti top diplomat estimated the trade exchange between the two countries at \$364 million in 2020. The investments of the Kuwaiti public sector in Egypt amount to \$5.4 billion whereas the private sector's investments exceed \$10 billion, he unveiled. —KUNA


KNPC inaugurates new gas station in Sabah Al-Ahmad

KUWAIT: The Kuwaiti National Petroleum Company yesterday inaugurated a new gas station at the southern residential district of Sabah Al-Ahmad. It is the 18th and the last station in the first phase of a strategy to build up to 100 new ones. Ghanem Al-Otaibi, the company's Deputy Chief Executive Officer, said in a statement to the press that with the opening of the new station, the KNPC has finalized the first phase of the long-term plan. The KNPC is committed to the strategy, execution of which kicked off in December 2019, when it opened the first station.

Architectural designs of the second batch of planned stations have been finalized, he said, forecasting that their construction and operation would be in the 2025-2026 period. The current number of the gas stations is 61 spread in different locations around the country, in addition to three mobile stations set to be replaced with fixed ones. Out of the company's keenness on protecting the environment, he continued, the KNPC equipped the new stations with solar energy panels that generate 30 percent of the whole amount of the consumed electricity at the stations. Moreover, these stations are equipped with systems that cut harmful gases emitted from vehicles, another method to minimize air pollution at the locations. —KUNA


Two kg of shabu found in lorry



Russia ordered killing on German soil

New Foreign Minister Annalena Baerbock faces 'her first major test'

BERLIN: The 2019 assassination of a former Chechen commander in a Berlin park was ordered by Russia, a German court ruled yesterday, in a verdict likely to escalate tensions with Moscow. Judges in a Berlin court sentenced Russian suspect Vadim Krasikov, alias Vadim Sokolov, to life in jail after finding him guilty of gunning down 40-yearold Georgian national Tornike Kavtarashvili in the Kleiner Tiergarten park in broad daylight on August 23, 2019.

"Russian state authorities ordered the accused to liquidate the victim," presiding judge Olaf Arnoldi said, agreeing with prosecutors that the murder had been carefully planned. The murder was meant "as retaliation" for being a Kremlin opponent, the judge added. The ruling piles pressure on Germany's new government, which has vowed a tougher stance towards Russia, and comes amid growing alarm in the West about Russian troop movements on the border with Ukraine.

"If the court should indeed assume a political contract killing, the German government would have to draw consequences," Der Spiegel weekly wrote. New Foreign Minister Annalena Baerbock now faces "her first major test", it added.

Tit-for-tat

Shortly after the murder took place, Germany

under then-chancellor Angela Merkel expelled two Russian diplomats in protest at Moscow's perceived lack of cooperation with the investigation. Russia, denying any connection to the killing, responded with a tit-for-tat move.

According to German prosecutors, the suspect



shot Kavtarashvili from behind on a bicycle and fired two shots from a Glock 26 pistol equipped with a silencer. After the victim fell to the ground, Krasikov is accused of then shooting him in the head, killing him on the spot, before getting back on his bicycle and fleeing. Police divers later recovered the Glock handgun, a wig and a bicycle from the nearby Spree river.

Calling for Krasikov to be jailed for life as they

summed up their case last week, prosecutors said they had identified him as a "commander of a special unit of Russian secret services FSB". "He liquidated a political opponent," prosecutor Lars Malkies told the court.

Tourist cover

But in an earlier hearing, the defendant had told the court through his lawyer Robert Unger that he should be identified only as Vadim Sokolov, who is "Russian, single and a construction engineer".

He denied being known as Krasikov, saying "I now of no one by this name". Prosecutors say the defendant travelled as a tourist in the days before the murder, arriving on August 17 in Paris where he visited sights before travelling to Warsaw. Photos of his tourist cover were found on a mobile phone in the Polish hotel where he stayed before heading to Berlin on August 22. Krasikov was arrested after the killing, which took place just minutes away from the German chancellery and parliament.

Ukraine tensions

The trial has spanned a period of particularly rocky ties between Berlin and Moscow over a series of espionage cases, as well as the poisoning and jailing of Kremlin critic Alexei Navalny. The verdict also comes at a time of severe tensions with Russia, which stands accused by the West of planning an invasion of Ukraine and massing tens of thousands of troops near its neighbour's border. Germany's new government has taken a sharp tone with Moscow, warning that it will not approve the controversial Nord Stream 2 gas pipeline from Russia in the event of any new "escalation" in Ukraine. Chancellor Olaf Scholz issued a fresh warning on Wednesday, saying Russia would pay "a high price" if it invaded Ukraine.

'Very cruel'

Russian President Vladimir Putin has described the Tiergarten victim as a "fighter, very cruel and bloody" who had joined separatists against Russian forces in the Caucasus and also been involved in bombing attacks on the Moscow metro. Moscow also said it had been seeking his extradition. According to German media, the victim survived two assassination attempts in Georgia before seeking asylum in Germany, where he had been living for several years. In another recent incident, a Russian diplomat was found dead outside the country's embassy in Berlin in October. Der Spiegel said the man was related to a high-ranking official of the FSB's second directoratea unit that Western secret services say was involved in the Tiergarten killing. —AFP

Sewell appointed NY's first woman police chief

NEW YORK: New York will appoint Keechant Sewell as its first-ever woman police chief to head the largest force in the country, mayor-elect Eric Adams said Tuesday, at a time when the city's trust in law enforcement has been shattered.

Sewell will also be only the third black person in the post, and will have to restore faith in a police department that has faced accusations of harboring violent, racist and corrupt officers in its ranks. Adams, a Democrat and former police officer, will become New York's second black mayor when he takes office on January 1.

With Sewell's appointment, he fills a key post two weeks before his formal start, with security having been one of the main issues during his campaign. "Keechant Sewell is a proven crime fighter with the experience and emotional intelligence to deliver both the safety New Yorkers need and the justice they deserve," Adams told The New York Post.

"Chief Sewell will wake up every day laserfocused on keeping New Yorkers safe and improving our city, and I am thrilled to have her at the helm of the NYPD." "Violent crime is the number one priority," Sewell told the Post. "I want to actually take a look at what's working in the city and what's not working," she added.

Commanding approximately 36,000 police officers in the largest city in the United States, 49year-old Sewell will shoulder the tough task of maintaining security in New York at a time when a surge in crime has accompanied the coronavirus pandemic. "We welcome Chief Sewell to the second-toughest policing job in America. The toughest, of course, is being an NYPD cop on the street," said Patrick Lynch, head of the main police union in the city, the Police Benevolent Association.

Sewell is currently chief investigator in Nassau County, east of New York City. The New York Times reported that she has served in the department for 23 years, working in the narcotics and major cases unit, and as a hostage negotiator. — AFP

US prepared to sell jet fighters to UAE: Blinken

DUBAI: Secretary of State Antony Blinken insisted yesterday the US was still prepared to sell F-35 fighter jets to the UAE, which has threatened to scrap the deal over stringent conditions. The \$23 billion arms package was pushed through by former president Donald Trump in what was seen as a reward for the United Arab Emirates' recognition of Zionist entity, but his successor Joe Biden

has pledged greater oversight over the planes. The Gulf state threatened to dump the agreement Tuesday over the strict conditions, and it comes as Washington grows concerned about China's involvement with the US ally. But Blinken said "we remain prepared to move forward... if that is what the Emiratis are interested in doing", speaking during a visit to Malaysia.

Asked about the conditions the US has set, he did not give precise details, but said Washington wanted to ensure that the Zionist entity maintains its "military edge". "We wanted to make sure that we could do a thorough review of any technologies that are sold or transferred to other partners in the region," he said.

US ally Zionist entity historically objected to Arab states obtaining the F-35s, seeking to maintain its regional advantage, but gave its blessing after the UAE last year became the first new Arab country in decades to recognise the Jewish state. The Wall Street Journal, which first reported the impasse, said that the United States was insisting on conditions to make sure the F-35s would not be vulnerable to Chinese espionage. Lawmakers from Biden's Democratic Party unsuccessfully sought to stop the sale, pointing in part to the Gulf state's participation in the bloody Saudi-led offensive in Yemen and its support for Libyan warlord Khalifa Haftar. The F-35s are prized for stealth capabilities and versatility with the capacity to gather intelligence, strike deep into enemy territory and engage in air duels. — AFP

Blinken cuts short Asia trip due to **COVID** case

KUALA LUMPUR: US Secretary of State Antony Blinken yesterday cut short a trip to Southeast Asia after a member of his delegation contracted the coronavirus, a spokesman for the US State Department said. The top US diplomat was due to meet Thai officials in Bangkok today after visiting Indonesia and Malaysia, but this final leg of the three-country tour has been cancelled.

Blinken told Thai foreign minister Don Pramudwina that he "would be returning to Washington DC, out of the abundance of caution," the spokesman said. A journalist with the travelling party tested positive for COVID on arrival in Malaysia on Tuesday night, he added.

No other members of the press or advisers close to Blinken returned a positive result, he said. The US embassy in Malaysia said in a statement that the person with Covid-19 did not participate in any of Blinken's planned activities in Kuala Lumpur. The journalist is now in isolation in Kuala Lumpur, in line with local regulations.

The state department's spokesman told reporters travelling with Blinken that the decision to end the tour was taken to "mitigate the risk of the spread of COVID-19 and to prioritise the health and safety of the US travelling party and those they would otherwise be in contact with". The US embassy in Jakarta said on Twitter that all members of the group had tested negative in Indonesia. Blinken's plane will make a short technical stopover in Thailand, with no official talks on the agenda, before he returns to the United States. — AFP

Germany vows to 'defend itself' as police raid anti-vaxxers

Scholz vows zero-tolerance policy against such extremist groups

BERLIN: Germany said yesterday it would "defend itself" against radicalised anti-vaccination groups after police launched raids in response to death threats against a top politician backing sweeping measures to fight the pandemic.

Police and special forces staged an operation in Saxony after an anti-vaccine group targeted the region's state premier Michael Kretschmer, who has vocally supported curbs for the unvaccinated in one of the areas of the country with the lowest inoculation rates

Chancellor Olaf Scholz, who took office last week, said Germany would "not allow a tiny minority of uninhibited extremists to try to impose its will on the

whole of society". The security forces launched the raids targeting five suspects in the eastern cities of Dresden and Heidenau, following threats from an anti-vaccine group against Kretschmer.

Threats against politicians and other public figures were "not acceptable", Kretschmer said during a press conference,

adding that "every effort" would be made to pursue any perpetrators. "Statements from certain members of the group suggested they might have real weapons and crossbows," police said, without indicating if any arrests had been made. Audio messages called for members to oppose the restrictions in place and "if necessary with weapons", targeting politicians — in particular, Kretschmer.

Authorities suspected "the preparation of a violent crime that threatens the state", police later said on Twitter. The investigation was opened after journalists from public broadcaster ZDF infiltrated an

BERLIN: Germany said yesterday it would "defend itself" against radicalised anti-vaccination groups encrypted chat on the Telegram messaging app and reported on the death threats last week.

'Bloody resistance'

ZDF revealed the contents of messages allegedly involving a hundred members of the chat group "linked by their opposition to vaccines, to the state and the current health policies", police said. In his first speech to parliament as chancellor, Scholz vowed a zero-tolerance policy against such extremist groups. Germany will "use all the means of its democratic rule of law to defend itself against this tiny minority of the hateful attacking the rest of us", he said.

The rise of violent farright extremism in Germany was the "biggest threat to our democracy", Scholz added. A large, partly radicalised movement has emerged in Germany against health restrictions imposed during the pandemic.

In the midst of a strong fourth wave of the virus, the national government

decided to strengthen restrictions on unvaccinated people, banning them from public venues, restaurants and non-essential commerce. Scholz has said parliament could vote on compulsory vaccination in the coming weeks, with the obligation to get the jab coming into force in February or March.

On Wednesday, police in Berlin confirmed they were investigating threats sent to several politicians across the country, which promised a "bloody resistance" against obligatory vaccines. One of the letters, of which there were "more than a dozen", contained a piece of meat wrapped in aluminium foil.

Opposition to health restrictions is particularly strong in Saxony, in former communist East Germany, one of the region's worst hit by the resurgent coronavirus and where the vaccination rate is lower than the national average. At the beginning of December, protestors gathered outside the house of the Saxony state minister of health with torches and whistles, a demonstration that was condemned by politicians.

The anti-vaccination scene was "being radicalised, not just politically but also showing a readiness to use violence," police union chief Rainer Wendt told local media. Between 15,000 and 20,000 people were currently implicated in the radical tendency, security expert Sebastian Fiedler of Scholz's Social Democrats told the Bild daily on Tuesday. Germany has seen a rise in political violence in recent years, often attributed to farright assailants. — AFP

Putin hails 'model' Russia-China relations in Xi Jinping call

MOSCOW: President Vladimir Putin yesterday hailed Russia's "model" relations with China in a call with Chinese leader Xi Jinping and confirmed he would attend Beijing's Olympics, as both countries face increasing criticism from the West. The video call came days after G7 foreign ministers discussed Moscow's sabre-rattling against Ukraine and Beijing's crackdowns in Hong Kong and Xinjiang

The talks also came after both Russia and China were pointedly left out of US President Joe Biden's democracy summit last week. "In February we will finally be able to meet in person in Beijing," Putin said in a television broadcast of the conversation after he said he would attend the Games, calling Xi his "dear friend".

"China-Russia relations have withstood all kinds of stern tests, and are showing new dynamism and vitality," Chinese state news agency Xinhua reported Xi as saying. He also accused "international forces" of meddling in China and Russia in the name of democracy and human rights and "grossly trampling" on international law, according to a Chinese foreign ministry statement.

"China and Russia must develop more joint actions to more effectively safeguard both sides' security and interests," the statement added. The United States, Britain, Canada and Australia are not sending political representatives to the Olympics over China's abuse of Uyghurs and other mostly Muslim minorities in Xinjiang.

Beijing and Moscow denounced the diplomatic boycott and Putin on Wednesday said both leaders opposed "any attempt to politicise sport and the Olympic movement", a criticism Russia has repeatedly levelled at the West. Russia was found to have used a state-backed doping programme at the 2014 Winter Games in Sochi and was banned from international competitions afterwards.

Russian athletes are allowed to compete as neutrals-without the Russian flag or anthem-if they can prove their doping record is clean.

'Unprecedented' relations

Russian officials including Putin are banned from attending international competitions unless invited by the head of state of the host country. Xi has invited Putin to attend. Both China and Russia have seen their relationship with Western nations deteriorate in recent years and have sought to project a more unified front.

Yesterday, Putin told Xi that "a new model of cooperation has been formed between our countries" that includes a "determination to turn our common border into a belt of eternal peace and good-neighbourliness". "I consider these relations to be a real model for inter-state cooperation in the 21st

century," the Russian leader said.

After the call, the Kremlin's top foreign policy adviser Yury Ushakov said that the conversation between the "two great friendly states" had lasted 90 minutes and was "very positive". "Both stated that the relationship had reached an unprecedented high level," he told reporters. The US and its allies have for weeks accused Russia of planning an invasion of its ex-Soviet neighbour Ukraine, warning of massive coordinated sanctions should Putin launch an attack.

Tens of thousands of Russian troops are stationed near Ukraine, where the West has accused the Kremlin of backing pro-Moscow separatists since 2014. Russia rejects the allegations and blames the West for stoking tensions. In calls on Tuesday with the leaders of France and Finland, Putin said he wanted security talks with the United States and

NATO to begin without delay.

Russia's demands included stopping NATO from expanding east and the deployment of weapons in neighbouring states, including Ukraine. China's relationships with multiple Western allies have cratered in recent vears over a host of issues-from trade and security to Beijing's human rights record and vows to seize Taiwan, which it claims. China, an authoritarian one-party state, responded with fury to being left out of the Biden summit, branding US democracy a "weapon of mass destruction". Beijing's diplomats overseas and its state-controlled media ramped up a propaganda blitz criticising Western democracy as corrupt and a failure. Instead, they touted 'whole-process people's democracy", aiming to shore up legitimacy for the ruling Communist Party, which has swung increasingly authoritarian

Navalny daughter urges EU to confront Putin

STRASBOURG: Jailed Kremlin critic Alexei Navalny's daughter yesterday urged the EU to stand up to Russian President Vladimir Putin, as she collected a rights prize on behalf of her father. "Although coming here is amazing, it is also probably exactly how mine and my family's worst nightmare looks like," Daria Navalnaya told the European Parliament as she picked up its annual Sakharov Prize.

Navalny-Putin's highest-profile domestic opponent-has been behind bars since returning to Moscow in January from Germany, where he was recovering from a poisoning attack with a Novichok nerve agent that both he and the West blame on the Kremlin.

"I don't understand why those who advocate for pragmatic relations with dictators can't simply open some history books," Navalnaya, a 20-year-old student at Stanford University in the United States, told lawmakers. "It's very easy to understand the inescapable political law: the pacification of dictators and tyrants never works."

Navalnaya attacked European politicians "who dream of getting a job on the board of directors of Putin's state-owned companies or sailing on an oligarch's yacht". "It seems to me that the problem is that the desire to appease the dictator, again and again, to not anger him, to ignore his crimes as long as it's possible is not a pragmatic approach at all," she said.b "It's time to say it straight. Under the sign of pragmatism, there is cynicism, hypocrisy, and corruption." —AFP

MPs fire warning shot at Johnson in COVID vote

LONDON: British Prime Minister Boris Johnson yesterday faced intense pressure after nearly 100 MPs from his party broke ranks and voted against new coronavirus restrictions. Even though the measures were passed, the scale of the rebellion from all sections of Johnson's ruling Conservatives was a very public shot across the bows.

"It was a very clear message that colleagues are not happy with how the government is operating at the moment," Mark Harper, who served as a parliamentary enforcer for former Conservative PM Theresa May, told Times Radio. May faced an ever bigger rebellion-against her Brexit deal-that led to an internal vote of no confidence. She then quit.

Conservative MP Geoffrey Clifton-Brown said after Tuesday's votes that Johnson had to be "in some danger", despite securing the party an 80-seat majority in the last election. "He's got to realise that, because if he doesn't

he'll be in much bigger danger," Clifton-Brown told Sky News, predicting that Johnson could face a leader-ship challenge in the new year if he failed to listen to his party more.

Mounting scandals

The popularity of Johnson and his party has taken a battering in recent weeks after a series of scandals. But it could get worse if the

Conservatives lose a by-election in a safe seat today. Many people in the North Shropshire constituency in central England said they would vote on Johnson's recent record, just two years after his thumping general election victory on a pledge to "Get Brexit Done". "This man is not fit to be prime minister," Garry Churchill, 71, a voter in the constituency, told AFP. "I can't imagine why people

would vote for the Conservative candidate in this by-election."

The by-election was prompted by the resignation of Conservative MP Owen Paterson over breaches of parliamentary lobbying rules. Johnson caused outrage by trying to change parliament's disciplinary procedure to prevent Paterson serving a 30-day suspension and was forced into an embarrassing U-turn. He is also facing claims of dodgy dealing after an electoral watchdog fined the Conservatives for failing to declare who paid for a lavish decoration of his flat. That compounded accusations of cronyism following reports that wealthy party donors were given plum seats in the upper House of Lords.

'Cry of pain'

Johnson's overall handling of the government's response to the coronavirus pandemic, however, has come under the most scrutiny, with 146,000 deaths and high infection rates. Since the Omicron variant of the virus was first identified, Johnson has sought to prevent its spread and protect health services from being overwhelmed. But public health messaging and compliance have been undermined by claims government staff held parties last Christmas, despite telling the public to cancel theirs.—AFP

Macron in campaign mode as election looms

PARIS: French President Emmanuel Macron is yet to declare he will run for a second term in next year's election, but his intentions are no longer in doubt and his unofficial campaigning is drawing fire. After Macron gave a rare two-hour press conference last week to outline his European ambitions, French television will broadcast late yesterday a prime-time TV interview on domestic policy with the 43-year-old head of state.

The one-and-a-half hour interview with TF1 was pre-recorded days in advance-but under live conditions according to the channel-and will be shown from 2000 GMT. For a leader who has always kept the media at arm's length and once theorised his role as acting like Jupiter, the Roman god of the sky, the sudden burst of transparency has not gone unnoticed.

Neither have a string of visits to small-town and rural France where he has wandered through picturesque cobbled streets, stopping to chat to shopkeepers or visiting local cafes. When asked again by a reporter last week whether he would seek re-election, he initially employed humour, saying the question was "a sign of affection, a hidden desire, almost an appeal". "In the time we are living through, the most important thing is that our institutions continue to function in the most stable way possible," he continued, evading the question. —AFP

US threatens new measures against Myanmar junta

Brutal crackdown has left more than 1,300 people dead

KUALA LUMPUR: The United States is considering new measures to pressure the Myanmar junta to return to a "democratic trajectory", Secretary of State Antony Blinken said yesterday, as alarm grows over an escalating crackdown on dissent. Myanmar has been in chaos since February when Aung San Suu Kyi's civilian government was ousted by the military.

The United States has imposed some sanctions and regional bloc the Association of Southeast Asian Nations (ASEAN) has drawn up a peace roadmap, but there are serious doubts about the generals' commitment. Speaking during a visit to Malaysia-among several ASEAN states that have strongly criticised the coup-Blinken conceded that the "situation has not improved".

"I think it is going to be very important in the weeks and months ahead to look at what additional steps and measures we can take-individually, collectively-to pressure the regime to put the country back on a democratic trajectory," he said. "That is something that we are looking at," he added, without saying what the measures might be.

The coup triggered nationwide protests but the junta has responded with a brutal crackdown that has left more than 1,300 people dead and seen thousands arrested, according to a local monitor. Blinken also said the United States was looking "very actively" at whether the treatment of the Rohingya Muslim minority in Buddhist-majority Myanmar might "constitute genocide". The group faces widespread discrimination in Myanmar, and hundreds of thousands fled to neighbouring Bangladesh in 2017 following a military crackdown.


'Alarming escalation'

They were responding to the reported killing of 11 villagers, including children. The United States said it was "outraged by credible and sickening reports" the military tied up and burned the vic-

11 Indonesians dead in Malaysia boat sinking

KUALA LUMPUR: At least 11 Indonesian migrants died and 27 are believed to be missing after a boat sank yesterday in stormy weather off southern Malaysia, authorities said. Indonesians looking for work sometimes try to enter neighbouring Malaysia illegally by making sea crossings in rickety boats, and accidents happen regularly.

The vessel, believed to be carrying 60 migrants, went down in the morning off Malaysia's southern state of Johor, the coastguard said. Soldiers on patrol discovered the bodies of seven men and four vomen on the shore, coastguard chief Admiral Mohamad Zubil Mat Som told AFP. Another 20 men and two women were found alive following the voyage from a nearby Indonesian island, and have been taken into custody, he said.

Those missing are believed to have fled into hiding or drowned, and authorities have deployed boats and an aircraft to hunt for them. "We deeply

Belgian trial opens over UK migrant truck deaths

BRUGES, Belgium: Two years after 39 Vietnamese migrants died aboard a truck that travelled to Britain, Belgium yesterday opened the trial of 23 people suspected of involvement in the human-smuggling ring responsible. The proceedings, in a courtroom in the city of Bruges, follow convictions handed down in Britain in January to seven men, several for manslaughter. They were given prison sentences ranging from three years to 27 years.

In Vietnam, in September last year, four men were sent to prison in connection with the case. Their sentences ranged from two-and-a-half years to seven-and-a-half years. The Bruges trial, expected to last two days, focuses on the fact that the truck left for Britain on October 22, 2019 from Anderlecht, a neighbourhood on Brussels' western outskirts, where the gang allegedly had two safe houses to group migrants.

The bodies of the migrants, 31 men and eight women, aged 15 to 44 and all from Vietnam, were discovered the next day in Britain, when the container they were in was opened in Grays, an industrial area in Essex, just east of London. They had suffocated in extremely hot weather as the truck had crossed by sea. They had tried, without success, to pierce the metal container's roof with a pole. A Belgian prosecutor told the trial: "What stays with me the most is a bloody handprint on the door of the container."

The macabre crime triggered police investigations on both sides of the Channel, and in Vietnam. On May 26, 2020 Belgian authorities raided several addresses, most in the Brussels region, to round up Vietnamese suspected of links to the people-smuggling outfit. A verdict in the trial of the 23 may take several weeks to be delivered. Prosecutors are seeking prison terms from 18 months to 15 years for the

Accused ringleader

The main defendant is a 45-year-old Vietnamese man charged with "running a criminal organisation" who faces up to 15 years in prison and confiscation of assets worth two million euros (\$2.3 million) if convicted. He denies all involvement. At least 17 of the others allegedly were members of the peoplesmuggling ring, with the remainder alleged accomplices used as safe-

clandestinely transporting people into Europe then Britain for a total fee of 24,000 euros (\$27,000) each. They said it used an Irish trucking company that regularly imported Vietnamese biscuits to get the migrants across the Channel, and that Vietnamese gang members took charge of them once they got to Britain.

Many of the dead migrants in the truck came from a poor region in the centre of Vietnam. Families there can rack up debts of thousands of dollars to have one member of their family smuggled into Britain in the hope they can secure a better life.

The Belgian investigation is not yet closed, with two more suspects still being sought according to prosecutors. Belgian authorities, who early last year conducted their investigation with counterparts in Francewhere 13 people were chargedestablished that the alleged ring daily transported dozens of migrants coming from Southeast Asia.

Prosecutors say the smugglers in Belgium had connections in France, the Netherlands and Germany, and that it was believed some of the defendants continued their illegal activities after the October 2019 tragedy. —AFP

Questions remain over the future of Apple Daily's Taiwan edition, after Bloomberg reported that the operation was strapped for cash and will close before the end of the year. Apple Daily Taiwan dismissed the report as "speculation" and said it had no further comment. Taiwan media reported that the court-appointed provisional liquidator for Next Digital has approached Apple Daily's Taiwanese unit to ask about its assets.

Authorities have moved to rein in press freedoms in Hong Kong as Beijing remoulds the city in its own image, following huge and often violent democracy protests two years ago. Earlier this month, the World Association of News Publishers awarded its annual press freedom prize to Apple Daily's staff and its founder Lai.

The association lauded the paper as a "symbol of pro-democracy and public dissent" and said Lai was an outspoken critic of Beijing's control over Hong Kong. The award recognises and reflects on "the jailing of a publisher, the arrest of an editor-inchief and his senior colleagues, the shuttering of a newsroom, and the closure of a media title", organisers said. —AFP

UK inflation spikes to decade-high on eve of BoE rate call

LONDON: British inflation has rocketed to its highest level for more than 10 years on broad-based price gains, data showed yesterday, sparking fears that wages will fail to keep pace on the eve of a Bank of England interest rate decision. The annual inflation rate surged to 5.1 percent in November after 4.2 percent in October, the Office for National Statistics (ONS) said in a statement.

That marked the highest level since September 2011, with inflationary pressures driven by jumping fuel costs as the rate accelerated further above the BoE's official target. The news sparked an outcry from Britain's Unite trade union, which complained many workers faced an effective pay cut with the prospect of below-inflation annual wage increases.

The BoE, whose main task is to keep inflation close to 2.0 percent, is however expected to hold its record-low interest rate today due to turmoil over the Omicron coronavirus variant.

Central banks normally use interest rate hikes to try to damp high inflation, which is weighing on companies and consumers globally.

Wide range of price rises

"A wide range of price rises contributed to another steep rise in inflation, which now stands at its highest rate for over a decade," said ONS Chief Economist Grant Fitzner. "The price of fuel increased notably, pushing average petrol prices higher than we have seen before.

"Clothing costs-which increased after falling this time last year-along with price rises for food, second-hand cars and increased tobacco duty all helped drive up inflation this month." Inflationary pressures were also fuelled by the global supply crunch and jumping commodity prices. "The cost of goods produced by factories and the price of raw materials have continued to increase significantly to their highest rate for at least 12 years,"

After countries emerged from pandemic lockdowns earlier this year, companies struggled to

meet demand for goods, energy and services, sending inflation soaring. However, the BoE will probably hold its key interest rate at 0.1 percent due to Omicron uncertainty, analysts say.

The Unite union meanwhile urged companies to grant pay hikes that preserve the buying power of workers' salaries. "Today's figures mean our members must fight for wage rises above the current rate of inflation," said Unite general secretary Sharon Graham.

'Hot and bothered'

Omicron, which emerged late last month, forced Britain to re-impose coronavirus restrictions that were passed by lawmakers late on Tuesday. BoE policymakers will also be mindful of news that UK unemployment has fallen again, despite the end of a scheme to keep millions of private-sector workers in their roles during the pandemic. "Faced with such a high inflation reading, and with forecasts that the

only way is up, the Bank of England would ordinarily be expected to call time on the cheap money party and raise interest rates," said Hargreaves Lansdown analyst Susannah Streeter.

"But with the recovery far from being in full swing and the omicron variant an unruly guest, set to knock back confidence further for many sectors, policymakers may be hot and bothered but are likely to stay in wait-and-see mode tomorrow." The UK economy was already struggling prior to the arrival of Omicron, growing by an anemic 0.1 percent in October from 0.6 percent in September.

The International Monetary Fund warned Tuesday that "new Covid-19 variants pose downside risks to the outlook" for Britain-and urged the government to consider new emergency stimulus measures in the event of fresh lockdowns. Prime Minister Boris Johnson has warned of a looming "tidal wave" of Omicron that could overwhelm hospitals.—AFP

How Fed used bond buying to boost an economy in crisis

WASHINGTON: The US Federal Reserve is poised to end its bond buying stimulus program early to prepare to combat inflation with interest rate increases. Here is a look at the key dates in the so-called quantitative easing (QE) program:

• November 2008: At the height of the global financial crisis, and after cutting the benchmark interest rate to zero, the Federal Reserve announces it will buy debt held by governmentsponsored mortgage lenders, as well as mortgage-backed securities (MBS).

 March 2009: The Fed expands QE to included purchases of longer-term Treasury debt, and would go on to increase the monthly purchases to \$45 billion for Treasuries, and \$40 billion for MBS.

· June 2013: Fed Chair Ben Bernanke announced the central bank was prepared to start to reduce its holdings, sparking the "taper tantrum" in financial markets, which delayed the actual taper until December, when QE was slowed by \$10 billion a month.

· June 2014: Fed ends QE, halting new asset

· October 2017: Fed begins "balance sheet normalization" to reduce the size of its securities holdings which had swelled to \$4.5 trillion by the end of 2017 from under \$900 billion before the crisis.

· March 15, 2020: After the COVID-19 pandemic hits the United States, the Fed cuts interest rates to zero and announces it will restart QE, purchasing Treasuries and MBS, eventually increasing asset purchases to \$120

 November 3, 2021: With the economy recovering and inflation picking up speed and hitting a 30year high, the Fed announces it will reduce the pace of bond purchases by \$15 billion a month, meaning QE would end by mid-2022 and open the door for policymakers to consider rate hikes. —AFP

US averts credit default with 11th-hour debt limit hike

WASHINGTON: US lawmakers voted to raise the federal debt limit vesterday, eliminating the threat of a disastrous credit default with just hours to spare ahead of the deadline set by the

The deeply divided Senate voted on Tuesday to raise the borrowing cap by \$2.5 trillion and the House of Representatives, the lower chamber of Congress, followed suit in the early hours of the following morning-staving off the next showdown until at least 2023. "No brinksmanship, no default on the debt, no risk of another recession: responsible governing has won on this exceedingly important issue," Senate Majority Leader Chuck Schumer said on the floor ahead of the votes.

"The American people can breathe easy and rest assured there will not be a default." The vote in both chambers of Congress followed party lines, with Republicans offering just one vote in the House to deliver the country from potential disaster, and no votes at all in the Senate. Both parties see raising the debt ceiling as politically toxic, although they acknowledge that failure to do so would plunge the US economy into a depression and roil world markets as the government missed debt

Republicans especially hope to weaponize the extension to campaign against Democratic "overspending" in the 2022 midterm legislative elections, although it would only cover commitments already made by both parties. The two sides agreed last week to create a one-off law allowing Democrats to lift the nation's borrowing authority without help from the opposition Republicans.

The legislative sleight-of-hand circumvented the "filibuster" rule, so that the required 60-40 margin could be

abandoned for this vote only, in favor of a simple majority-allowing Republicans essentially to stand on the sidelines.

'A basic responsibility'

The Bipartisan Policy Center, an independent Washington-based think tank, predicted the United States would no longer be able to service its debts sometime after December 21, although Treasury Secretary Janet Yellen set the deadline at the start of the business day yesterday. America spends more money than it collects through taxation, so it borrows money via the issuing of government bonds, seen as among the world's most reliable investments. Around 80 years ago, lawmakers introduced a limit on how much federal debt could be accrued.

The ceiling has been lifted dozens of times to allow the government to meet its spending commitments-usually without drama and with the support of both parties-and stands at around \$29 trillion.

The new borrowing cap will be \$31.5 trillion. Democratic leaders have spent weeks underlining the havoc that a default would have wrought, including

the loss of an estimated six million jobs and \$15 trillion in household wealth, as well as increased costs for mortgages

and other borrowing. "Addressing the debt limit is a basic responsibility of the federal government," the White House said in a statement. "Passage of this legislation will allow the Treasury to finance spending and tax cuts Congress has already authorized and to keep its commitments without causing disruption or harm to our economy and American families." — AFP

Turkish lira slides ahead of likely interest rate cut

Policymakers bow to Erdogan's wishes to cut borrowing costs despite inflation

ISTANBUL: The Turkish lira yesterday extended its historic slide on the eve of a meeting at which the central bank was expected to lower interest rates for the fourth month in a row. The lira has shed half its value since the start of the year-and 30 percent in the last month alone-as policymakers bow to President Recep Tayyip Erdogan's wishes to bring down borrowing costs despite soaring inflation.

A dollar could buy three liras in 2016 and 7.43 liras on January 1. It was worth 14.70 liras on Wednesday while the annual rate of consumer price increases stood at more than 20 percent. Erdogan has launched a self-declared "economic war of independence" that defies conventional market economics by fighting inflation through a reduction of borrowing costs. Central banks around the world are instead either raising or preparing to raise rates to combat consumer price jumps caused by factors related to the coronavirus pandemic. Analysts and diplomats believe Erdogan unleashed his pro-growth policy in a bid to revive sagging approval numbers ahead of a general election due within the next 18 months.

One senior Western official said Erdogan feels "unchained" after stacking the central bank with allies and ousting ministers who refused to subscribe to his unorthodox views.

Dropping support

Erdogan's public support levels have languished

near the low end of his 19-year rule for much of the past year. Most polls show him losing in a runoff against potential presidential rivals-a defeat that could leave his Islamic-rooted party in disarray.

Erdogan has cited China as an example as he pushes for economic growth at all costs. China brought down the value of its currency to boost exports and achieve spectacular rates of economic expansion over most of the past two decades.

This created a new middle class that helped China achieve more sustainable consumer-driven growth. Turkey's economy also expanded at an annual rate of 7.4 percent between July and September.

But most analysts believe Erdogan's attempts to boost jobs and propel economic expansion through cheap exports are likely to end in social turmoil.

'Heightening risk'

Turkey imports most of its raw materials and spends foreign currency to buy foreign oil and natural gas. The lira's steady depreciation makes these purchases more expensive. Economists estimate that Turkey's net hard currency reserves are running dangerously low-and are in negative territory when so-called "currency swap" agreements with allied countries' banks are taken out. The central bank has depleted its reserves further by intervening four times in the past month to help cushion the

lira against more dramatic single-day falls.

But the losses continue as Turks buy up gold as well as dollars and euros in a bid to preserve their savings. S&P last week became the last major global ratings agency to switch Turkey's credit

outlook to negative.

Current policies have "further undermined the exchange rate of the lira and worsened the inflation outlook, heightening the risk of banking system distress." —AFP

China's consumer data adds to worries over economic rebound

China's retail sales growth eases, factory output picks up

BEIJING: Chinese consumer spending grew at a rise, while warning of other "downbeat signals" slower-than-expected pace in November, data released yesterday showed, with analysts warning that an uptick in coronavirus cases was dampening sentiment and adding to questions over a rebound in the world's second-largest economy.

China's economy bounced back quickly from the pandemic after authorities contained COVID-19 with strict border controls and targeted lockdowns, but the recovery has been losing steam this year. Economists said a current nationwide increase in Chinese coronavirus cases, and resulting containment measures, appear to have led to cautious consumer behavior just as a property market slump worsens.

Retail sales rose 3.9 percent on-year, according to the National Bureau of Statistics (NBS), coming in below expectations and markedly slower than October's 4.9 percent. "The international environment has become more complex and severe, and there are still many constraints on domestic economic recovery," NBS spokesman Fu Linghui told reporters.

Fu added that China's economy faced the "triple pressures" of shrinking demand, supply shocks and weakening expectations, but that it was still expected to steadily improve. Economists Sheana Yue and Mark Williams of Capital Economics said in a research note that the pandemic "remained the key reason holding back a full recovery," blaming it for "weakness in the labor market."

The urban unemployment rate ticked up to five percent last month, from 4.9 percent. Williams had said earlier that recent data indicated that consumers were choosing to travel less as virus cases such as slowing growth in sales during the annual November 1-11 shopping festival-China's answer to the US "Black Friday" consumer spree.

Power crisis fades

NBS spokesman Fu had told reporters previously that "current international environment uncertainties are mounting and the domestic economic recovery is still unstable and uneven." The economy grew only 0.2 percent from the previous three months in the third quarter, the weakest since a historic contraction in the first quarter last year.

On the positive side, industrial production grew 3.8 percent on-year in November, in line with expectations of a pick-up as disruptions from power shortages eased. Outages in recent months, which were linked to emission reduction targets, surging coal prices and supply shortages, had hit some factory production.

"Even though power supply shortages have eased recently, elevated input prices will linger... and sluggish domestic demand could be a longerterm drag," Moody's Analytics warned. Fixed-asset investment growth slowed to 5.2 percent in the first 11 months, with property investment rising six percent-down from the January-October period-amid falling home sales and tight financing rules.

'Wage arrears in property-related sectors, especially the construction sector, could also weigh on consumption," said Lu Ting, chief China economist at Nomura.

The Chinese property sector has been thrown into uncertainty as major developers such as the giant Evergrande Group struggle to dig out of



crushing debt burdens. China's economic growth rate came in below expectations at 4.9 percent in the July-September third quarter on the property sector woes and energy crisis. Policy makers have been grappling with a long-term slowdown in recent years, which follows decades of hyper-fast growth. Lu said consumer spending was likely to

"remain subdued" in coming months, including the upcoming Lunar New Year holidays, as authorities in some areas have encouraged consumers to avoid unnecessary travel. The extended holiday period, which falls at the beginning of February next year, is normally an important time for the travel and retail

Arabic calligraphy, a key tradition in the Arab and Islamic worlds, to its Intangible Cultural Heritage list. A total of 16 Muslim-majority countries, led by Saudi Arabia, presented the nomination to the UN Educational, Scientific and Cultural Organization, which announced the listing on Twitter. "Arabic calligraphy is the artistic practice of handwriting Arabic script in a fluid manner to convey harmony, grace and beauty," UNESCO said on its website.

"The fluidity of Arabic script offers infinite possibilities, even within a single word, as letters can be stretched and transformed in numerous ways to create different motifs." Saudi Culture Minister

Prince Badr bin Abdullah bin Farhan Al-Saud welcomed the decision and said it would "contribute to developing this cultural heritage", in a statement carried by the official Saudi Press Agency.

Abdelmajid Mahboub from the Saudi Heritage Preservation Society, which was involved in the proposal, said calligraphy "has always served as a symbol of the Arab-Muslim world".

But he lamented that "many people no longer write by hand due to technological advances", adding that the number of specialized Arab calligraphic artists had dropped sharply. The UNESCO listing "will certainly have a positive impact" on preserving the tradition, he added. According to the UNESCO website,

intangible cultural heritage "is an important factor in maintaining cultural diversity in the face of growing globalization". Its importance "is not the cultural manifestation itself but rather the wealth of knowledge and skills that is transmitted through it from one generation to the next".

Congolese dance

Also, the United Nations' cultural agency UNESCO on Tuesday added the Congolese rumba dance to its intangible cultural heritage list, sparking delight in the Democratic Republic of Congo and Congo-Brazzaville. A UNESCO summit approved the two countries' joint application to add rumba to its Intangible Cultural Heritage of Humanity list, where it joins Cuban rumba, the Central African Republic's polyphonic pygmy music and the drums of Burundi. DRC President Felix Tshisekedi welcomed the news "with joy and happiness" as citizens from both nations celebrated on social media.

"This cultural jewel unique to the two Congos is recognized for its universal value," Tshisekedi wrote on Twitter.
"Rumba is our identity! Its international recognition is a source of pride and a treasure," said DRC culture minister Catherine Furaha. Specialists have located rumba's origins in the ancient central African kingdom of Kongo, where people practiced a dance called "Nkumba". The word means navel as performances involved a man and woman dancing with their navel opposite the other person's.

'National life'

Africans brought their music and culture across the Atlantic through the slave trade, eventually giving birth to jazz in

North America and rumba in South America. Traders then brought the music back to Africa through records and guitars in more recent times. The modern version of rumba is 100 years old and symbolizes cities and bars, Andre Yoka Lye, a director at the DRC's national arts institute in the capital Kinshasa, told

Rumba has been marked by the political history of the two Congos before and after independence and is "present in all areas of national life", he added. It draws on nostalgia, cultural exchange, resistance, resilience and the sharing of pleasure through its flamboyant "sape" dress code, said Lye. "These treasures from Congo and exported throughout the

world are part of our pride," DRC government spokesman Patrick Muyaya tweeted last week in anticipation of the announcement.

Rumba stars are occasionally contro-

versial or mired in scandals. A French court on Monday convicted high-profile DRC performer Koffi Olomide of holding four of his former dancers against their will during tours. But the people of both countries say the dance lives on and hope its addition to UNESCO's list will give it greater fame even among Congolese. "It is our common duty to promote rumba," said the DRC's communications minister Muyaya. "We are the country of rumba, what will we make of it?" he asked. —AFP

rapper who allegedly told Megan Thee Stallion to "Dance, b***h" before shooting at the singer's feet after a Hollywood party was ordered to stand trial in California on Tuesday. The "Savage" singer was in an SUV with Tory Lanez driving away from a party hosted by Kylie Jenner when the pair got into an argument in June last year, a court in Los Angeles heard. A bikini-clad Megan Thee Stallion demanded to be let out of the Cadillac and then heard Lanez shout "Dance, b***h" as he opened fire with a handgun, Los Angeles Police Department Detective Ryan Stogner told a judge.

The "Hot Girl Summer" singer told police she was "bleeding profusely" from her feet and that she fell to the ground and crawled to a nearby driveway. Lanez then "emphatically apologized for what he did" and offered to drive her home, the court heard, with the rapper later telling officers he had offered her money not to say anything about the shooting.

Police responding to reports of a shooting later stopped the vehicle and took Megan Thee Stallion to hospital, where she initially told doctors she had hurt her feet on broken glass. Several bullet fragments were removed from her feet, but some remain and she told the detective that she had difficulty walking in certain shoes. She told Stogner she was "scared (Lanez) was going to get in trouble," but later alleged that he had shot her.

Investigating officers found four spent bullet casings at the scene of the alleged shooting. Megan Thee Stallion subsequently posted a video to Instagram Live in which she said "Tory shot me. You shot me and you got your publicist and your people... lying... Stop lying." Lanez, a 29-year-old Canadian whose real name is Daystar Peterson, has denied wrongdoing. "I have all faith in God to show that ... love to all my fans and people that have stayed true to me & know my heart ... a charge is not a conviction," he wrote on Twitter last year.

He also addressed the claims on his fifth album, "Daystar," wondering how someone could get "shot in your foot... don't hit no bones or tendons?" Lanez was charged in October 2020 with one count each of assault with a semi-automatic firearm and carrying a loaded, unregistered firearm in a vehicle. He faces more than 22 years in jail if convicted. At Tuesday's hearing a judge refused a defense application to dismiss the charges. Lanez is on bail, and set to be arraigned on January 13.—AFP

ESTONIA'S WOOD PELLET INDUSTRY STOKES CONTROVERSY

stonia's thriving wood pellet industry is pitting environmentalists who warn it increases logging and harms biodiversity against supporters who say it makes good use of wood that would otherwise go to waste. The subject is particularly sensitive in the tiny Baltic state once ruled by Moscow, whose forests cover more than half the surface area and are very much part of the national identity. But, at a plant belonging to Europe's biggest wood pellet producer, Estonia's Graanul Invest, the company's head of quality and certification systems defended the industry.

"Wood only comes to us when sawmill or plywood factories reject it," Mihkel Jugaste told AFP over the sounds of machinery turning logs into sawdust and compacting them into pellets. Wood pellets are a type of biofuel that can be used in special pellet stoves or central heating furnaces for homes. They are also used on a larger scale. The former coal-fired power station of Drax in Britain now runs partially on wood pellets, including some from Estonia.

Logging intensity 'too high'

Environmentalists say biomass demand in western Europe is causing an intensification of logging in places like Estonia, including in protected areas and using techniques such as clearcutting in which entire areas of forest are destroyed. They warn that bird species like black grouse and woodlark are under threat from the logging, pointing out that woodland bird numbers have fallen by around a quarter over the past two decades.

Their warnings have been heard in Brussels and the European Commission earlier this year initiated infringement proceedings against Estonia for failing to ensure environmental impact assessments before issuing logging permits in these areas. "The intensity of Estonian forest management is too high and pellet production within the forestry industry plays an important role," said Siim Kuresoo, forest program coordinator at the Estonian Fund for Nature.

"The initial idea of allowing wood to be

burned as renewable energy was only to lessen the waste of the industry. Now it has grown into a big industry by itself," he said. Wood and wood product exports make up around 10 percent of Estonia's total and the value rose by 48 percent to 165 million euros (\$186 million) for the 12 months until August 2021 compared to August 2020, according to official figures.

Graanul has also reported its revenues rose to 438.9 million euros in 2020 compared to 401.7 million euros in 2019. Jugaste said his company respects and will continue to abide by any environmental protection regulation but emphasized that sometimes stakeholders disagree on what the rules should be. "We, as a wood processor, cannot really decide for them," he said. "As long as experts make a decision about the protection status or the protection territory and that list is given to us, then we can protect it 100 percent," he added.

'An unbelievable myth'

An article in Nature Research in 2020 found that there had been an 85-percent increase in logged areas in Estonia between 2016 and 2018 compared to the period 2004-2015 - one of the largest expansions in the European Union. At the same time, thanks to natural reforestation and planting, the overall forested area in Estonia has increased to 2.3 million hectares in 2020 from 2.2 million hectares in 2001. The issue in Estonia is part of a wider European debate over whether wood pellets can be considered a carbon-neutral energy source as long as there is replanting of trees.

Many argue they cannot because burning wood is as dirty as coal and trees take many years to grow back. Taavi Ehrpais, a forest owner in northwest Estonia, said only about 10 percent of his timber - the lowest quality pieces - would end up in a pellet factory. Ehrpais, who is also the head of Vardi Metsauhistu, a forest management organization, said it was "an unbelievable myth" that the wood pellet industry was leading to an increase in logging. Ehrpais also defended logging laws, saying they were "very strict" and guaranteed biodiversity. —AFP

'She's big!'

He settles on his target and pulls the trigger. The startled pride grunts and disperses as a red-topped syringe filled with anaesthetic shoots into her neck. One of her sisters pounces over and swats it to the ground. Ten minutes later she's fast asleep, unresponsive to her peers' nudges. Rogers drives up to the tree, shoos away the others and sets to work. The team moves swiftly, blindfolding the animal to protect

her eyes and fitting her with a drip. They keep an eye on the horizon,

as other lions lurk nearby, and heave the 140-kilogramme (300pound) beast into a white fourwheel drive. "She's big!" says one vet, huffing as she slams the boot shut and jumps into the front seat, barely glancing at the sleeping killer behind her. The vehicle speeds through the reserve, lifting clouds of red dust and unsettling a tower of giraffe browsing treetops. Two ostriches trail along for a few meters before it turns out the gate and takes the main asphalt road into

'Meta' population

The surgery takes almost four hours, complicated by the lioness's swollen intestines. "They had just eaten a zebra so... she had a full stomach. It just made the (operation) a lot more difficult," said Rogers, standing by the enclosure where the animal woke up retching and groggy from the anaesthetic. "It's a very invasive technique," he conceded. "But as soon as you have got four fences around a place you have to manage it."

Conservationists and small reserve managers in 2010 set up a forum to manage their wild lions as a "meta

population". The Lion Management Forum South Africa (LiMF) oversees around 700 lions among 59

They mimic natural processes by controlling reproduction rates and swapping males. Careful management has allowed the meta population to grow at a sustainable two percent per year. "If we didn't do the management... the population would be increasing at 22 percent per year," LiMF chair Sam Ferreira said. "Now that sounds really nice, but the trouble is we don't have lots of space for that in South Africa." Globally, wild lions are disappearing fast, but South Africa has an abundant and growing population of around 3,500 - about 17 percent of the world's total.

"Smaller reserves have increased the lion range in the last 30 years probably by 50 percent," said Leo-Smith. Rietspruit's males will be replaced with younger lions when they age, and then some females will be taken off contraception. They remain king until then, golden manes framing their faces. Other reserves will probably still take them when they grow old, said Leo-Smith. "They will be very desirable for photographic reasons."—AFP

After months on the run, 2 zebras caught

wo zebras that had been on the run for months in the countryside outside Washington, DC, have finally been caught, an official said Tuesday. The pair had escaped from an exotic animal farm in Maryland at the end of August and eluded numerous attempts to capture them, their escapade enthralling local residents and media.

But after repeatedly thwarting the authorities, the quadrupeds have been snagged, said Richard Bell of the US Department of Agriculture, without providing any further details. Prince George's County, where the pair had been running free, announced several weeks ago that it planned to use "food and other zebras" to try to lure the striped fugitives back to the exotic animal farm.

The affair had been documented on social media by bemused residents, but the saga took a sad turn when a third zebra that had escaped with the others died after being caught in an illegal snare. Their owner, Jerry Holly, owns a large farm with a herd of around 30 zebras. He is facing charges of cruelty to animals after vet another zebra was found dead on his property in October, local media said. The possession of exotic animals, a phenomenon highlighted in the hit Netflix series "Tiger King," is allowed in some US states. —AFP

HK'S YOUNG 'NEON NOMADS' KEEP DYING TRADE FLICKERING

ong Kong (HK) was once world famous for its neonlight shop signs but many old masters took their secrets to the grave - now a generation of tech-savvy, globally connected young artists are trying to keep the trade alive. Karen Chan describes herself as a "neon nomad". Better known by her professional artistic name Chankalun, she had long been fascinated by the kaleidoscopic neon lights that bathed Hong Kong streets in a warm glow.

But finding someone who might teach her was far from easy. The trade has long been dominated by masters - "si fu" in Cantonese - who guarded their knowledge even as neon gave way to cheaper, more efficient LED lights and city officials began clamping down on unsafe hoardings. "The si fu will not pass on all the knowledge, especially if there are no guidelines or manuals, they will only pass on their skills to their own descendants," Chan said. Few family members wanted to take up a skill that was becoming redundant so many masters died without passing on their knowledge. "If you have very valuable skill or knowledge, you should be spreading it around so that it could live as well," the 33-year-old artist lamented. "Overprotection can be a cause for a lot of crafts to die."

Secret trade

Undeterred, Chan turned to the internet and travelled to places such as Amsterdam and New York to learn from artists there. There she discovered a global community of neon fans and professionals willing to trade tips. "There is an open sourcing culture appearing in the new generation of artists," she said. "Everyone is posting their experiments or their new finds on Instagram or Facebook, and everyone is very happy to share... this kind of knowledge," she explained.

The old generations see it as a secret trade." Chan, the only Hong Kong woman currently working within a traditionally male-dominated trade, operates out of a studio run by Jive Lau, a 38-year-old artist who also represents the new breed of younger neon light benders. Together they work glass to near melting point, bending and blowing the tubes

into remarkable shapes over blue flame burners that can reach 1,000 degrees Celsius (1,800 degrees Fahrenheit).

Lau was introduced to neon bending in Taiwan, where he said masters were more willing to share their knowledge with strangers. But he too has found the internet a huge help. "I keep learning from online resources and from watching videos," he explained. Today, he offers workshops to a growing number of neon enthusiasts. "The education can actually help... (in) promoting the neon culture, keeping it alive," he said.

The last light benders

Chan's current project is called "The Neon Girl" and involves her working with half a dozen neon light masters around the world to create six distinctive pieces. They are a far cry from the huge flashing signs that used to protrude horizontally from the sides of Hong Kong buildings, advertising everything from restaurants to mahjong parlors. Instead they have a modern, but still local vibe. "For neon to live... it needs

some other elements to inject into it, and this is what I'm doing as a new generation of neon artist," she explained.

She hopes the pieces will "break the boundaries or the perspective of how the people think of neon, that it can be expanded so that it can really live on a new form". She compares neon glass bending to an Olympic sport that requires strength, precision, and flexibility. And her stubborn perseverance has paid off in that she eventually found a si fu - known as Master Wong - willing to take her on. "Because I fell in love with this medium, I tried to do it myself, so I begged Master Wong and other neon benders in Hong Kong but they refused teaching me," she recalled. In 2018, she then decided to learn on her own and enlisted the help of a glass sculptor who watched the neon creation process on YouTube to explain the technique to her. After creating an art piece in a week, she returned. Master Wong, who is now 80 years-old and eschews publicity, was impressed with her work and agreed to take her on as an apprentice. "I think the neon masters in Hong Kong will never accept me as a real neon master," she said, "but maybe as a neon artist, which is fine with me." —AFP

Baboons can reproduce social conventions to problem solve

rench researchers have observed non-human primates developing social conventions to work together to obtain a reward, in an experiment set up with a group of baboons. About twenty baboons raised at a primatology centre were given the task in pairs of making the same choice when each presented with a set of two images on touch screens. If both animals made the same choice, they were rewarded with a treat. It took the baboons about three days to establish a system for choosing the same image, even when they could not see their partners' choices, says the report, published Monday in the journal Philosophical Transactions of the Royal Society B.

While previous research had shown that primates were capable of social conventions like grooming, this is the first to show a new behavior appearing spontaneously in a group, without human intervention. The experiment was conducted by French national research institute CNRS and Aix-Marseille University. Over the course of tens of thousands of tests the baboons developed a hierarchy for the images presented, the researchers noted.

At first the baboons could see what was happening on other animals' screens, but in the second phase of the experiment that visual cue was taken away. "The group's performance didn't budge," the study's main author, cognitive psychology researcher Anthony Formaux told AFP. "It surprised us when they continued to choose the same image without being able to imitate each other." Researchers ruled out the possibility of a simple shared affinity for certain colors by repeating the experiment with black and white designs. —AFP

PHOENIX, COLMAN MOVIES AMONG THE INDIE SPIRIT AWARDS NOMINEES

oaquin Phoenix's "C'mon C'mon" and Olivia Colman's "The Lost Daughter" were among this year's indie films to earn Spirit Award nominations on Tuesday, boosting their chances for Hollywood's upcoming prize-giving season culminating with the Oscars. The Spirit Awards, which only consider low- and mid-budget movies, named five best feature contenders including Phoenix's black-and-white family drama, and Colman's adaptation of an Elena Ferrante novel about motherhood. "Zola," a black comedy based

on a viral Twitter thread about a part-time stripper's disastrous trip to Florida, led the overall nominations with seven.

Rounding out the best feature category were Italian-language family drama "A Chiara" and college rowing thriller "The Novice." The Film Independent Spirit Awards are an important early marker for indie Oscar contenders. Only films made for less than \$22.5 million can compete. They are typically held the day before the Academy Awards, although the Oscars' delay this year

means indie stars will gather at a beach outside Los Angeles three weeks earlier, on March 6.

That means the winners will be revealed before voting has ended for the Oscars, which will take place on March 27. Each year, the Spirit Awards also gives the prestigious Robert Altman Award to a film's director, casting director and cast. This year's winner, "Mass," is the harrowing tale of the fallout of a school mass shooting, in which a victim's parents attempt to find closure through sitting down with the mother and father of the attacker.

Four of the five directors nominated were women, including Maggie Gyllenhaal for "The Lost Daughter." Like many Hollywood ceremonies, last year's Spirit Awards were forced online by the pandemic. A virtual ceremony also honored indie television for the first time. "After being away for more than a year, IFC is ready to bring audiences back to the beach celebrating the best of film and television," said Blake Callaway, general manager of the ceremony's broadcast channel. —AFP

Santa closed: In Beirut, crisis snuffs out Christmas spirit

eirut in December was once a shopping extravaganza, where day-long traffic jams clogged streets decked out with flashing Christmas lights and building-sized billboards advertising champagne and jewelry. In barely two years of a brutal economic collapse, the lights have gone out on Beirut's commercial heyday and power shortages have left the city's streets shrouded in gloom.

This year, the roadside billboards tell a different. more frugal story: one that reflects the worst financial crisis to ever hit the once free-spending Middle Eastern country. Steel safes, banknote counters, discounts on money transfers - the offers plastered on the bridges straddling the main highway into Beirut aren't vour typical Christmas pleasers. "Sales of safes and vaults have increased by 35 to 50 percent since the start of the economic crisis in 2019," a sales representative at Smartsecurity LB, one of the main retailers in Lebanon, told AFP.

Alarms and CCTV systems are also selling like hot cakes. The lack of trust in banks that are widely blamed for the worst financial crisis in Lebanon's history has raised the estimated amount of cash stashed away in Lebanese homes to a whopping \$10 billion. "We're at minus 90 percent compared to pre-2019 crisis levels," said Antonio Vincenti, chairman of the Pikasso out-of-home advertising company, a market leader in Lebanon.

'Last Christmas'

The banks, whose campaigns were once ubiquitous on his billboards, are insolvent, sometimes replaced by money transfer companies offering to funnel the diaspora's precious dollars into the country. "Digital screens remain switched off, mostly because of the problems we face in electricity supply," Vincenti said.

The government provides barely two hours a day of mains electricity and the cost of powering the screens with newly non-subsidized diesel would outstrip the income from clients. In Beirut's long-deserted downtown area, where luxury brands used to be concentrated, one apologetic Christmas sign still flashes at night with the words: "Despite it all". On Hamra, a main thoroughfare in central Beirut, there is little left of the high street Christmas shopping vibe and the mood echoes the popular hashtag "Santa bala shanta" (Santa without a sack).

Municipality budgets cannot keep traffic lights switched on, let alone the miles of string lights that used to canopy the street throughout December. Even Wham's usually unescapable seasonal hit "Last Christmas" is nowhere to be heard, a relief to some perhaps, but a sure sign that something has changed. On shop windows, Christmas sale posters are outnumbered by "We're Closed" signs - and beggars have replaced Santa impersonators on the street outside.

'No joy left'

The busiest shops are foreign exchange booths, which now provide free black plastic bags in which to carry out bulging wads of the ever depreciating Lebanese pound. Four out of five Lebanese are now considered poor, according to the UN income threshold of \$2 a day. At a supermarket in an upscale neighborhood of the capital, a half-bottle of the cheapest champagne costs 900,000 Lebanese pounds, substantially more than the minimum monthly wage, now worth less than \$25 on the black market.

In previous years, gigantic pyramids of panettone and Christmas hampers overflowing with foie gras and cognac obstructed the aisles. "This year there's an offer on detergent! Buy one, get one free," Christine Kreidy said, laughing, as she pushed her empty trolley past the welcome displays and into the silent store. "I suppose it's an opportunity to focus on the real meaning of Christmas but I have to admit I used to enjoy Christmas shopping," the 49-yearold said. "That's the thing though in Lebanon now: whether it's Christmas or any other day, there's no

mid the devastation after World War I, Verica Ivanovic's grandfather used whatever construction materials he could find to build the family's home including, unbeknown to him, bricks from the Roman Empire. The house and its ancient foundation are still used by the family in central Serbia's Stari Kostolacon the outskirts of what was once a major Roman settlement and military garrison then known as Viminacium.

It was only years later that the family realized the bricks were cobbled together from the ruins belonging to structures from the once powerful empire. Emilija Nikolic, a research associate from the Belgrade Institute of Archaeology, estimates that the bricks found on Ivanovic's house likely originate from the third or fourth century AD.

"It's kind of awkward, I know it's Roman. But everyone was doing it," Ivanovic, 82, told AFP. The fields around Viminacium remain an archaeological gold mine teeming with ancient coins, jewelry, and other artefacts. In an abandoned backyard near Ivanovic's home lies the remnants of an ancient Roman wall. "We were ploughing potatoes in a field. I looked down and saw a cameo... When I turned it with my hoe, I saw a beautiful female face," said Ivanovic. "It's in a museum now."

Buried treasure

For centuries, residents near Stari Kostolac have used the bricks and mosaic tiles and other pieces from antiquity that were found in abundance in the area to fill everyday needs. "Historians in the 19th century noted that a peasant from a nearby village used a sarcophagus as a pig feeder," Nikolic told AFP. Today, the sarcophagus-which features images from the ancient Greek myth of Jason and the Golden Fleece-resides in a museum. According to archaeologists, Viminacium was once the provincial capital of Rome's Moesia region and supported a population of about 30,000 inhabitants during

its heyday. Tens of thousands of artefacts have been unearthed from the area so far, including a Roman bath with heated floors and walls, a fleet of ships, and hundreds of sculptures. The ancient city is also believed to have been home to one of the largest necropolises discovered in territory belonging to the former Roman empire, with about 14,000 tombs unearthed. Viminacium started to decline following the Hun inva-

sion in the mid-fifth century AD and was completely abandoned by the time Slavs arrived in the region at the beginning of the seventh century.

What lies beneath

The archaeological site is also the only major Roman settlement that has no modern city built on top of it, according to experts. "You can't see Londinium" anymore because modern London is there. No Lutetia nor Singidunum-Paris and Belgrade are built on top of

it," said Miomir Korac, director of the Belgrade Institute of Archaeology. Sprawling underneath Stari Kostolac's corn fields are the remnants of the entire ancient city-including temples, an amphitheatre, a hippodrome, a mint and an imperial palace, according to extensive scannings, Korac said. Just two to three percent of the area has been excavated and explored by experts to date.

But centuries after its fall, the ancient garrison city is under siege again. For more than four decades, nearby mining projects, including the recent expansion of a coal project and a power plant, have increasingly encroached into the area. Last year, miners unearthed several ancient ships during a dig, with archaeologists dating the oldest vessel to the first century BC. "It has definitely put (the site) in danger, as many ancient buildings have already been destroyed by building the mine, Nikolic said. "We have saved what we could." —AFP

OJ Simpson a free man as parole ends: Police

Simpson, the professional football playerurned-movie-star whose double murder trial gripped and divided the United States, is a free man after finishing his parole, police said Tuesday. Simpson, who is now 74, was released from jail in Nevada in 2017, where he had served nine years for armed robbery in a case revolving around sports memorabilia. He had been due to finish parole in February. "The Nevada Board of Parole Commissioners conducted an early discharge hearing for Mr. Simpson," Nevada Police spokesman Kim Yoko Smith said.

"A decision to grant early discharge from parole was ratified on December 6, 2021. The Board awarded credits in an amount equal to the time remaining on the sentence to reduce the sentence to time served." Simpson's soap opera public life began as a stand-out running back in college football, winning the coveted Heisman Trophy for the best player in the nation, before a stellar career in the NFL. It morphed into lucrative success in movies and commercials.

Then in 1994, millions of Americans watched wall-to-wall TV coverage of Simpson traveling in a white Bronco driven by a friend, leading a police convoy along the highways of southern California as he fled over the suspected double murder of his exwife and her male friend. Simpson was famously acquitted in 1995 by a Los Angeles jury in a case decried by many as a media circus that became known as the "Trial of the Century," with a cast of larger-than-life lawyers and drama over whether or not a glove found at the scene would fit him.

The verdict was greeted with disbelief by many Americans, with opinion on the Black athlete's guilt divided sharply along racial lines. The case was turned into the Emmy-winning FX television series, The People vs OJ Simpson: American Crime Story," which aired in 2016. Simpson was found liable for the deaths in a 1997 civil suit and ordered to pay \$33.5 million damages to the family of Ron Goldman - who was stabbed to death alongside Simpson's ex-wife Nicole Brown Simpson.

Simpson maintains his innocence and has always denied he was trying to flee during the famous chase, even though he ignored a police deadline to turn himself in. He told an LAPD detective over the phone during the slow-speed pursuit to "let them all know I wasn't running," but rather visiting Nicole's grave. A duffel bag containing Simpson's passport and cash - as well as a gun - found by police in the car led many to question this, but was never submitted as evidence by the prosecution. He later authored a book entitled "If I Did It," which proffered a hypothetical description of the murders. —AFP

US sport on alert as COVID cases surge in NFL, NBA, NHL

Professional sports leagues on red alert

LOS ANGELES: Professional sports leagues across North America were on alert Tuesday as a surge of COVID-19 cases left dozens of players sidelined, prompted teams to shutter facilities and forced the postponement of more fixtures. The NFL, NBA and National Hockey League were scrambling to counter a sharp uptick in coronavirus cases as the Geneva-based World Health Organization warned the new Omicron variant was spreading at an unprecedented rate.

After a relatively untroubled opening three months of the American football season, COVID-19 has returned to stalk the NFL with a vengeance in

the past week. A day after the NFL reported a sharp spike in COVID-19 caseswith 37 recorded in a single day on Monday-the Los Angeles Rams and Cleveland Browns became the latest teams to be hit by the virus. The Rams closed their practice facility and entered the NFL's intensive safety protocols after nine players were

placed on the reserve/COVID-19 list. Affected Rams players included star wide receiver Odell Beckham Jr Four other Rams players were already on the COVID-19 list. Rams staff will work remotely on Tuesday and Wednesday and more cases are expected in what head coach Sean McVay said was a "uniquely challenging" situation. In Cleveland meanwhile, the Browns announced the team had also entered the NFL's enhanced COVID-19 protocols after eight players were put on the

reserve list. The Washington Football Team reported two more players on the team's COVID-19 list, taking the tally to 10. On Monday, US reports said a Washington employee-not directly involved with the playing or coaching staff-had tested positive for Omicron, the first known case of the variant in the NFL. As of November 17, more than 94% of NFL players have been vaccinated, while nearly 100% of NFL personnel have also been vaccinated.

NBA, NHL hit

In the NBA meanwhile, the Los Angeles Lakers cancelled a scheduled practice session on Tuesday after Talen Horton-Tucker tested positive. In a separate development, the Brooklyn Nets confirmed

that starters James Harden, LaMarcus Aldridge and DeAndre Bembry would miss Tuesday's home game against the Toronto Raptors after entering COVID-19 protocols.

Jevon Carter and James Johnson were also added to the COVID-19 list on Tuesday, joining the Nets Paul Millsap, who entered the protocols on Monday.

On Monday, the NBA said Chicago's games against the Detroit Pistons on Tuesday and Toronto Raptors on Thursday had both been called off, the first games of the season to be postponed due to COVID-19. Ice hockey was also facing a COVID resurgence. On Monday, the NHL postponed Calgary Flames games through to December 16 after six players and a member of staff entered the COVID protocols.

Seven NHL teams reported new COVID cases on Tuesday, and the Carolina Hurricanes were forced to postpone their game with the Minnesota Wild on Tuesday after an outbreak. COVID-19 con-

cerns have also placed a question mark over the participation of NHL stars at next February's Winter Olympics in Beijing. NHL Players Association executive director Don Fehr said on Saturday that a lack of "concrete answers" from Beijing Games officials about COVID-19 protocols, including quarantine rules, was creating uncertainty among players.

Speaking on a video conference call on Tuesday, USA Hockey executive director Pat Kelleher said that, although officials received fresh guidelines on Monday, they were still awaiting clarity on quarantine rules for any player testing positive for COVID-19 in China. "We are certainly hopeful that all systems will be go by the time we get ready to go to Beijing," Kelleher said. "But there's certainly work to be done. There are a lot of moving parts, a lot of things to be discussed and hopefully answered so that everybody can feel the best about sending the best players from the NHL." — AFP

F1 rivalry to set sail as Red Bull enters America's Cup

AUCKLAND: Red Bull announced yesterday it was entering a team in the America's Cup yacht race, in a move that will take its bitter Formula One rivalry with Mercedes onto the water. Red Bull Racing principal Christian Horner said the team will partner with two-time America's Cup winner Alinghi to challenge for yachting's most prestigious

"Our F1 team is looking forward to helping this new member of our family to succeed... we will share our experiences, engineering tips, etc. It is a two-way cooperation," he said in a statement. Rival syndicate Ineos Britannia already has close ties to Mercedes, which has been involved in a furious tussle with Red Bull during the FI season.

It culminated in Red Bull's flying Dutchman Max Verstappen being controversially crowned world champion over Mercedes' Lewis Hamilton of Britain this week, in a result the German team looks set to appeal. Both yachting teams will bring F1 technology to the spectacular 23-metre (75-foot) AC75 foiling monohulls used during the last America's Cup, won by Team New Zealand off Auckland in March. Alinghi, owned by Swiss billionaire Ernesto Bertarelli, won the America's Cup in 2003 and 2007 but has not competed since 2010.

Team New Zealand chief executive Grant Dalton said applying more FI expertise to the foiling yachts promised to make the next edition of the America's Cup one of the most exciting ever. "We are seeing the merging of two of the most technologically advanced sports in the world on land and on the water, which is only going to be a good thing for the competition and the growth of the sport and its audiences," he said. The venue of the next America's Cup in 2024 is yet to be determined, although Dalton has said it is unlikely to return to Auckland for financial reasons. — AFP

Stade Francais lose Nayacalevu but Naivalu stays

PARIS: Fiji international Waisea Nayacalevu is to leave Stade Français at the end of the season to join Top 14 rivals Toulon, the Mediterranean club announced on Tuesday. "One of the greatest talents of the Fijian team and the Top 14, the three-quarter Waisea Nayacalevu, is joining Toulon for the next two seasons (+ one optional)", the club said in a statement.

The versatile back joined Stade Français in 2012, helping them to win the Top 14 in 2015 and the European Challenge Cup two years later. "This player with exceptional athletic qualities combines the speed, creativity and unparalleled technique of Fijian artists with defensive solidity and a tactical brain recognized and feared at every ground," said Toulon.

The 31-year-old, who has 26 Fiji caps, has played 10 matches for the Parisian club this season, scoring four tries. Stade Francais, who are currently 10th in the Top 14, just ahead of Toulon, have been bouyed, however, by news that Australian three-quarter Sefanaia Naivalu has extended his contract for an extra two years until 2024. "Soon to return and for two more seasons. Sefanaia Naivalu extends (his stay) in the capital," tweeted Stade Français. — AFP

India's Kohli says given 90 minutes notice of sacking

NEW DELHI: Virat Kohli said yesterday he was told only 90 minutes before the official announcement that he had been sacked as India's one-day captain. Kohli quit as T20 skipper after the recent World Cup and last week lost the ODI job too, with India's cricket board saying it wanted Rohit Sharma to lead in both white-ball formats

The surprise announcement came in one line at the bottom of a press release by the Board of Control for Cricket in India (BCCI) about the Test squad for the upcoming tour of South Africa. "I was contacted one and a half hours before the selection meeting on the 8th for the Test series and there was no prior communication to me at all," Kohli told reporters yesterday ahead of the team's departure for South Africa, where they will play three Tests and three ODIs.

"Before ending the call I was told that the five selectors had decided that I would not be the ODI captain, to which I replied, 'ok fine'," the 33-yearold said. Kohli will still captain India in the Tests in South Africa but press reports suggested that he had decided to skip the subsequent ODI series in a huff. But Kohli denied this, telling reporters that

he "was and am available for selection" and hit out at sections of the media for "writing lies".

"Nothing can derail me from being motivated to play for India," he said. "I am very focused and mentally prepared and very excited to go to South Africa and do the best that I can for my team." Kohli said he would support "100 percent" Rohit and new manager Rahul Dravid, calling him a "very balanced coach" and a "great man-manager". "Rohit is a very able captain and very, very tactically sound. We have seen that in the games that he captained for India and in the IPL as well," Kohli said.

'Toughest conditions'

India have never won a Test series in South Africa, but Kohli said the visitors were motivated by the fact that the last Test they played there, in Johannesburg in 2018, they won. "We probably won in the toughest conditions in that tour, so that should give us a lot of confidence that if we have the right mindset and we start out the series with a lot of confidence, we can definitely stand up to any challenge that comes our way," Kohli said.

"South Africa is one place where we have not won a series yet. We are very motivated to do that and the mindset is always (to) go out there and win a series in any country that we play. We don't anymore just think of winning a Test match in India," he added.

This year India beat Australia 2-1 Down Under - albeit in Kohli's absence apart from the first Test - and were 2-1 up in England before the tour was called off because of the pandemic.

Last week in India, they thrashed New Zealand by 372 runs to win the series 1-0, avenging their loss to the Black Caps in the inaugural World Test Championship final in England in June. "South Africa presents a different kind of challenge. The wickets present a lot of pace and bounce and you need to be at your absolute best to be able to perform there and get runs," Kohli said. "I think we are very well placed in terms of experience and belief and confidence that this time around we can do something special and get the results that we want as a team."— AFP

Sergio Aguero - Impish striker who became a **Manchester City icon**

BARCELONA: Sergio Aguero ended his career with Barcelona but will forever be associated with Manchester City and in particular with the goal that won them the Premier League title in 2012. Aguero, who announced his retirement aged 33 on Wednesday because of a heart condition, spent a decade at the English club before departing at the end of last season as their all-time top scorer with 260 goals in just under 400 appearances.

One goal stands out above all the others. On May 13, 2012, Roberto Mancini's City came into the final day of the Premier League season ahead of rivals Manchester United at the top of the table only on goal difference. With United winning 1-0 at Sunderland and City losing 2-1 at home to Queens Park Rangers going into the 90th minute, it looked like a first league title since the Abu Dhabi takoever of 2008 would escape them.

But Edin Dzeko headed in the equalizer before Mario Balotelli pushed the ball into the path of Aguero to score the most dramatic of winners. "I swear you'll never see anything like this ever again," said Sky Sports commentator Martin Tyler, and the goal has gone down as arguably the most iconic moment in the history of modern English football.

There is even a 93:20 lounge at City's Etihad Stadium in a nod to the timing of Aguero's dramatic title-

clinching winner. Aguero, who ioined City from Atletico Madrid in 2011, won five Premier League titles in total in his time at the club, as well as one FA Cup and six League Cups. He came off the bench in last season's Champions League final defeat against Chelsea, having fallen from favor under Pep Guardiola towards the end of his time at the Etihad

Aguero scored 20 league goals or more in six seasons with City and is the highest overseas goal-scorer in Premier League history. He is also the fourth-highest scorer of all time in the division with 184 goals, behind Alan Shearer, Wayne Rooney and Andrew Cole. City announced that they would build a statue to honor the Argentinean striker. "A huge sense of satisfaction and pride remains in me for having played with Manchester City for a whole 10 seasons - unusual for a professional player in this day and age," Aguero wrote in March when revealing his departure.

Maradona connection

Aguero then helped Argentina win the Copa America in Brazil in July, their first major international trophy since 1993. He won his 100th cap in a 4-1 win over Bolivia in the group stage but played just one minute in the knockout phase and was an unused substitute in the final. It was

the second medal of his international career, though, as he also helped his country win Olympic gold alongside the likes of Lionel Messi and Angel Di Maria in Beijing in 2008.

Aguero signed a two-year deal with Barcelona in May, attracted by the prospect of teaming up with his friend Messi. They never played together, however. With the Catalan club in crisis, Messi departed for Paris Saint-Germain in August. Because of injury, Aguero didn't appear in a Barcelona shirt until October. He played just five matches, once from the start, before being taken to hospital with breathing problems after a match against Alaves on October 30 and being diagnosed with a heart condition.

Before joining Barcelona, Aguero whose nickname 'Kun' was inspired by a Japanese cartoon character - had been targeted by Argentine club

Independiente. The record seven-time Copa Libertadores winners are one of Argentina's traditional giants and the club where he broke through as a youngster. Aguero made his debut in the red shirt of Independiente aged just 15 in 2003 and thus surpassed the late, great Diego Maradona as the youngest player to play in the Argentine top division.

The impish forward was sold to Atletico in 2006 for a reported club record fee of over 20 million euros. He was just 18 when he first appeared for Atletico, coming off the bench to make his La Liga debut up front with Fernando Torres. He scored 74 La Liga goals for them, winning the Europa League and UEFA Super Cup in 2010. Off the field, Aguero married Maradona's daughter Gianinna, although the relationship, which produced a son, lasted only four years. — AFP

Gnabry hits hat-trick as Bayern crush strugglers Stuttgart 5-0

Bayern go nine-points clear in Bundesliga

BERLIN: Bayern Munich opened a nine-point lead at the top of the Bundesliga on Tuesday as Serge Gnabry claimed a hat-trick and Robert Lewandowski scored twice in a 5-0 rout at strugglers Stuttgart. Bayern head coach Julian Nagelsmann promised to supply beers for the ride home - "we always have a crate on the bus" -

Premier League increases COVID testing

LONDON: Premier League players and staff must take a lateral flow test every time they enter their club's training ground as part of strict new measures to curb the threat of the coronavirus. The protocols were agreed after Manchester United's Premier League match at Brentford on Tuesday and Tottenham's trip to Brighton last Sunday were postponed due to COVID-19 outbreaks. United, Tottenham, Brighton, Leicester, Norwich and Aston Villa have all been hit by the virus over the last week as the new Omicron strain threatens to cause havoc in England's top-flight.

Twice-weekly PCR testing is also reported to have been introduced after a clubs' shareholders' meeting on Tuesday. The increased testing will sit alongside the other recently introduced emergency measures, including face coverings, limiting time in the treatment

room and observing social distancing. The Omicron variant has become the dominant strain of the coronavirus in Britain and the Premier League has not been

Premier League officials announced on Monday there had been 42 positive COVID cases among Premier League players and staff last week - the most recorded by the top-flight in any seven-day period since testing began during the 2019-20 season. The most positive tests returned in a week this season was 16 from August 16-22. The league's clubs discussed the Government's COVID Plan B measures at their meeting on Tuesday, which are set to come into force in England on Wednesday.

The measures require spectators to provide proof of full vaccination or a recent negative lateral flow test in order to enter venues holding more than 10,000 people. Sports Minister Nigel Huddleston said on Tuesday the measures were "proportionate" to the situation the country faced at this moment, but refused to rule out even stricter measures such as forcing clubs to reduce capacity at matches.

"What we are doing is focusing on the situation at the moment and that we're carefully monitoring the situation," he said. "The Prime Minister said yesterday

that we will have to deal with this COVID situation as the facts tell us, so I can't rule anything out. But we need to deal with the situation as it is at the moment and we believe the measures brought in place now are proportionate."—AFP

Shevchenko gets first Genoa win

MILAN: Andriv Shevchenko got his first win as Genoa coach on Tuesday with a 1-0 success over Salernitana booking an Italian Cup last 16 clash against his former club AC Milan. Ghana international Caleb Ekuban's 76th-minute header lifted the north-western port side to their first home win this season. Former AC Milan and Chelsea player Shevchenko took over in early November, replacing Davide Ballardini after a miserable start to the campaign.

It was the Ukraine forward's first club management role after coaching his national side for five years. Shevchenko's Genoa desperately needed a result with their only success in the league back mid-September against fellow strugglers Cagliari. "I'm really very happy, the squad suffered a lot today and it was important for us to get back winning," said Shevchenko whose side play Milan in January.

The 45-year-old scored 175 goals in 324 matches in two spells with Milan, twice emerging as Serie A's top scorer and winning a league title and the 2003 Champions League. Promoted Salernitana crashed out of the competition as they also sit bottom of Serie A with a seven-match winless run in the league. Elsewhere, Udinese and Venezia also advanced to the last 16 with wins over Crotone (4-0) and Ternana (3-1) respectively. —AFP

Boca beat Barcelona in inaugural Maradona Cup

'That's greatness!' Stephen Curry sets NBA three-point record

clash with the Toronto Raptors both called off.

LOS ANGELES: A Brooklyn Nets team rocked by the absence of seven players because of coronavirus clawed out an unlikely 131-129 overtime victory over the Toronto Raptors on Tuesday. The Nets had the league-minimum eight players available at Barclays Center in Brooklyn, where star James Harden and Bruce Brown were late scratches. The Nets had announced earlier in the day that starters LaMarcus Aldridge and DeAndre Bembry would miss the game.

Jevon Carter and James Johnson were also added to the virus list, joining Paul Millsap, who entered the NBA's COVID-19 protocols on Monday. "It's unfortunate, for sure," Nets coach Steve Nash said shortly before the contest tipped off. "Fortunately for us they're predominantly asymptomatic, but there will be a period of time required for them to test negative and have our full group together."

Kevin Durant helped the Nets pull through with a triple-double of 34 points, 13 rebounds and 11 assists. Durant, who had been listed as "questionable" to play because of a sore ankle, played a game-high 48:11 minutes. Patty Mills added a season-high 30 points and forced overtime with a three-pointer with 13.1 seconds remaining in regulation.

All of the Nets players in the COVID protocol had to provide proof of vaccination in order to play in Brooklyn, under New York City's coronavirus rules. Under NBA guidelines, vaccinated players are placed in COVID protocols when they test positive or have an inconclusive result. They must quarantine for 10 days or until they have two negative tests within 24 hours. "It's a new normal, but it's scary because I don't know that there's an end in sight," Nash said of the pandemic. "This is kind of the world we may live in for indefinitely."

The Nets aren't the only NBA team grappling with an uptick in COVID cases. The Los Angeles Lakers cancelled their last practice before they were due to travel to Dallas on

Giannis Antetokounmpo would miss the game against the Indiana Pacers after being placed in the COVID protocols. Newly signed guard Wesley Matthews Jr had already been placed in the health and safety protocols earlier this week.

Golden State Warriors star Stephen Curry eclipsed Ray Allen's all-time record for NBA three-pointers on Tuesday, savoring a "beautiful moment" at storied Madison Square Garden. Curry, whose remarkable shooting range has revolutionized the NBA in his 13-year tenure, matched Allen's record with his 2,973rd career three-pointer. It came on his first shot of the clash with the New York Knicks, less than two minutes into the contest, and had the crowd on its feet.

He then missed a chance at breaking the record, but with 7:33 remaining in the opening period, Anthony Wiggins kicked the ball to him from the paint and he swished in number 2,974, letting out a yell as teammates celebrated with him and the New York crowd cheered. "I can't say it enough, I appreciate so much the way the fans embraced the moment with me and let me just get kind of lost in it," Curry, 33, said. "Hell yeah!" teammate Draymond Green shouted as the Warriors called a timeout and photographers gathered around Curry. "That's greatness!" Curry has been scorching

towards overtaking Allen's record for years. He finally surpassed the milestone in his 789th career game; Allen achieved his old benchmark in 1,300 appearances. Curry exchanged an emotional hug with coach Steve Kerr, who corralled the ball used in the record-setting shot. Curry then embraced his father, former NBA player Dell Curry, as well as Allen, who was courtside.

"There was a lot of emotion for sure because I know how much work has gone into this, dreaming big from the time I first picked up a basketball," Curry said. Kerr said the moment was "more emotional" than he had expected. "It was just an outpouring of love and support for Steph from seemingly everybody in the building," Kerr said. "Beautiful, beautiful moment." Curry is on pace to make well over 400 three-pointers this season, which would put him at more than 3,200 for his career. He finished the night with five three-pointers as the Warriors pulled away late to beat the Knicks 105-96 and improve their league-leading record to 23-5. Curry's long-range prowess is such that there was real belief he could break the record with a single-game mark of 16 in a home game against the Portland Trail Blazers last Wednesday. That didn't happen, but he did not have to wait too much longer.

Electric atmosphere

Curry's 54-point performance against the Knicks on February 27, 2013 at Madison Square Garden was a harbinger of a career that now includes three NBA titles and two Most Valuable Player awards. "It's been a long week since our last home game, where everybody was talking about 16," he said. "(It) seemed like every shot I took there was another level of anticipation and anxiousness around it.

"I was just trying to play my game. Tonight it kind of set up perfectly, made that first one, get that one out of the way and then just let the record-breaker come to me." The

atmosphere was electric even before the game, with Allen courtside and Reggie Miller, who held the three-point record at 2,560 before Allen broke it in 2011, on duty as a television commentator. Both chatted and shared a hug with Curry before the game, with filmmaker and Knicks super-fan Spike Lee catching the moment on his phone camera.

After the game, Allen and Miller presented Curry with a jersey with the number 2,974 emblazoned on it. "Basketball history, this is pretty special," Curry said. "These two, legends. I watched them growing up and understood what it meant to shoot the ball because of them and my dad. "Full-circle moment, man. I'm blessed, blessed for sure."—AFP

Man City demolish Leeds 7-0 as virus fears mount

LONDON: Manchester City powered four points clear at the top of the Premier League as Kevin De Bruyne inspired a 7-0 rout of Leeds just hours after clubs were given strict new measures to curb the threat of the coronavirus on Tuesday. De Bruyne delivered an imperious display including two goals on his first league start since November 6 after the Belgian star recovered from a bout of COVID-19.

Phil Foden, Jack Grealish, Riyad Mahrez, John Stones and Nathan Ake were also on target as Pep Guardiola's side ran riot at the Etihad Stadium. City's seventh successive league victory put pressure on second placed Liverpool and third placed Chelsea, who face Newcastle and Everton respectively today. The champions' biggest win this season equaled Liverpool's 1982 top-flight record of 33 victories in a

calendar year. "We're proud of the way we're playing. When you get these results it is because individually they are brilliant," Guardiola said.

"Kevin, in these type of games when it is open up and down, is devastating as he can do what he wants. He's so important for us." It was the joint biggest league defeat in Leeds' history and shell-shocked boss Marcelo Bielsa said: "We've never had a performance like this. There is no justification. I have to take responsibility."

City took the lead in the eighth minute when Foden's shot was deflected in via Stuart Dallas's miscued attempt to clear off the line. It was City's 500th Premier League goal in 207 matches under Guardiola, setting a new record that surpassed the previous fastest mark by Jurgen Klopp's Liverpool. Grealish had managed just two goals for City since his British record £100 million (\$132 million) transfer from Aston Villa.

In the 13th minute, the 26-year-old headed in Mahrez's cross to score for the first time since September. De Bruyne marked his return with his first goal since October, converting Rodri's defense-splitting pass in the 32nd minute. Mahrez added

City's fourth in the 49th minute when his strike deflected in off Junior Firpo. De Bruyne made it five in the 62nd minute with a thunderous 20-yard drive into the roof of the net. Stones blasted home in the 74th minute and Ake headed City's seventh four minutes later.

'Tough few days'

Whether City's determined title defense survives without a brush with COVID remains to be seen as the new Omicron strain wrecks havoc. The Premier League announced on Monday there had been 42 positive COVID cases among top-flight players and staff last week - the most recorded in any seven-day period since testing began during the 2019-20 season.

Manchester United's match at Brentford on Tuesday and Tottenham's trip to Brighton last Sunday were both postponed due to virus outbreaks. United and Tottenham had several unnamed players test positive, while Brighton, Leicester, Norwich and Aston Villa were also hit by the virus over the last week. Now all top-flight players and staff will have to take a lateral flow

test every time they enter their club's training ground as part of the protocols. Twice-weekly PCR testing will also be introduced after a meeting of the 20 clubs on Tuesday.

The increased testing sits alongside the other recently introduced emergency measures, including face coverings, limiting time in the treatment room and observing social distancing. Norwich manager Dean Smith revealed his club had asked the Premier League for guidance over his bottom of the table team's COVID issues prior to Tuesday's 2-0 defeat against Aston Villa. "It's been a tough few days. We've had a few COVID-related drop outs," Smith said before kick-off at Carrow Road.

Villa were also hit by COVID but they kept their focus to make it four wins from six games under new boss Steven Gerrard. Smith had hoped for revenge on Villa just 38 days after his sacking. But Jacob Ramsey ran from the halfway line to fire home in the 35th minute and Ollie Watkins tapped in after 87 minutes. "It's been a challenging week," Gerrard said. "We have to make sure we're very diligent with the guidelines. Nobody wants to see the situation deteriorate."—AFP
