

MoI warns reckless drivers

19,000 expats deported, 3,500 licenses revoked over traffic violations



KUWAIT: Acting Prime Minister and Interior Minister Sheikh Talal Al-Khaled Al-Sabah affirmed on Wednesday the importance of dealing with reckless drivers firmly and traffic congestions promptly to ensure everyone's safety, as the new academic year starts next week. A statement released by the ministry's public relations and media security department said Sheikh Talal headed a security meeting with Undersecretary Lt Gen Anwar Al-Barjas to follow up on the ministry's readiness to handle traffic congestions during school hours.

Sheikh Talal stressed the importance of police presence on all roads and intersections that lead to schools in residential areas to help reduce traffic jams and eliminate illegal parking in front of schools. He also ordered to boost security and traffic awareness campaigns to provide parents and drivers with all the necessary information needed to avoid bad behaviors by motorists that can affect the safety of other drivers.

Meanwhile, the traffic department has confirmed that the implementation of ministerial decision 270/2020, which calls for the revocation of expatriate driving licenses for those who do not meet the

required conditions, is still in effect. The department has been diligently monitoring compliance on a daily basis, adding 3,500 licenses were permanently revoked in the first half of 2023.

Additionally, the department said 14,000 licenses of citizens have been temporarily suspended for various reasons, including administrative issues, medical concerns, military obligations and exceeding the maximum penalty points. The department emphasized that the deportation of expatriates who violate traffic regulations and commit serious infractions is occurring at a significant rate due to ongoing enforcement campaigns and road monitoring. It stressed that there are no exceptions or leniencies in this regard.

Furthermore, the traffic department noted that nearly 19,000 expatriates were deported by the end of August for offenses such as speeding, running red lights, illegally ferrying passengers, driving in the wrong direction and driving without a valid license. It also reported that the total number of traffic violations committed by both Kuwaiti and expat motorists amounts to nearly 3 million, with two-thirds of these violations classified as indirect.

FMs discuss Kuwait map 'mishap'

KUWAIT: Kuwaiti Foreign Minister Sheikh Salem Al-Abdullah Al-Sabah and his Egyptian counterpart Sameh Shoukry discussed in a phone conversation late Tuesday the "map mishap" issue, when an unofficial map of the Arab World was used at a training course in Egypt attended by Kuwaiti officers without including the internationally recognized borders of Kuwait. Shoukry affirmed that this incident was unintentional, vowing a thorough investigation into the matter. Those responsible for this mishap would be held accountable, he said, adding this mistake did not reflect the strong relations linking Kuwait and Egypt. — KUNA

KU to cancel coed class: Hayef

KUWAIT: MP Mohammad Hayef announced reaching an agreement with the education ministry and Kuwait University to enforce the coeducation ban and cancel a class in the Faculty of Law where male and female students were scheduled to enroll. Hayef, who chairs the alien phenomena committee at the National Assembly, said that the panel agreed with the ministry to make sure that the coeducation ban remains enforced at all Kuwait University faculties. "The morals of the Kuwaiti society and Islamic sharia have put together standards to protect our young people," the lawmaker said during a press conference on Wednesday.

Largest liquor brewery busted

KUWAIT: The interior ministry busted on Wednesday "the largest liquor factory" in Abdaly farms, run by six Asians. The ministry said officials from the Criminal Investigation Department monitored and traced the suspects and were able to apprehend them in a farm in Abdaly. It noted six Asians were apprehended and 236 barrels and manufacturing equipment were confiscated during the raid. — KUNA



Kuwait qualify for U23 Asian Cup 2024 finals

KUWAIT: Kuwait's Olympic football squad drew 2-2 with Iraq, leaders of Group F of the AFC U23 Asian Cup Qatar 2024 qualifiers on Tuesday, securing a ticket to the final round of the cup. The encounter, held at Kuwait Sports Club Stadium, saw a goalless first half before Salman Al-Awadhi scored the opener for the Blues in the 48th minute. Bander Al-Salameh doubled Kuwait's lead in the 65th minute.

Iraq, undeterred, were able to come back with goals from Dhul-Faqar Younus in the 69th minute and Mustafa Al-Korji

in the 70th minute. Kuwait ranks second in Group F after Iraq on goal difference, with seven points each. Qatar's iconic Lusail Stadium, which staged the FIFA World Cup 2022 final, will host the first match of the AFC U23 Asian Cup. The finals, which will take place from April 15 to May 3 next year, are also a qualifying event for the 2024 Olympic Games in Paris.

Saudi Arabia also secured their place at the AFC U23 Asian Cup finals with a comfortable 6-1 victory over Cambodia at the Prince Sultan bin Abdulaziz Sports City Stadium in Abha on Tuesday. Striker Ahmed Al-Ghamdi scored twice, in the sixth and 17th minutes. Abdullah Radif also grabbed two for the Green Falcons, in the 26th and 56th minutes, while Musab Al-Juwair added to the tally in the 39th minute and Mohammed Abu Al-Shamat in the 87th. — KUNA



Fears mount of rising death toll in Libya

DERNA, Libya: Libya was reeling Wednesday from a massive flood that left thousands dead and missing, wreaking havoc in the eastern city of Derna where bodies wrapped in blankets lined the ravaged streets. Relief missions gathered pace with Turkey, Egypt and the United Arab Emirates among the first nations to rush aid to the warscarred country after the disaster that also displaced tens of thousands. A Kuwaiti flight arrived in Libya Wednesday with 40 tons of supplies.

The Mediterranean coastal city of Derna was hit by a huge flash flood late Sunday that witnesses likened to a tsunami after two upstream dams burst when torrential rains brought by Storm Daniel battered the region. Media reports

Kim meets Putin, says Russia will win 'great victory'

MOSCOW: Kim Jong Un told President Vladimir Putin on Wednesday he was sure Russia would win a "great victory" over its enemies, as Ukraine's Western allies warned of a possible Russian arms agreement with North Korea. Russia became a pariah in the West after launching full-scale hostilities in Ukraine last year and has looked to strengthen alliances with other hardline leaders ostracized by democratic countries.

Footage broadcast on social media by state media showed an apocalyptic landscape in the city, with debris littering streets and people lifting sheets off bodies lying on sidewalks to try to identify them. Satellite images of Derna after the surge of water showed coastal neighborhoods almost entirely submerged. The United Nations has pledged \$10 million in support for survivors, including at least 30,000 people it said had been left homeless in Derna.

The wall of water ripped away buildings, vehicles and the people inside them. Many were swept out into the sea, with bodies later washing up on beaches littered with debris and car wrecks.

Traumatized survivors have dug through the mud-caked ruins of shattered buildings to recover bodies, scores of which were lying out in the open Continued on Page 6

"We are confident that the Russian army and people will win a great victory in the just fight to punish evil groups who pursue hegemony, expansion, and ambition," Kim told Putin, raising a toast during an official dinner following one-on-one talks. Kim also praised the "heroic" Russian army in comments that news agencies sponsored by Moscow interpreted as relating specifically to Moscow's large-scale military operation in Ukraine.

Putin meanwhile praised "the future strengthening of cooperation and friendship between our countries," while hosting Kim at a Far East spaceport, and later told reporters he saw "possibilities" for military cooperation with North Korea. He had earlier said Moscow could help Pyongyang build satellites and suggested the countries might also discuss military cooperation.

Kuwait ambassador and Iraq defense minister discuss ties

MP asks about Kuwait loans and investments in Iraq

KUWAIT: Kuwait Ambassador to Iraq Tariq Al-Faraj on Tuesday discussed with Iraqi Minister of Defense Thabet Al-Abbasi the bilateral relations and ways to develop them. The meeting dealt with several files of common interest and the mechanisms for enhancing cooperation between the two

countries and serving the interests of the two brotherly peoples, Ambassador Al-Faraj said. The Iraqi minister asked Al-Faraj to convey an invitation to Kuwait Minister of Defense Sheikh Ahmad Fahad Al-Sabah to visit Iraq.

Meanwhile, MP Jarrah Al-Fouzan asked the foreign minister about the total value of loans and grants offered by Kuwait to Iraq since the liberation of the

country from a seven-month Iraqi occupation in February 1991. He also inquired about the commitment of the Iraqi government to repayment of the loans. The lawmaker also demanded copies of all cooperation agreements signed by the two countries in the past three decades, especially agreements related to promotion of investments in Iraq.

In another question, MP Fouzan said

that in 2018, Kuwait hosted a conference for Iraqi reconstruction in which pledges by the international community reached \$30 billion, of which Kuwait contributed \$1 billion in the form of a loan and the other billion in the form of direct investments in Iraq. He asked if Iraq had repaid the \$1 billion loan.

He also asked the minister about the total value of Kuwaiti investments in Iraq

over the past five years. The lawmaker demanded a copy of a protocol signed by the two countries regarding joint investments in border oilfields and what happened about the agreement. Meanwhile, MP Adel Al-Damkhi called on Tuesday for the government to transfer the forensic and criminal evidence department from the interior to the justice ministry in order to avoid legal problems.



S Sudan lauds Kuwait humanitarian efforts

KUWAIT: Kuwait Minister of Foreign Affairs Sheikh Salem Abdullah Al-Jaber Al-Sabah met with Minister of Humanitarian Affairs and Disaster

Kuwait stresses the importance of Arab Parliaments summit

DOHA: The Secretary-General of the Kuwait National Assembly, Khalid Abu Salib, has stressed the importance of the 10th annual conference of the Association of Secretaries-General of Arab Parliaments in its 43rd meeting, as it contributes to strengthening joint Arab action and developing Arab parliamentary relations. In a statement to KUNA, Abu Salib said after the opening session that the General Secretariat of the Assembly played a pioneering role in establishing, supporting, and sponsoring the association since its founding in 1994.

The conference program includes discussing a working paper entitled "Digital Democracy, Social Media, and the Role of Councils in Promoting It", confirming that the general secretariat of the Ku-

wait National Assembly has the lead in using modern technological and electronic systems to keep pace with modern developments and serve those working in the parliamentary field.

In a similar statement, the head of the information security department at the National Assembly, Engineer Fahd Al-Hatem, said that the working paper addresses several topics, including electronic voting, publishing records electronically, and how to spread parliamentary awareness electronically.

Al-Hatem added that the Kuwait National Assembly is currently the only Arab parliament to vote for the positions of the General Secretariat and parliamentary committees electronically, pointing to the system of documenting parliamentary papers, which is one of the largest projects in the Council, as it has converted approximately 400,000 parliamentary documents into a digital copy and is available to everyone. The tenth annual conference of the Association of Working Secretaries of Arab Parliaments began Tuesday in the Qatari capital, Doha, and will continue its sessions on Wednesday. — KUNA

KUWAIT: Georgetown University in Oatar (GU-Q)'s three-day conference, "The Invasion of Iraq: Regional Reflections," opens on Thursday, September 14, with discussions on the multifaceted impacts of the conflict and its repercussions for global diplomacy. Former president of the Republic of Iraq, Dr Barham Salih, is set to deliver a distinguished keynote address and share further insights in a conversation with Peter Harling, founder and director of the Beirut-based Synaps Network.

The conference is convened by GU-Q's Dean, Dr Safwan Masri, in collaboration with the Center for International and Regional Studies (CIRS). Dr Robert Groves, Provost of Georgetown University in Washington, DC, and Dean Masri will present opening remarks. "It's a great honor and pleasure to have Barham Salih delivers the keynote speech at the conference. A long-term Kurdish Iraqi politician, who served as the eighth president of Iraq between 2018 and 2022, he has a profound, personal understanding of the complexities involved in Iraq's multi-ethnic, multi-religious socio-political landscape.

The opening will also feature a high-level panel, "The Iraq War and Global Diplomacy," with senior diplomats sharing their perspectives on the role of international diplomacy during and after the 2003 invasion. The engaging discussion will be moderated by Al Jazeera's Laila Al Shaikhli.

Running until September 16 at the Four Seasons Hotel in Doha, the conference creates an inclusive space for an exchange of perspectives among top scholars including GU-Q faculty, policymakers, journalists, filmmakers, and the wider public. "At the heart of this conference lies a dedicated effort to elevate diverse voices and perspectives from within Iraq," emphasized Zahra Babar, Associate Director for Research at CIRS. "Our goal is to transcend the boundaries of scholarly discourse, and to ensure that the live experiences and personal narratives of Iraqis are an integral part of the conversation."

With a focus on Iraq's current political, social, and economic dynamics, September 15 will feature a plenary on "Regional Security Perceptions Post-US Invasion of Iraq." Discussions will probe youth and activism, relations with Iraq's key regional neighbors, as well as the view from Kuwait and Qatar. The closing day on September 16 will consider the obstacles confronting future generations such as the emergence of Da'esh, the role of women, global governance, and natural resource management, with a final plenary on "US Foreign Policy towards the Region." GU-Q's Hiwaraat Conference Series has been launched as a platform that brings together scholars, policymakers, and government officials from around the world to explore challenges and solutions for a better future.





First KRCS planeload of supplies arrives in Libya

CAIRO: Kuwait's plane arrived in Libya carrying 40 tons of equipment, food, medical supplies, power generators and tents on board, in addition to rescue boats provided by Kuwait Fire Force. In remarks to KUNA, Libyan Foreign Minister Dr Abdul Hadi Al-Hawaij expressed his thanks and appreciation for Kuwait's humanitarian efforts in relieving those afflicted by Storm Daniel, appreciating the immediate response.

The Minister said that the disaster exceeds the available capabilities, calling for concerted humanitarian relief efforts from all parties to help Libya overcome this unprecedented ordeal. In turn, the head of the KRCS mission, Dr Musaed Al-Enezi, said that the Kuwaiti Air Force plane landed in Benghazi, northeastern Libya, carrying a shipment of various relief materials commensurate with the basic needs required by such conditions.

The Kuwait Red Crescent Society announced on Wednesday that the first planeload of relief supplies has taken off for Libya to relieve victims of

the devastating floods. The KRCS said in a statement that the plane of the Kuwait Air Force took off from Abdullah Al-Mubarak Air Base, flying to Libya. The Kuwaiti aid supplies are destined for victims of the ravaging hurricane Daniel, which caused floods on large swaths of the Libyan territories, claiming more than 5,000 lives and inflicting wide-scale destruction.

KRCS Deputy Chairperson Anwar Al-Hasawi affirmed in remarks to KUNA that the supplies were dispatched in line with instructions by the political leadership to relieve the floods' victims rapidly. The urgent flight was organized after the KRCS coordinated with the Libyan Red Crescent, the Kuwaiti ministries of defense and foreign affairs, the Kuwaiti ambassador to Libya, and the Libyan envoy in the country. He indicated that other flights carrying identical materials would be organized for Libya.

Solidarity with Libya

The Arab Inter-Parliamentary Union expressed solidarity with Libya after the deadly flooding that ravaged the eastern region of the country. In a statement on Tuesday, the AIPU appealed for the Arab countries and the international community to join forces immediately to provide urgent aid to Libya and help alleviate the impacts of this natural disaster. The AIPU Presidency offered sincere condolences to the Libyan people and government, expressing sympathy with the families of the victims. — KUNA

Chinese envoy lauds Kuwait ties, embassy marks anniversary

KUWAIT: Chinese Ambassador to Kuwait Zhang Jianwei described the upcoming visit of HH the Crown Prince Sheikh Mishal Al-Ahmad Al-Jaber Al-Sabah to the opening of the Asian Games as a historic event for China that will play a crucial role in advancing their strategic partnership. During a press conference held on the occasion of the 10th anniversary of the launch of the Belt and Road Initiative, Ambassador Zhang affirmed that HH the Crown Prince of Kuwait will attend the opening of the 19th Asian Games in the city of Hangzhou. This marks his first visit to China since assuming the role of Crown Prince.

"This year marks the fifth anniversary of the establishment of strategic partnership relations between China and Kuwait, and this visit is considered a historic one. It will effectively strengthen the traditional friendship, deepen mutual strategic trust, and enhance cooperation between the two countries in various fields within the framework of joint construction of the 'Belt and Road' initiative," Zhang said.

The ambassador pointed out that China will continue its efforts to enhance cooperation with Kuwait, emphasizing that China has become the largest trading partner for more than 140 countries. "We believe in fostering development and stability in the region and reject the politicization of economic issues. We seek cooperation and solidarity with all countries, especially in the face of real challenges that require international cooperation," he said.

Ambassador Zhang highlighted that Kuwait was the first Gulf Arab country to establish diplomatic relations with China and the first Arab country to sign a memorandum of understanding with China regarding the joint construction of the Belt and Road Initiative. Additionally, Kuwait is the Arab country that provides China with preferential government loans.

"Kuwait is the only Gulf country to which the Chinese government has sent a Chinese medical team. Since 1976, the Chinese government has sent 23 batches of medical teams to Kuwait. These actions

reflect the development of friendly China-Kuwaiti relations and highlight the cooperation between the two countries. Kuwait is one of the friendliest countries towards China, and Chinese-Kuwaiti relations serve as a model for exchanges between countries.

In 2018, during the visit of His Highness the late Amir Sheikh Sabah Al-Ahmad Al-Jaber Al-Sabah to China, the two leaders announced the establishment of strategic partnership relations between China and Kuwait," he pointed out. Zhang confirmed that both countries maintain close communication and support each other in international and regional affairs. He stressed the importance of dealing with global challenges through mutual respect and finding common ground for peaceful coexistence.

"Kuwait enjoys a distinct geographical location, and in recent years it has put forward its Vision 2035, which seeks to develop a diversified and sustainable economy, which is largely consistent with the strategy of the Belt and Road initiative. China always views Kuwait as an ideal and natural partner in jointly building the Belt and Road, as they enjoy strong economic complementarity and similar development concepts," he said.

Regarding economic and trade cooperation, the ambassador noted that since 2015, China has consistently been Kuwait's largest trading partner. In 2022, the total bilateral trade volume between the two countries reached \$31.48 billion, representing an annual increase of 42.3 percent. Kuwait is also the seventh largest source of crude oil imports to China, as China imported 33.28 million tons of crude oil from Kuwait, an annual increase of 10.34 percent.

Zhang revealed that approximately 60 Chinese companies operate in Kuwait and have participated in over 80 projects, contributing significantly to infrastructure construction and economic development in Kuwait. "In recent years, the new headquarters of the Central Bank of Kuwait, Sabah Al-Salem University City, Health Assurance Hospital, infrastructure project for South Al-Mutlaa City, Seventh Ring Road project and other projects were built," Zhang said.

Chinese direct investment in Kuwait has reached approximately \$550 million, making it the second largest source of foreign investment in Kuwait. Ambassador Zhang also mentioned that the Kuwait Investment Authority established its second office abroad in Shanghai in 2018, indicating Kuwait's optimism about investment prospects in China, as the office already owns more than 97 million A-shares with a total market value of about \$280 million. Finally, he reiterated China's unwavering support for the establishment of a Palestinian state along the borders of June 4, 1967, with Jerusalem as its capital.

Media plays significant role in promoting food security: KUNA chief

SHARJAH: Director General of Kuwait News Agency (KUNA), Dr. Fatima Al-Salem, stressed Wednesday the importance of the role played by news agencies and media in promoting the concept of food security and to discuss and address all challenges facing it. This came during her participation in a discussion session within the World Media Forum held on the sidelines of Expo Sharjah 2023 within the theme (Media, Food Security, Opportunities, and Challenges).

Dr. Fatima Al-Salem said that food security is a very important case to the world and to the GCC countries, especially in the wake of the CORONA pandemic, noting that these challenges and food security have become a very urgent necessity. The global reports related to food security and its challenges have imposed more tasks on the media, such as preparing distinguished cadres and specialized journalists to deliver the media message in a comprehensive manner to the reader to raise awareness and rationalization.

She pointed to the importance of media theories that manner, and shed light on the humanitarian aspect in media materials dealing with topics and concepts related to food security, development, and other issues in the same context. She noted that the State of Kuwait is at the top of the global rankings for achieving food security by establishing special reserves, campaigns concerned with rationalizing surplus food, and multiple official and civil national strategies concerned with that.

In this regard, she explained the importance of the role of the media message in shedding light on the concept of food security, as she believed that the most effective way to reach the recipient and public opinion lies in simplifying the media message and using advanced technological means. On the other hand, Dr. Fatima Al-Salem confirmed the importance of focusing on journalism specializing in climate change issues and launching initiatives and steps that create a new generation of journalists, as the Media Training and Development Center at KUNA is doing by holding courses in these fields.

On his part, Acting Deputy Director General of the Emirates News Agency (WAM), Ali Al-Saad, said that the media and news agencies have a very significant role to play in food security issues and concepts. "Our priority is to focus on preparing specialized materials and broadcasting awareness messages in a smooth manner that relies on simple language and methods, through different materials and stories that carry a human dimension", he explained. Al-Saad pointed out the importance of establishing effective strategic partnerships, especially in the Arab region, moving towards specialized media, and benefiting from the tremendous development in media, digital communication, and others, to shed light on this issue through awareness and rationalization.

The World Media Forum highlights the most important media topics, practices, opportunities, and challenges related to issues of sustainability and the environment, climate change, food security, concepts of the green economy, and other issues related to the various media fields of journalism, radio, television, digital, and artificial intelligence. — KUNA

Rehabilitation center for Kuwait pensioners

KUWAIT: Social Insurance has announced that it will open a rehabilitation health treatment center for Kuwaiti retirees in the coming months on the directives of HH the Amir Sheikh Nawaf Al-Ahmad Al-Jaber Al-Sabah. The officials said in a statement to the Kuwait News Agency (KUNA) on Wednesday that this initiative comes primarily as a confirmation of the support of HH the Amir, indicating that the center will be the first health center in Kuwait that specializes in the elderly with government support to enable them to assess their conditions comprehensively and provide them with appropriate treatment plans for each individual.

Officials explained that the center will include clinics, gyms, swimming pools, physiotherapy rooms, etc. It will be divided into three separate floors and also include common spaces dedicated to social interaction, such as a restaurant and cafe. She pointed out that the center will be managed by distinguished and specialized teams in various medical fields. The center will provide a special team to follow up on the cases and what happens during the treatment plan, in addition to holding educational and social activities of interest. — KUNA

GCC's Justice Ministry undersecretaries meet

KUWAIT: The Ministry of Justice participated in the 25th meeting of the undersecretaries of the Ministries of Justice of the Gulf Cooperation Council (GCC) held in Muscat. The ministry said in a statement received by the Kuwait News Agency (KUNA) that the Kuwaiti delegation was headed by the undersecretary of the Ministry of Justice, Hashim Al-Qallaf.

The ministry pointed out that the officials discussed many topics, including the draft agreement on the extradition of suspects and convicts within the GCC countries and the development of a draft agreement on the implementation of sentences, proclamations, and judicial declarations. The report of the meetings of the committee of officials for international cooperation and relations was also discussed.

The ministers of justice of the member states recommended that they submit it to the ministers of justice at their next meeting in October. She pointed out that the initiative submitted by Oman on strengthening judicial integration between the GCC countries was approved, and the secretariat was tasked with developing the mechanism and visualization of the initial draft of the document. — KUNA





Warmer seas, political chaos drive Libya flood toll: Experts

'There is no such thing as a natural disaster'

'Everything comes back': Quake leaves mental scars



PARIS: Warmer seas, political chaos and inadequate infrastructure combined with devastating effect in the flooding that has killed more than 2,300 people in Libya, experts said on Tuesday. Riverside buildings in the eastern Mediterranean coastal city of Derna collapsed after Storm Daniel brought heavy rainfall that broke river dams and engulfed entire neighborhoods. Daniel formed around September 4, bringing death and destruction to Bulgaria, Greece and Turkey last week. These Mediterranean storms which bear the features of tropical cyclones and hurricanes, known as "medicanes", only occur one to

three times a year.

They need fluxes of heat and moisture, which are "enhanced by warm sea surface temperatures", noted Suzanne Gray, a professor at the meteorology department at the University of Reading in Britain. The surface waters of the eastern Mediterranean and Atlantic are two to three degrees Celsius warm-

er than usual and are "likely to have caused rainfall to be more intense", said scientists taking part in a UK National Climate Impacts meeting. But it is unclear if the persistent high-pressure blocking pattern that caused the heavy rainfall and flooding will become more common in the future, they said.

The last assessment report by the UN's scientific advisory panel on climate change, released earlier this year, concluded that a warming world increases the strength of medicanes even if they become less frequent, added Gray. Most scientists are cautious about making direct links between individual weather events and long-term changes in the climate.

But Storm Daniel "is illustrative of the type of devastating flooding event we may expect increasingly in the future" as the world heats up, said Lizzie Kendon, a climate science professor at the University of Bristol. The European Union's climate monitoring service Copernicus said rising global

sea surface temperatures were driving record levels of heat across the globe, with 2023 likely to be the warmest in human history. Oceans have absorbed 90 percent of the excess heat produced by human activity since the dawn of the industrial age, according to scientists.

A 'natural' disaster

Some analysts believe the fragmented political scene in Libya — torn apart by more than a decade of civil conflict following the fall of longtime dictator Moamer Kadhafi in 2011 — contributed to the devastation. The North African country is divided between two rival governments: the UN-brokered, internationally recognized administration based in the capital Tripoli in the west, and a separate administration in the eastern region impacted by the flooding. "There is no such thing as a natural disaster," argued Leslie Mabon, a lecturer in environmental systems

at the UK-based Open University. Although climate change can make extreme weather events more frequent and intense, social, political and economic factors determine who is at greatest risk, he said.

The loss of life was also a consequence of the limited nature of Libya's forecasting ability, warning and evacuation systems, said Kevin Collins, senior lecturer at the Open University. Weaknesses in the planning and design standards for infrastructure and cities were also exposed, he added. The UK National Climate Impacts scientists also noted that "infrastructure tipping points", such as extra strain on the dams, make extreme weather events deadlier and more destructive. The political conditions in Libya "pose challenges for developing risk communication and hazard assessment strategies, coordinating rescue operations, and also potentially for maintenance of critical infrastructure such as dams", Mabon added. — AFP

Shipyard hit by Ukrainian missiles in Crimea

MOSCOW: Ukrainian cruise missiles struck a ship-yard in the Crimean port of Sevastopol overnight, Russia's defense ministry said Wednesday. The strike comes as Russia continues to intensify its attacks on Ukraine's southern Odesa and Mykolaiv regions, leaving Romanians living in nearby villages afraid for their lives.

Russia, which annexed Crimea in 2014, said that Ukraine used three maritime drones and ten cruise missiles in the attack, which it claimed damaged two ships undergoing repairs. "The Ukrainian armed forces launched a strike with 10 cruise missiles at the S Ordzhonikidze ship repair plant," Moscow's defense ministry said.

It said that air defense systems shot down seven of the missiles, while the Vasily Bykov patrol ship destroyed all the drones. "As a result of being hit by enemy cruise missiles, two ships undergoing repairs were damaged," it said.

Crimea has been targeted by Ukraine throughout Moscow's offensive but attacks there have recently intensified as Kyiv vows to take the peninsula back. Ukrainian air force commander Mykola Oleshchuk posted an image on social media of what appeared to be a large blaze at a port, and said Russia was "still recovering" from the attack. "I would like to thank the pilots of the Air Force of the Armed Forces of Ukraine for their excellent combat work," he said.

Mikhail Razvozhayev, the Russia-backed governor of Sevastopol, Crimea's biggest city and home to Russia's Black Sea fleet, said on social media that he was at the scene of a fire at the shipyard. "As a result of the attack, according to preliminary information, a total of 24 people were injured, four of them in moderate condition," he said.

'Louder than a plane'

Across the black sea, Romanians fear war spilling over. Villagers say they have not been able to sleep as Russia pounds Ukraine's southern regions. "When the sirens wail at night, that's when you should expect the drones to come," said Costica Tanase, who lives in the remote Romanian village of Plauru.

The border village faces Izmail just across the Danube, and drones can be often heard flying over Romanian territory. Since exiting a deal allowing safe grain shipments via the Black Sea, Moscow has ramped up strikes on Ukraine's southern Odesa and Mykolaiv regions, home to vital grain-exporting infrastructure.

Fresh drone debris was discovered Wednesday, after Romanian soldiers found fragments of a drone "similar to those used by the Russian army" in the Plauru area over the weekend. One of them left a gaping hole in the ground after burning several trees, AFP journalists observed at the scene.

In constant fear of a drone hitting his house, Tanase said that the Romanian soldiers who were recently deployed to the area did little to make him feel safer. "What can they do? They don't have an air-defense system," he said.

"The sound (of drones) is louder than a plane," says 72-year-old resident Ion Giuvanovici, who went looking for debris after he saw one explode nearby. If things get worse, 70-year-old Gheorghe Puflea might pack up and leave, together with his two horses, cows and hens.

"It shakes like an earthquake" when a drone approaches, and his farm animals start stressing. "The calf hid between my legs, scared to death."

Soon the residents will be able to take refuge in two concrete air-raid shelters, hastily built by the military this week.

'Really in danger'

At the weekend, Bucharest condemned the "violation of (its) airspace" and called on Russia to refrain from actions that could threaten the "safety and security" of Romanians. President Klaus Iohannis and NATO chief Jens Stoltenberg also discussed the drone fragment discovery.

Stoltenberg wrote on X (formerly Twitter) that there was "no indication of intent to hit NATO, but the strikes are destabilizing". For several days, Romania had rejected claims by Kyiv that Iranian-made Russian drones fell and detonated on its soil.

Ukrainian Foreign Minister Dmytro Kuleba criticized its NATO neighbor for playing down events to avoid being drawn into a direct conflict. The mayor of Plauru, Tudor Cernega, claimed to have found the first drone fragments — and alerting the authorities — after scouring certain areas identified by Internet users. "Something like this (is not) in the mayor's manual," he told AFP. Real drone fragments were in the end found, said Cernega —fortunately for them, he added, for until then, nobody had believed the residents. "It turned out that we are really in danger," he said. — AFP

Palestinian figures slam Abbas for Holocaust outburst

RAMALLAH: More than 200 Palestinian figures have condemned President Mahmoud Abbas for his "reprehensible" comments claiming Jews were murdered in the Holocaust because of their "social role" and not their religion.

The public figures said they "unequivocally condemn the morally and politically reprehensible comments" by Abbas, in a letter published on Sunday. The signatories include US congresswoman Rashida Tlaib, historian Rashid Khalidi and legal scholar Noura Erakat. "We adamantly reject any attempt to diminish, misrepresent or justify anti-Semitism, Nazi crimes against humanity or historical revisionism visa-vis the Holocaust," they wrote.

The letter follows the surfacing of a video last week in which the Palestinian president said Nazis killed millions of Jews "because of usury and money" rather than anti-Semitism. The remarks made to senior members of his Fatah party in the seat of the Palestinian Authority in Ramallah were swiftly condemned by the European Union and Germany.

One of the signatories, businessman Sam Bahour, said Abbas "doesn't legitimately represent us". "It's not his role to give history lessons," Bahour told AFP on Wednesday, calling the president's remarks "inappropriate". But Fatah leapt to the defense of its leader, describing the letter as a "statement of shame" in comments published by the official Palestinian news agency Wafa on Tuesday.

The PLO's legislative arm, the Palestinian National Council, described the letter as "political and intellectual terrorism against our people", Wafa reported. Abbas, 87, has previously made similar comments downplaying the systematic killing of Jews during World War II. — AFP

'Everything comes back': Quake leaves mental scars

Morocco survivors haunted by flashbacks, grief looking to 'heal their heart'

ASNI: When Khadija Temera, a survivor of Morocco's devastating earthquake, was sent to a psychiatrist on Tuesday, she was just one of a hundred newly traumatized patients who would be seen within 24 hours. The powerful quake last Friday killed more than 2,900 people, most of them in remote villages of the High Atlas Mountains.

Beyond the physical devastation, soldiers and aid workers say it is becoming increasingly clear that many of the survivors are facing severe mental suffering. "The most important thing is that we are alive," Temera says, her henna-stained fingers fiddling with a piece of paper, her eyes swollen with tears. But now she wants to "heal her heart", and on Tuesday she had her first consultation with a psychiatrist, seeking balm for the trauma inflicted by the quake.

She had first gone to see a regular doctor for hypertension. But Moroccan troops in the area quickly referred her to the psychiatrist, who said he had seen around a hundred patients since the previous day out of the 500 who came to the field hospital in Asni, around 90 kilometers (55 miles) south of the tourist hub of Marrakesh.

Flashbacks from the fateful day continue to haunt Temera: of stairs collapsing and trapping her and the nine members of her family before they could be rescued. "I've been awake ever since, I can't fall asleep—as soon as I lie down everything comes back," said the 68-year-old from the village of Lareb.

'Acute stress'

Next to her on a bench, a mute woman was also waiting for a consultation, her hands clasped across her chest and breathing heavily. She has lost both her children. After her comes the turn of a man in his thirties, his eyes red from crying. Of the thousands injured in the powerful earthquake, "some were not only wounded and bruised in their flesh, they were also often 'bereaved', having lost their homes", said Adil Akanour, the only psychiatrist at the makeshift hospital, which was opened to the press on Tuesday.

Meanwhile villagers in more isolated hamlets, which have remained inaccessible, told AFP of their isolation and the absence of aid. Survivors find themselves in a "state of acute stress with symptoms, often physical at first", Akanour said, adding that dizziness, palpitations, headaches and abdominal pain can be symptoms that "hide" a psychological problem. According to the World Health Organization, nearly everyone who experiences such an emergency will suffer some psychological problems which, in most cases, will fade with time.

The separation of families, insecurity, loss of livelihoods and disruption of social contacts are all potential psychological problems, according to the UN organi-



zation, which recommends urgent care to prevent the development of post-traumatic stress disorders. The 6.8-magnitude quake that struck on September 8 was the most powerful ever recorded in the kingdom, with the provisional toll of 2,900 people dead likely to rise.

Entire villages were swallowed up, and with them the lives of hundreds of modest families. Thousands of people were left homeless, the majority now living alone in makeshift tents or, for a few such as Mouhamed

El Makhconi, sheltering in genuine windproof tents provided by the interior ministry. "I was the only one providing for my family," the 60-year-old said with a resigned toothless smile.

He did so by selling jewelry to tourists heading to the summits of the High Atlas Mountain range that dominates the landscape. But now "there's nothing left" of his ground-floor apartment, leaving him and his eight-member family destitute. "I haven't even got a dirham on me," he sighs, sitting outside the tent. He had to be provided with everything from blankets to glasses. Adding to his desperation are the sounds of the earthquake that remain resonant in his memory. He too cannot sleep, saying he can still feel the tremors and the waves of fear that went through his body. But El Makhconi has not consulted a psychiatrist, largely because he needs to sort out his diabetes first. — AFP

Broken city: Historic Marrakesh hit hard by quake

MARRAKESH: Fatima Sanoussi's wrinkled hand tapped the wall in Marrakesh's historic medina on Sunday. Her house was able to withstand the 6.8-magnitude earthquake that rocked Morocco, but many others did not. "Now that's what I call solid," said the 68-year-old in a yellow jellaba and black kerchief on her head, before sweeping away dust and stones from the arch leading to her modest home.

Marrakesh has a rich architectural heritage, and much of it suffered damage in Friday's quake, the strongest ever to hit the North African country. Some parts of the 700-hectare (1,730-acre) medina and its network of alleyways saw significant damage, with mounds of rubble and crumpled buildings.

The 12th-century walls that surround the millennium-old city, founded by the Almoravid dynasty, have also been partly dis-

figured by the tremor. Al-Haouz province, site of the quake's epicenter, suffered the most. It is around 70 kilometers (45 miles) southwest of Marrakesh, Morocco's main tourist attraction. "After a disaster like this, the most important thing is to preserve human life," said Eric Falt, UNESCO's regional director for the Maghreb. "But we also have to plan immediately for the second phase, which includes rebuilding schools and cultural property affected by the earthquake."

Marrakesh is full of such places that have been on the UN cultural agency's World Heritage list since 1985. The vast Jemaa el-Fna square is just one: the huge open area on the edge of the medina is known for its snake charmers and henna hawkers among other attractions. Just hours after the quake struck, Falt led a UNESCO team into the medina on a visit to inspect the damage. "The damage is much more significant than we expected," he said. "There are significant cracks on the emblematic Koutoubia minaret, and the minaret of the Kharbouch mosque is almost completely destroyed," Falt said.

A few meters (yards) from this damaged mosque on Jemaa el-Fna square, vendors waiting for passing trade sat on their stools. Across the street, a 1960s-era cafe remained open to customers, despite now having a large crack in an interior wall. The city's ramparts "have also been damaged in many places", said Falt. "But the most badly affected district is the Mellah (the former Jewish quarter) where there has been widespread destruction of old houses." In 2017, the district underwent significant renovation work estimated to cost more than 17.5 million euros, aimed at developing the district's tourism potential.

Originally built for the Jewish population of Marrakesh, it is now home to a large Muslim population of modest means who carry out small jobs in the medina, and where several families often share one house. One-story houses of stone that shone pink in the sun have been reduced to rubble. Iron bars and other makeshift patchwork can be seen here and there to prop up sagging walls.

and there to prop up sagging walls.

Those visiting Morocco's main tourist attraction now come across entire families living in the street. "Some people, like my parents, found refuge with relatives, but many others are now living in the street," said 56-year-old Saida Mirouch, pointing to the cracks in the walls of the house where she grew up. "We don't have the means to fix them. People came

to inspect them, but they told us nothing. What do we do now? Will the house fall down? We don't know," she said. Housing ministry teams made site visits on Tuesday and architects were expected to come on Wednesday, but no official statements have yet been released. Chakib Benabdellah, head of Morocco's Na-

tional Council of the Order of Architects, told AFP: "we will carry out diagnostics to determine whether evacuation will be necessary" or buildings can be reinforced. "In earthquakes it's not just the houses that fall—those that don't come down sometimes pose a very significant danger," he said. — AFP

before being buried in mass graves. The confirmed death toll reached 2,300 by Tuesday afternoon, but some regional officials were quoted as giving figures more than twice as high.

"The death toll is huge and might reach thousands," Tamer Ramadan of the International Federation of Red Cross and Red Crescent Societies (IRFC) said on Tuesday. He added the organization had independent sources saying that "the number of missing people is hitting 10,000 persons so far". The United Nations' humanitarian agency OCHA on Wednesday reported estimates of "over 2,000 deaths and at least 5,000 people missing".

Oil-rich Libya is still recovering from the war and chaos that followed the NATO-backed uprising which toppled and killed longtime dictator Muammar Gaddafi in 2011. The country has been left divided between two rival governments — the UN-brokered, internationally recognized administration based in Tripoli, and a separate administration in the disaster-hit east.

Derna is ringed by hills and bisected by a riverbed that is usually dry in summer, but which became a raging torrent that also destroyed several bridges. Mudslides and flooding also hit nearby areas where aid group the Norwegian Refugee Council said "entire villages have been overwhelmed by the floods". "Communities across Libya have endured years of conflict, poverty and displacement. The latest disaster will exacerbate the situation for these people."

Erik Tollefsen, head of the weapon contamination unit at the International Committee of the Red Cross, warned of risks posed by landmines planted during the war. "Derna flood waters have shifted unexploded ordnance into areas previously free of weapon contamination. This means more risk for survivors and those providing humanitarian assistance," Tollefsen said on X, formerly Twitter. Several nations offered

urgent aid and rescue teams to help address what one UN official called "a calamity of epic proportions". At the Vatican, Pope Francis invited prayers "for those who lost their lives, their families and the displaced".

Rescue teams from Turkey have arrived in eastern Libya, authorities said, and Algeria, France, Italy, Qatar and Tunisia also pledged to help. The UAE sent two planes carrying 150 tons of aid. The European Union said assistance from Germany, Romania and Finland had been dispatched. Palestinian media reported a rescue mission had left from Ramallah in the occupied West Bank, and Jordan sent a military plane loaded with food parcels, tents, blankets and mattresses.

Climate experts have linked Libya's deadly disaster to a combination of the impacts of a heating planet and of the country's years of political chaos and underinvestment in infrastructure. Hurricane-strength Mediterranean storms such as Daniel — which earlier hit Turkey, Bulgaria and Greece — are known as "medicanes" which can gain strength as warmer air absorbs more moisture.

Climate-linked extreme weather events tend to be the deadliest in strife-torn and poor countries that lack good infrastructure, early warning systems and strong emergency response services. As the world heats up, Libya's disaster "is illustrative of the type of devastating flooding event we may expect increasingly in the future," said University of Bristol climate science professor Lizzie Kendon.

Egypt's President Abdel Fattah Al-Sisi directed authorities Wednesday to set up camps in the country's west to provide shelter for survivors of devastating floods in neighboring Libya, state media reported. Sisi ordered "the establishment of shelter camps" in the western coastal region bordering Libya "for our impacted Libyan brothers who have lost their homes", according to official newspaper Al-Ahram.

The aid is unprecedented in Egypt's recent history, with Cairo having repeatedly refused to set up camps in the face of refugee crises. Most recently, over 280,000 people have fled war in Sudan across Egypt's southern border, but Cairo has said there was no need for camps as the new arrivals are given the right to work and move freely. — AFP

Kim meets Putin, says Russia will...

US officials and experts have said Russia is interested in buying North Korean ammunition to use in Ultraine

Both leaders affirmed historical ties between Moscow and Pyongyang. "We will always be with Russia," Kim said, according to footage broadcast on Russian TV. "An old friend is better than two new ones," Putin said, quoting a Russian proverb and referencing the Soviet Union's role in the Korean War. Their talks as well as discussions with delegations lasted around two hours before the leaders proceeded to the officials dinner in Kim's honor. Kim will later oversee a display of the potential of Russia's Pacific fleet in Vladivostok, Putin announced.

The two leaders met at the Vostochny Cosmodrome in Russia's Far East, with footage released by the Kremlin showing the pair shaking hands enthusiastically as Kim arrived. The two then toured assembly and launch facilities for the Angara and Soyuz-2 space rocket launchers before sitting down for talks with their delegations. While Kim was in Russia, Pyongyang fired two ballistic missiles on Wednesday, the South Korean military said, the latest in a string of sanctions-busting tests.

Experts say Russia will likely use the talks to seek artillery shells and antitank missiles from North Korea, which wants advanced satellite and nuclear-powered submarine technology in return. Kim, who travelled overland to Russia in his bulletproof train, was accompanied by an entourage that suggested the summit would have a strong military focus. Among the top military officials accompanying Kim were Korean People's Army Marshal Pak Jong Chon and Munitions Industry Department Director Jo Chun Ryong, according to the North's state media. Russian Defense Minister Sergei Shoigu took part in the talks with Kim, as did Foreign Minister Sergei

Lavrov, images on Russian state television showed. Ahead of the announcement of the talks, Russian news agencies published images of Kim and Putin touring the vast space center. "The leader of the DPRK shows great interest in rocket technology, and they are trying to develop (their presence in) space," Putin said, referring to North Korea by its official name. Kim thanked Putin for inviting him to visit, despite the Russian leader's "busy schedule". Kim had earlier stressed the trip — his first post-pandemic foreign travel — showed North Korea was "prioritizing the strategic importance" of its Russia ties.

The meeting at the cosmodrome is symbolic, especially as Pyongyang failed twice recently in its bid to put a military spy satellite into orbit, experts said. Russia is eager for North Korea's stockpile of artillery shells, while Pyongyang is looking for help with satellite technology and upgrading its Soviet-era military equipment, An Chan-il, a defector-turned-researcher who runs the World Institute for North Korea Studies, told AFP. "If North Korea's multiple rocket launchers and other artillery shells are provided to Russia in large quantities, it could have a significant impact on the war in Ukraine," he said.

Russia's natural resources minister Alexander Kozlov greeted Kim when he arrived in the country, giving him historic autographed photographs of Soviet cosmonauts, including Yuri Gagarin, Kozlov's ministry told TASS. The White House warned last week that North Korea would "pay a price" if it supplies Russia with weaponry for the conflict in Ukraine.

Kim is also risking the displeasure of his other major ally Beijing by meeting Putin, Vladimir Tikhonov, professor of Korean studies at the University of Oslo, told AFP. "China will be hardly too happy about Russia entering into what Chinese consider their monopoly territory," he said, adding Beijing would be worried about the regional destabilization impact of any transfer of Russian military technology to Pyongyang. Kim and Putin "may conduct an exchange of North Korea's old-age, Soviet-type ammo for Russia's newer military tech or hard currency (or wheat)". But he warned that "Russia's important ties to Seoul will be dealt irreparable damage". — AFP

Trump's allegations at heart of Biden impeachment push

Biden allowed family to 'sell his brand' for financial benefit: Committee

WASHINGTON: Donald Trump was impeached by Congress in late 2019 for extorting Ukraine in an unsuccessful effort to get up dirt on his reelection rival Joe Biden. Four years later, Republicans are moving to impeach now-President Biden, claiming they have the dirt Trump sought: that while vice president, Biden personally benefitted from his son Hunter's business dealings.

Republican House Speaker Kevin McCarthy on Tuesday announced he was ordering an impeachment inquiry into the Democratic leader — a move demanded for months by Trump and his right-wing backers in Congress. But in contrast to the well-documented actions by Trump that supported his impeachment, Democrats — and even some Republicans — say House Oversight Committee Chairman James Comer, one of the Republicans leading the probe, has no evidence yet of wrongdoing by Biden.

Hunter's lucrative jobs

Comer alleges that the "Biden family" — without explicitly naming the president — and their "associates" have received over \$20 million in payments from foreign entities. While Hunter Biden had business ties in China, Kazakhstan, Romania and elsewhere, McCarthy's impeachment probe announcement focused on his dealings with Ukrainian energy

Hunter was given a lucrative position on Burisma's board in early 2014, when his father was vice president under Barack Obama and had oversight of US policy toward the country. Burisma's owner was Mykola Zlochevsky, a powerful oligarch awash in allegations of corruption, both inside and outside Ukraine. While Hunter Biden was a Yale law graduate and had some experience in business and finance, it

Cubans fret about sons recruited to fight for Russia

SANTA CLARA: For Cuban Pedro Roberto Gamuza, 59, the war in Ukraine has hit very close to home: one of his sons has gone to fight there and another was detained on his way, charged with being a mercenary. Gamuza's sons, aged 33 and 34, are believed to be among a group of Cubans recruited by an alleged criminal network to fight for the Russian army

Last week, Havana said it had arrested 17 people over alleged links to a "trafficking network that operates from Russia to incorporate Cuban citizens living there, and even some from Cuba, into the military forces involved in military operations in Ukraine." Among the 17 were an alleged organizer, two recruiters, and 14 volunteers — including one of Gamuza's four sons, 34-year-old Liogi Gamuza Perez.

Announcing the arrests, the Attorney General's office said anyone found guilty of human trafficking, offering mercenary services or "hostile acts in a foreign state" could face a life sentence or even the death penalty. Gamuza told AFP that Liogi phoned him on Tuesday of last week to say he had been summoned by Cuban state security.

Days later, authorities informed him his son had been detained for mercenary activities, Gamuza said in his hometown of Santa Clara, some 280 kilometers (174 miles) from the capital. He has not heard from him since. Gamuza also has no idea as to the whereabouts of his other son, 33-year-old Robeisi Alexander, who has a three-year-old daughter.

Six weeks ago, Alexander's wife told Gamuza her husband had left for Russia. Local media identified him as a recruit for Russia's war. There has also been no recent news from him. "I feel giddy, my head doesn't work," a worried Gamuza, decked out in the blue uniform and white rubber boots of a factory worker, told AFP on Monday.

'Deception'

Gamuza said he was unaware of his boys being recruited to fight for Russia. Liogi, he said, was never called up nor did he undergo military training due to ill health. His son must have fallen victim to "deception," said Gamuza, who said Liogi had denied ever signing any contract with any recruitment group.

Earlier this month, Miami's America TeVe station circulated what it said were testimonies from two teenagers — Andorf Velazquez and Alex Vega who claimed to have been tricked into working with the Russian army on construction sites in Ukraine. Another Cuban man told the media outlet he had signed up with Moscow's armed forces hoping to legalize his status in Russia. Andorf's father, Mario Velazquez, told AFP he has had no word from his son for a week. The last time he spoke to him, the 19-year-old said he was in Russia and headed for Ukraine, Velazquez said by telephone from Leon in Mexico, where he lives. He also claimed to have had no response from the Cuban embassy in Mexico, which he had approached for help. — AFP

The Ukraine-Trump link

In 2014, Ukrainians revolted and ejected Moscow-backed president Viktor Yanukovych. The year was also the beginning of a deep economic crisis in Ukraine, and on the verge of a massive debt default, Ukraine sought global help. But the IMF held up new financing and Washington stalled a \$1 billion loan guarantee until newly-elected President Petro Poroshenko took action on corruption.

In meetings with Poroshenko in December 2015 and January 2016, Biden said fiscal support would not advance until he fired prosecutor general, Viktor Shokin, who allegedly continued to protect corrupt Ukrainian oligarchs, including Zlochevsky. "I looked at them and said, 'I'm leaving in six hours. If the prosecutor is not fired, you're not getting the money," Biden recounted in 2018. "He got fired," he said. With Shokin gone, Zlochevsky's properties were raided by

In January 2017, Biden left office and Trump became president. Within 18 months, it became clear that Joe Biden would challenge him for the White House in the 2020 vote. His reelection under threat, Trump dispatched his personal lawyer, Rudy Giuliani, to Kyiv to dig up dirt on the Bidens in early 2019. When Giuliani's efforts were stymied, Trump in July stepped up the pressure on Poroshenko's successor, Voldymyr Zelensky, by summarily freezing \$400 million in military aid. In a phone call days later, on July 25, Trump alluded to US support and strongly urged Zelensky to investigate the Bidens and announce the results. That call became the basis for the first impeachment of Trump, on the grounds that he illegally

Biden 'brand'

With Republicans winning control of the House of Representatives in the 2022 midterm elections, Trump's allies gained the legal tools to take their revenge. After eight months of investigation, Comer's Oversight Committee is turning the story of Shokin's firing on its head. How safe is it?

"It is equipped with attack weapons and a helicopter for escape in case of emergency," the ministry says, adding that due to the weight of all the extra equipment the vehicle moves at only around 60 kilometers (37 miles) per hour. Despite its slowness, the train has key advantages over an aircraft, it said, chiefly offering more flexibility in unforeseen circumstances, including attacks. Were an aircraft with Kim on it to be attacked, "survival chances are significantly reduced", it said. The ministry said it was also more challenging to predict train itineraries To bolster on-board security measures, Pyongyang has in the past asked for guards to be deployed along the tracks, as it did for Kim's 2019 Hanoi visit.

Does Kim ever fly?

Kim has made seven previous overseas trips four to China and one each to Russia, Vietnam and Singapore. The latter two were for summits with Trump. He has also crossed the border into South Korea twice. Unlike his father, he is not scared to fly: he flew on three trips — two to China, and one to Singapore — and has even been shown at the controls of an aircraft in 2014 state media footage. His private plane, which flew him to China in 2018, is known as "Chammae-1" after the national bird of North Korea and is a Cold War-era Russian-made Ilyushin-62. Analysts question the aircraft's reliability due to its age and possible maintenance issues. – AFP

With records obtained from the FBI and Justice Department and witness testimony, Comer has been able to detail large sums of money going to Hunter Biden and his associates, but nothing showing the elder Biden personally benefited. The committee instead says the probe is investigating "influence peddling" by what Trump repeatedly calls "the Biden crime family.'

The investigation "reveals Joe Biden allowed his family to sell him as 'the brand' around the world to enrich the Bidens," the committee said Tuesday. The committee will "work to follow the facts to ensure President Biden is held accountable for abusing public office for his family's financial gain," it said. – AFP

Iranians hit by Internet curbs since protests

TEHRAN: Iran has imposed curbs on the Internet in the year since protests erupted over Mahsa Amini's death, forcing people to find other ways to run their businesses or keep in touch with loved ones. Amini, a 22-year-old Iranian Kurd, died on September 16, 2022 after her arrest in Tehran for an alleged breach

of the Islamic republic's strict dress code for women. Her death triggered months of nationwide protests in which hundreds of people were killed, including dozens of security personnel, before authorities moved to quell what they branded "riots", including restrictions on the use of social media.

Alma Samimi, who makes a living by selling leather bags online, said her business had suffered since the blackout came into force. "The damage has been irreversible," she said, with profits linked to her Instagram account — which had amassed thousands of followers - nosediving 80 percent. "Online interactions have dramatically dropped since last year," she said. The restrictions, which affected online activity including on Instagram and WhatsApp, come as millions of Iranians struggle to make ends meet, grappling with an economic crisis marked by soaring inflation and the Iranian rial's sharp decline. Iran's economic woes were significantly compounded by Washington's 2018 decision to reimpose sanctions on Tehran after then-president Donald Trump unilaterally withdrew the United States from a landmark nuclear deal. "We cannot plan for the future anymore," Samimi lamented.

'Added cost'

Some 1,200 business owners have since called on Iran's President Ebrahim Raisi to lift the restrictions, according to local media. To keep her business afloat, Samimi resorted to using virtual private networks and anti-filter tools to bypass the censorship. Daily demand on VPN services in Iran rocketed to "3,082 percent higher than before the protests" last year, according to Top10VPN, a British-based digital security advocacy group.

Mohammad Rahim Pouya, a psychologist who offers online therapy sessions, said he lost more than 50 percent of his clients in the early days of the blackout. The 32-year-old said he could maintain communication lines with clients in Iran but it was more challenging with those abroad. For him, the use of anti-censorship tools was "an added cost and probably has security flaws". "But what are the options?" Finding ways around Internet curbs has become commonplace in Iran where authorities have repeatedly blocked access over the years at times of unrest. — AFP

Over 10 days in August, more than 50,000 people fled the city, according to the UN. In early September, those who remained looked up to see a new escalation: air force fighter jets — whose strikes have been largely limited to the capital Khartoum — fly-

Their bombs struck both RSF bases and the residential neighborhoods they inhabit, witnesses told AFP. The army maintains control of the skies, and has been accused of repeated indiscriminate shelling of residential areas where paramilitaries have embedded themselves, including by evicting families and taking over homes. Positioning themselves in civilian occupied neighborhoods and buildings is "a potential violation of the Geneva Conventions," the US-supported Sudan Conflict Observatory has said. It added that the Sudanese Armed Forces "would still be required to ensure that civilian harm is minimized regardless of whether a target has been made a legitimate military target." — AFP

At least 40 killed in Darfur as UN's Sudan chief quits

WAD MADANI: An air raid on Sudan's war-ravaged Darfur region killed at least 40 civilians Wednesday, according to a medical source, as the head of the UN mission to the country resigned. Volker Perthes, who has been "persona non grata" by Sudanese authorities since June, warned the United Nations Security Council again, in his final briefing before leaving the post, that Sudan's war risks further deterioration.

"Forty civilians have been killed in an air strike that hit two markets and a number of the city's neighborhoods," the medical source told AFP from a hospi-

tal in Nyala, the capital of South Darfur. The source asked for anonymity out of security concerns. Since battles began on April 15 between the regular army, led by General Abdel Fattah al-Burhan, and the paramilitary Rapid Support Forces (RSF) commanded by Burhan's former deputy Mohamed Hamdan Daglo, nearly 7,500 people have been killed, according to a conservative estimate from the Armed Conflict Location & Event Data Project. More than five million people have been uprooted, including one million who fled across borders, according to UN figures.

Intensified fighting

Witnesses in Nyala had reported earlier on Wednesday air strikes falling on two markets and causing civilian casualties in Sudan's second-biggest city. The western region of Darfur — the size of France and home to a quarter of Sudan's population had already seen some of the war's worst unrest before violence intensified last month.

US consumer inflation ticks up

WASHINGTON: Consumer inflation in the United States rose for a second straight month in August, the government reported Wednesday, putting the heat on policymakers as they work to lower prices.

The consumer price index (CPI), a key inflation gauge, jumped 3.7 percent from a year ago, picking up pace from July's 3.2 percent figure, said the Labor Department. But a measurement stripping out volatile segments cooled to its slowest rate since September 2021.

All eyes are on the report, which is expected to have a bearing on the US central bank's interest rate decision due next week. The Federal Reserve has lifted the benchmark lending rate rapidly since March last year to tamp down demand and sustainably lower inflation — but the current figure remains stubbornly above officials' two percent goal. In August, higher gasoline costs bumped up headline inflation but the so-called core reading — removing the volatile food and energy components — cooled to 4.3 percent on an annual basis.

This is its lowest level in nearly two years. "Today's report provides more evidence that core inflation is trending down toward pre-pandemic levels at a time when employment remains strong," said President Joe Biden in a statement. Acknowledging that an increase in gas prices has strained family budgets, Biden added that he remains "laser-focused on cutting energy costs.'

Disinflation ahead

tor to the monthly all items increase, accounting for over half of the increase," said the Labor Department on Wednesday. The department added that the shelter index, which takes into account rent, continued advancing — rising for a 40th consecutive month.

Between July and August, CPI rose 0.6 percent, accelerating from the prior month too while the core figure picked up more than anticipated in the same period. But the general uptick is expected to reverse in the coming months.

"We expect that a slowing economy, looser labor market conditions and moderating wage growth will support a further deceleration in inflation," said economist Nancy Vanden Houten of Oxford Economics. She added that Fed officials will likely look past the latest rise in headline CPI. "Easing demand for goods and services, the pass-through from softer home and rent price inflation, and cooling wage growth should lead to further disinflation," added EY chief economist Gregory Daco. — AFP

deputy governor Margarita Delgado, who had also made the shortlist. According to industry insiders, Buch's nomination could boost Spain's chances of nabbing a different top EU role. Spain's deputy prime minister and economy minister Nadia Calvino is currently in a tight race to become the new president of the European Investment Bank (ÉIB).

If Buch's nomination is approved, she will take the helm of the SSM as lenders are adjusting to a high-interest-rate environment after years of ultra-low rates that squeezed banks' profitability. At the same time, inflation remains stubbornly high despite an unprecedented series of rate hikes from the ECB, adding to a gloomy outlook for the eurozone economy. In an interview with the Financial Times in July, Buch said the resilience of eurozone banks following the upheaval from the pandemic and Russia's invasion of Ukraine reflected the sector's efforts to boost capital and liquidity as well as "the success of supervision". — AFP

High costs push home ownership out of reach of younger Americans

WASHINGTON: When Jennie Luhmann started searching for her family's "forever home," she found herself in a perfect storm — few properties were available, buyers were making all-cash offers and interest rates were climbing. Outbid by others and pressured by soaring mortgage rates, Luhmann and her husband decided to rent, before temporarily moving into her mother's house.

The 37-year-old is not alone. Homeownership feels increasingly out of reach for younger generations of Americans, who are squeezed by student debt and childcare costs in an era of slower economic growth. The pressures come as President Joe Biden struggles to tackle negative sentiment about his handling of the economy, as he campaigns for re-election. The Biden administration has sought to narrow America's housing shortfall, in part by lowering barriers to building, but it is not a quick solution.

Millennials, born between the early 1980s to late 1990s, formed the biggest share of homebuyers between 2014 and 2022 according to the National Association of Realtors (NAR). But they lost the position this year to baby boomers, who can fork out

cash for their home purchase.

"Inventory is incredibly limited especially at the affordable price points," said NAR deputy chief economist Jessica Lautz. "We're seeing millennials encounter a very difficult housing market, especially with rising interest rates," she added. Young adults in America also "have a rising amount of student loan debt," Lautz said, and the restarting of payments in October after a pandemic-era pause adds to financial stress. Among first-time buyers, 27 percent moved directly from a family member's home into homeownership last year — the highest share recorded since the 1980s — the NAR said. First-time homebuyers are also older, at a median age of 36. — AFP

Oil prices fuel US inflation but stocks resist

LONDON: US stocks edged higher Wednesday despite data showing rising oil prices pushed US inflation to its largest monthly gain in over a year in August as investors see the Federal Reserve likely to hold interest rates steady. The consumer price index (CPI), a key inflation gauge, jumped 3.7 percent from a year ago in August, in line with expectations, picking up pace from July's 3.2 percent figure.

The 0.6 percent monthly increase was also an acceleration from the 0.2 percent registered in July. But the "core" measure that excludes volatile food and energy prices cooled last month. US pre-market stock futures fell after the data was initially released, but bounced back with the Dow edging higher at the opening bell. All three major indices pushed into the green as trading continued. Ben Laidler, global markets strategist at financial services firm eToro, said the drop in core inflation may outweigh the rise in headline inflation. "However the numbers will still be too high for the Federal Reserve," which holds its next meeting on interest rates next week, he said in a note to investors. "This will force it to keep interest rates at a 20-year high until it sees more progress in the last and hardest yards to get inflation firmly on track towards its 2 percent target," Laidler added.

Briefing.com analyst Patrick O'Hare said the data "probably won't compel the Fed to raise rates further at this point" but it "will certainly keep the Fed in a 'higher for longer' mindset." He noted that investors' expectations of a 0.25 percentage point Fed rate hike


later this year dipped only marginally to 43.3 percent. The US central bank has insisted that its decision-making on monetary policy will be data-driven as it assesses a range of figures, which have for much of 2023 suggested that more than a year of tightening is having the desired effect. That had fanned optimism that July's hike was the last and officials would allow its measures to work through the economy and bring inflation to heel.

But a recent run of strong data, particularly on the jobs market and the services sector, has revived talk that more were on the way, with a surge in oil prices to 10-month highs adding to those concerns.

The pick-up has been fuelled by Saudi Arabia and Russia's decision to slash output until the end of the year, while floods in Libya have hammered its ability to pump. Oil prices rose further on Wednesday as the International Energy Agency warned that Moscow and Riyadh's decision would cause a "significant supply shortfall". In afternoon trading, both Paris and Frankfurt stocks were lower, ahead of an interest-rate decision Thursday from the European Central Bank.

On the corporate front, shares in British oil giant BP fell nearly 1.4 percent after chief executive Bernard Looney unexpectedly resigned, having admitted to not being "fully transparent" about historical relationships with colleagues. Looney, 53, has left after less than four years in the role, having seen the firm through a tumultuous period that included huge swings in prices owing to the COVID pandemic and Russia's invasion of Ukraine. — AFP

Kuwait's financial wealth to reach \$302 billion by 2027: BCG report

'Global Wealth Report 2023' puts annual growth rate of Kuwait's wealth at $2.7\,\%$

KUWAIT: Kuwait's financial wealth is anticipated to experience a steady compound annual growth rate (CAGR) of 2.7 percent in new wealth, rising to \$302 billion by 2027, according to a new report by Boston Consulting Group (BCG)

LONDON: The imminent demise of household goods seller Wilko highlights the challenges UK retailers currently face amid decades-high inflation and anaemic economic growth, but experts argue it also stems from bad management. With nearly 12,500 job losses looming, Wilko's downfall is the biggest bankruptcy in the sector since Woolworths shuttered in 2008, according to the Centre for Re-

The chain's red-and-white logo has been a familiar sight for decades on shopping streets across the country, but will soon disappear following Monday's liquidation announcement.

Wilko was synonymous with bargains in household and garden items, from small electrical appliances and cleaning products to suitcases and gardening tools. The chain, which filed for bankruptcy in August, prided itself on being a family business—founded 93 years ago by JK and Mary

But it ultimately found itself ensnared by Britain's worst cost-of-living crisis in a generation, as increasingly cash-strapped customers curbed their spending in the face of rising bills and went elsewhere. Credit Suisse takeover, 'deal of the century'?

ZURICH: Did banking giant UBS make "the deal of the century" when it bought one of the world's biggest banks for a pittance as it teetered on the edge of the abyss? Switzerland's largest bank was in March strongarmed by Swiss authorities into a \$3.25-billion takeover of Credit Suisse, to keep its closest domestic rival from

At the time, investors gasped at the risks UBS was taking on with the purchase. But by August, the bank said it would not need the billions in support offered by the Swiss government and central bank to offset any surprises that might pop up in its stricken rival's accounts. That must mean that Credit Suisse's situation was "much better than described in March", Thomas Aeschi, a member of parliament with the populist rightwing Swiss People's Party (SVP), wrote on X, formerly Twitter. UBS seemed to prove him right when it unveiled its second quarter results on August 31.

The bank posted a towering net profit of \$29.2 billion for the three-month period, thanks to an exceptional gain due to the gulf between the amount paid for Credit Suisse and its book value.

'Godsend'

"UBS has pulled off the deal of the century," Switzerland's Socialist Party said, maintaining the "rescue" was more of a "godsend", allowing it to snatch up a bank at a dramatically reduced rate. "If we had chosen another path, (like) a temporary or partial nationalization," said Samuel Bendahan, a Socialist MP and economics professor at the University of Lausanne, the Swiss state "would have taken on the risk, but those \$29 billion would have gone to the population". —AFP

EU to probe China electric car subsidies

STRASBOURG: Brussels will investigate Chinese state subsidies for electric cars, EU chief Ursula von der Leyen said Wednesday, vowing to defend Europe's industry against "artificially low prices".

'Global markets are now flooded with cheaper Chinese electric cars. And their price is kept artificially low by huge state subsidies," von der Leyen said, during a speech at the European Parliament in Strasbourg. This could lead the European Union to impose duties on those cars that it believes are unfairly sold at a lower price, thereby undercutting European competitors.

"Europe is open for competition but not for a race to the bottom," the European Commission president said. France reportedly pushed von der Leyen to launch the investigation, but there are growing concerns across Europe about how much the continent relies on Chinese products. European car makers hailed the investigation as a "positive signal".

"The European Commission is recognizing the increasingly asymmetric situation our industry is faced with, and is giving urgent consideration to distorted competition in our sector," said Sigrid de Vries, director general of the European Automobile Manufacturers Association. The EU's internal market chief Thierry Breton last week warned about a trend emerging where Europe was "being relegated to net imports of electric vehicles or solar panels".

China could overtake Japan to become the world's largest car manufacturer this year, according to some experts. France is particularly concerned that Europe will fall behind if it is not more assertive when confronted with China's actions that are more protectionist.

Paris has announced measures that would provide subsidies for new electric cars based on the manufacturers' emissions output. This would be more difficult for Chinese cars since their production often relies on coal-powered electricity. Von der Leyen has called

on the EU to define its own approach to Beijing, although some of Europe's larger powers want to be cautious to avoid severing business ties. Despite her strong comments, von der Leyen said it was "vital" for Europe to maintain "communication and dialogue with China".

"Because there are also topics, where we can and have to cooperate.

De-risk, not decouple—this will be my approach with the Chinese leadership at the EU-China Summit later this year," she added. The EU's trade commissioner Valdis Dombrovskis will head to China next week, he said in a social media post, "to engage on trade and economic opportunities/ challenges". — AFP

It recommended that Italy carry out "a thorough analysis" of the windfall tax's "potential negative consequences for the banking sector". — AFP

BP shares drop after CEO quits over relationships

LONDON: Shares in British energy major BP dropped Wednesday after chief executive Bernard Looney resigned unexpectedly over his failure to disclose past relationships with colleagues. BP's stock fell nearly one percent to 518.20 pence at midday on London's falling FTSE 100 index, despite rising oil prices that normally boost energy firms. The company announced late Tuesday that Looney, 53, resigned "with immediate effect" after admitting he had not been "fully transparent" about historical relationships with colleagues.

The Irishman is leaving after less than four years in the role, having steered the energy major through a tumultuous period that included huge swings in prices owing to the COVID pandemic and Russia's invasion of Ukraine. "The higher oil price might limit some of the fallout from the shock resignation... but this is a highly unwelcome turn of events for

investors given his long tenure at the company and his pivotal role at the helm as it navigates the tricky transition to greener energy," said Susannah Streeter, head of money and markets at Hargreaves Lansdown.

"Change at the top is always unsettling and the abrupt nature of his departure will intensify reactions, particularly as it comes at such a sensitive time in the company's strategy," she said. Looney took the top job in February 2020, shortly before the 10th anniversary of the explosion on the BP-leased Deepwater Horizon rig in the Gulf of Mexico that triggered the worst oil spill in US history. The disaster killed 11 employees and cost the British firm tens of billions of dollars in damages and compensation. Looney's arrival came also shortly before oil prices briefly turned negative as COVID lockdowns slashed energy demand and slammed the sector. Finance chief Murray Auchincloss will now act as interim CEO while the group seeks a permanent successor.

"Compared to the multi-billion-dollar fines following the Deepwater Horizon spill, briefly negative oil futures prices and dividend cuts during the pandemic, the resignation is a surprise but perhaps not a major chapter in BP history," said Interactive Investor analyst Richard Hunter.

"With a temporary replacement now confirmed, BP will be hoping for markets to regard the situation as business as usual," he said. "There will, however, inevitably be uncertainty until such time as a permanent replacement is found and the company clarifies whether there will be any changes to its current strategy." Looney had also come under fierce criticism from environmentalists, who have accused BP and rivals of not going far enough in transitioning away from fossil fuels. He is not the first head of a major global company to resign or be ousted over relationships with employees. Steve Easterbook was ousted as CEO of McDonald's in 2019 for having a "consensual relationship" with an employee, in violation of company policy. — AFP

ECB worried over Italy's windfall tax on banks

FRANKFURT: The European Central Bank on Wednesday sharply criticized Italy's surprise windfall tax on banks, warning it could weaken lenders' capital buffers and make them more vulnerable to future economic shocks. Italy's hard-right government announced last month it would levy a one-time 40-percent tax on banks' "surplus profits" netted as a result of the ECB's series of interest rate hikes over the past year. The shock move spooked investors and sent shares in Italian banks plunging before the government watered down the plan, saying the new tax would be capped at 0.1 percent of a bank's assets.

"Imposing an extraordinary tax on the banking sector could make it more difficult for credit institutions to build up additional capital buffers, as their retained earnings will be reduced, making them less resilient to economic shocks," the ECB said in a legal opinion. aylor Swift cleaned up at Tuesday's MTV Video Music Awards and won the evening's top trophy, as Shakira accepted the night's prestigious Video Vanguard honor with a hip-shaking, career-spanning performance. Swift continued her global reign by scooping awards including Best Song, Best Pop and Best Direction, as well as the top competitive award for Video of the Year, which she won for her hit "Anti-Hero."

Turn-of-the-millennium heartthrobs NSYNC reunited onstage for the first time in a decade to present her with the Best Pop award, leaving Swift, who is poised to post the first billion-dollar tour, fanning her cheeks. "This is unbelievable," Swift

said as she accepted the night's top prize, which she also took home in 2022. "I just want to say that the fact that this is a fan-voted award means so much to me." But she didn't per-form on the night known far more for its spectacle than its awards, instead sipping her drink as artists including Olivia Rodrigo, Anitta and Doja Cat took the stage.

The made-for-broadcast show, held this year in Newark's Prudential Center, frequently panned to Swift who was seated near the main stage next to Ice Spice, the viral Bronx rapper who has collaborated with the pop phenom and who won the evening's prize for Best New Artist. A camera operator was reportedly tasked with filming Swift for the show's entire duration.

The nearly four-hour show that included some 20 performances ended without handing out awards in a number of categories, however, including for Artist of the Year, which for the first time was an all-women slate including Swift, Shakira and Beyonce. Lil Wayne opened the show in a nod to this year's 50th anniversary of hip hop, and Sean Combs-known by his stage names Puff Daddy, Puffy, P. Diddy and Diddy-delivered a career-spanning performance as he accepted the night's Global Icon lifetime achievement award.

"This is so surreal," said the 53-year-old from Harlem. "I started out as a paper boy." And it was Shakira who scored the night's most prestigious honor for lifetime achievement, the Video Vanguard award that celebrates music video innovations. The Colombian performer, 46, stole the show as she performed her signature hip swings and pops, singing a bilingual medley including "She Wolf," "Te Felicito," "Objection (Tango)," "Whenever, Wherever" and "Hips Don't Lie."



Wellalage effort in vain as India beat Sri Lanka to reach Asia Cup final

Rohit enters an elite list of players with over 10,000 ODI runs

COLOMBO: Kuldeep Yadav starred as India overcame a brilliant all-round effort from Sri Lanka's Dunith Wellalage to win a tense Asia Cup clash by 41 runs on Tuesday and book a place in the final. Kuldeep took four wickets including the final two as India defended 213, bowling out Sri Lanka for 172 to silence a large home crowd at Colombo's R. Prema-

India recorded their second straight Super Four win in the 50-over tournament, a prelude to the upcoming ODI World Cup, and ended Sri Lanka's 13-match winning streak in ODIs. Wellalage, who claimed his maiden ODI five-wicket haul, remained unbeaten on 42 when he ran out of partners as leftarm wrist spinner Kuldeep wrapped up the opposition tail in 41.3 overs.

"Kuldeep is a great bowler, I tried to play my normal game with a positive mindset," said Wellalage, who was named man of the match despite being on the losing team. "I want to thank my team-mates and my coaching staff — they gave me great support."

India skipper Rohit Sharma praised Kuldeep, who also took five wickets in his team's previous win over Pakistan, for his rhythm and consistency. "For the past year or so, bowling really, really well. He has done a lot of hard work on his rhythm," said Rohit.

"He went back to the drawing board and worked on it. The ball is coming out nicely and you can see the results in the last 10 ODIs." It was India's third straight day on the field after they crushed Pakistan by 228 runs on Monday in a match that was played across two days due to rain. The next Super Four match between Sri Lanka and Pakistan on Thursday will decide the second finalists between the two teams.

Rohit to 10,000 runs

Rohit, who entered an elite list of players with over 10,000 ODI runs and hit his second successive fifty, scored 53 to hand his team a brisk start but Wellalage hit back. The 20-year-old returned figures of 5-40 including the key wickets of Rohit and Virat Kohli with strong support from parttime spinner Charith Asalanka, who claimed four victims for 18 runs.

Wellalage struck with his first ball of the match when he bowled Shubman Gill for 19 and there was no looking back for the young spinner. He made the home fans erupt with the wicket of Kohli who fell for three a day after an unbeaten 122 against Pakistan at the same venue.

Rohit was also bowled by Wellalage who snared his third scalp in three overs. Ishan Kishan, who made 33, and previous-match centurion KL Rahul attempted to rebuild the innings with a stand of 63.

Wellalage ended that partnership when he got Rahul caught and bowled for 39 and then took his fifth. Asalanka kept chipping away from the other end and was on a hat-trick with India on 186-9, but Axar Patel took the total past 200 after a nearly 45-minute rain break and hit 26.

India hit back with regular wickets and Jasprit Bumrah struck twice. Asalanka attempted to increase the run-rate but became Kuldeep's second wicket. Dhananjaya de Silva fought back along with Wellalage in a threatening seventh-wicket stand of 63 but Ravindra Jadeja broke the partnership with the wicket of De Silva for 41. — AFP

LONDON: Manchester United have announced a bumper sponsorship deal with USbased Qualcomm Technologies, whose Snapdragon brand will replace the TeamViewer logo on their shirts from next season. The Premier League club, who did not reveal the financial details of the deal, were reportedly targeting an agreement worth £60 million (\$75 million) per year. It is understood the figure equals or even surpasses the previous biggest shirt deal in football history. Qualcomm has been one of United's global partners since last year. "Manchester United plc has agreed to an expanded strategic collaboration with Qualcomm Technologies, Inc, that will see the Snapdragon brand displayed on the front of the club's famous shirt," the club said in a statement confirming the agreement. It added: "Under the expanded agreement, Snapdragon will become Manchester United's front of shirt partner from the start of the 2024/25 season, featuring on the home, away and third kits of the men's and women's teams." United have not won the Premier League since former manager Alex Ferguson retired in 2013. — AFP

Mushfiqur to miss India match

DHAKA: Bangladeshi batsman Mushfiqur Rahim will skip Friday's Asia Cup Super Four match against India to spend time with his wife and newborn daughter, the cricket board said Wednesday. Bangladesh is already out of the race for the September 17 final after India defeated Sri Lanka by 41 runs in Colombo on Tuesday, in the tournament that is a prelude to the upcoming ODI World Cup in India. Mushfiqur had returned to Bangladesh for the birth of his second child, born on Monday. He was initially expected to rejoin the team for the India match in the Sri Lankan capital Colombo. He will now remain in Dhaka, the Bangladesh Cricket Board said. "Mushfigur has informed us that his wife is still recovering, and he needs to be by her side and with their children," BCB operations chief Mohammed Jalal Yunus. "We fully understand his situation, and have decided to permit him to skip the game." Skipper Shakib Al Hasan, who also returned home with Mushfiqur after their defeat against Sri Lanka on September 9, rejoined the team in Colombo on Wednesday. — AFP

Embarrassing defeat

BEIJING: Angry China fans turned on their team and applauded the visiting Syrians off the pitch after what Chinese state media called "another embarrassing defeat". China's Serbian coach Aleksandar Jankovic blamed bad luck for the 1-0 friendly loss in Chengdu on Tuesday, which came days after they were held 1-1 by Malaysia also at home. President Xi Jinping wants China to one day host and even win the World Cup, but they are ranked 80th in the world and confidence is rock-bottom ahead of World Cup qualifying. Thaer Krouma scored the second-half winner for Syria, who are 94th in the FIFA rankings, in front of just over 12,000 spectators at a 60,000-capacity stadium. The Paper, reporting from the southwestern city, said irate home fans booed afterwards and demanded refunds. Video footage also showed the Chinese players being roundly booed and spectators chanting: "What a disgrace!" — AFP

The tourists looked on track for another win when Warner and Head thrashed 79 for the first wicket off only 48 balls. Australia were 104 for one at the end of the 10-over power play, the second time in a row they reached three figures while fielding restrictions were in place.

Max Verstappen win streak under threat in 'perilous' Singapore race

SINGAPORE: Max Verstappen's bid for a record-extending 11th straight win faces a severe test in Sunday's "perilous" Singapore night race on the unpredictable Marina Bay street circuit. The Red Bull driver's third world title in a row is only a matter of time but the Dutchman has never triumphed under the lights in Singapore, where tropical storms, intense humidity and concrete barriers all await.

Safety cars and red flags will almost certainly play a part too, with memories of an "incredibly messy" race in Singapore a year ago fresh in Verstappen's mind. Rain is again forecast for race weekend. Verstappen was only eighth on the grid in 2022 after being under-fuelled in Saturday qualifying and a pre-race deluge saw him start poorly on the sodden track, dropping back five places.

He clawed his way through the field with the help of several safety car and virtual safety car periods, only to slither on to an escape road while trying to take fourth place, eventually rejoining and settling for seventh.

Red Bull teammate Sergio Perez kept his cool out in front to win ahead of Charles Leclerc in a Ferrari and keep the champagne on ice for a bit longer. "It's better than eighth but it's not what I'm here for, not with a car like that," lamented Verstappen after the race. "It was just incredibly messy.

Verstappen leads Perez by 145 points in this year's championship and could clinch the world title with six races to spare at next week's Japanese Grand Prix. Mercedes are second in the constructors' championship, a distant 310 points behind, with team boss Toto Wolff believing that Red Bull are on course to win all 22 races this season.

"I think they need to screw it up themselves," Wolff said after Verstappen's 10th win in a row at

'One of the toughest'

If they complete the clean sweep, Red Bull would eclipse the record of Mercedes in 2016 when Nico Rosberg and Lewis Hamilton won 19 of 21 races. Red Bull team principal Christian Horner warned that the unique Marina Bay challenge could upset their perfect season.

"It's a street circuit, it's one of the toughest on the calendar. We saw last year how perilous it can be," said Horner. "We'll just do our best to keep this momentum running. "One day we're going to get beaten. It's just a question of when, and we've just got to make the when as far away as we can. "I think with every weekend that goes past there's more expectation to keep up this amazing run of results."

Mercedes chance?

Singapore lap times will be quicker this year because of construction work near the city-centre circuit which has meant the removal of four 90-degree corners towards the end of the lap. The total number of corners has dropped

from 22 to 19 with lap times around eight seconds faster. That will add a new element of uncertainty — team strategists will have less time to make calls on whether to pit for new tyres during the safety-car periods that frequent the Singapore race. Wolff believes Mercedes may have their best chance to upset Red Bull on a track where straight-line speed is not so crucial but grid position is everything because of the difficulty in overtaking.

"Singapore is back to high downforce and coming towards our direction a little bit more," he said. "It will be important for us to maximize that opportunity when it comes." — AFP

Johnson ready for blame if US should fall at Ryder Cup

SAN FRANCISCO: US Ryder Cup captain Zach Johnson said Tuesday he is ready to handle criticism if the Americans lose to Europe in two weeks at Italy after a dominating 2021 triumph. Seeing the disappointment over a fourth-place finish by US NBA

stars at the Basketball World Cup, Johnson accepts he might pay a price if the Americans cannot snap a 30year win drought on European soil.

"I've thought about it," Johnson said. "I kind of know what I'm signing up for. That being said, I didn't know all of what was going to be shot at me. There's no way to really know that. "All the arrows, some of them you just deflect and some of them you've got to veer and just try to navigate what you

can. I don't mind it. "I love responsibility, I love difficulty, I love being pushed and somewhat being uncomfortable if that makes sense." Johnson said full credit for victory should go to his 12-man team but he accepts his share of blame for a defeat. "If we lose this, there's probably some merit some of that can go on me," Johnson said. "I fully accept that, that's what I signed up for.

"I hope that's not the case but I'm at peace with whatever comes my way." Johnson spoke ahead of the PGA Tour's Fortinet Championship, which starts Thursday at Napa, California. Two-time defending Fortinet champion Max Homa and two-time major winner Justin Thomas from the US

squad will compete in the field. Thomas, a controversial captain's pick without a top-eight finish in seven months, has not played in six weeks after missing the FedEx Cup playoffs. Homa went 4-0 in the 2022 Presidents Cup the week after a Napa triumph. "Ideally they get some momentum. Momentum in this game is pretty lethal and can be a really good thing," Johnson said. — AFP

France off to a flyer as Davis Cup group stage finals begin

Wawrinka mocks empty stands for Davis Cup in Manchester

PARIS: France swept aside Switzerland and Chile crushed Sweden as the Davis Cup group stage finals got underway on Tuesday. Serbia, with Sunday's US Open champion Novak Djokovic taking a well-earned breather, were equally emphatic winners over South Korea while the Netherlands felled Finland 2-1.

The top two from each of the 16-team four group round robin will move into the knockout phase in Spain in November. And 10-time previous titleholders France made the best possible start to their Group B campaign in Manchester.

In front of massed ranks of empty seats - as the home crowd awaited the arrival on court of Andy Murray and his Great Britain team's clash with Australia on Wednesday - France gave Switzerland short shrift.

Adrian Mannarino got the ball rolling for Sebastien Grosjean's team, despatching 21-year-old Dominick Stricker who made the last 16 at the US Open at Flushing Meadows, in three sets, 3-6, 6-1, 6-4. Making reference to the near-deserted arena Mannarino said: "I wasn't expecting such a small crowd, it was almost cold out on court". Ugo Humbert made it 2-0 for the French when beating Stan Wawrinka, 38, who delivered the Davis Cup for Switzerland alongside Roger Federer in 2014, 6-4, 6-4, saving a match point before succumbing.

Earlier Warwinka had also drawn attention to the sparse turnout, poking fun at the former organizers of the Davis Cup, ex-footballer Gerard Pique's Kosmos company. The three-time Grand Slam champion played in Switzerland's 2014 triumph, when they beat France in the final, under the old format of knock-out ties played home and away.

Halep gets four-year doping ban

LONDON: Former world number one Simona Halep has been given a four-year suspension from tennis for two doping offences, the International Tennis Integrity Agency said Tuesday. The 31-year-old Romanian has been provisionally suspended since October last year after testing positive for the blood-boosting substance Roxadustat at the 2022 US Open.

And in May the two-time Grand Ślam singles champion was charged with a second anti-doping breach relating to irregularities in her Athlete Biological Passport (ABP). Both charges have been upheld by an independent tribunal. Halep, who has been provisionally suspended since October 2022, will not be able to play professional tennis again until October 6 2026.

'My fight continues'

But soon after the ITIA statement was released, Halep announced she would appeal the decision, saying: "Today (Tuesday), a tribunal under the tennis anti-doping programme announced a tentative decision in my case. The last year has been the hardest match of my life, and unfortunately my fight continues. "I have devoted my life to the beau-

Tonga to turn up the heat on Ireland in Rugby WCup

RUEIL-MALMAISON: Tongan rugby fans "are getting warm" as the 'Ikale Tahi (Sea Eagles) prepare for their Rugby World Cup opening match with world ranked number one Ireland in Nantes on Saturday, said captain Sonatane Takulua.

The 32-year-old scrum-half knows this because they have apparently started by now familiar ritual of painting his name on to cars and property in his home village of Lapaha. Whether there are any cars or houses left for his name to be painted on remains to be seen as they did this prior to the 2015 and 2019 editions.

The French wrapped up their 3-0 win in the doubles with Nicolas Mahut and Davis Cup debutant Edouard Roger-Vasselin seeing off Wawrinka and Marc-Andrea Huesler 6-2, 6-2. "It's the best way to start the competition," said captain Grosjean.

"We have a day to prepare for (28-time winners) Australia - we're going to watch the matches tomorrow and then give 100 percent on Thursday," he added. In Bologna, Chile made an early statement in a Group A which includes reigning champions Canada and hosts Italy. Christian Garin was made to sweat for his opening 7-6 (8/6), 3-6, 7-5 win over Leo Borg, the 20-year-old son of the legendary Bjorn Borg.

'Rollercoaster'

Nicolas Jarry had an easier time of it sending Elias Ymer packing with the loss of only six games before Marcelo Tomas Barrios and Alejandro Tabilo took the closing doubles 6-4, 7-5. For Jarry this was the latest high in what has been a "rollercoaster" few weeks. Last month he had to pull out of Cincinnati to attend the birth of his second child. He then flew to New York for the US Open, returned home after losing in the third round, before flying to Bologna, arriving with his luggage missing.

"I'm very happy, very emotional, a roller-coaster of things happening, travel and beautiful things," he smiled. With Djokovic sitting out the

tiful game of tennis. I take the rules that govern our sport very seriously and take pride in the fact I have never knowingly or intentionally used any prohibited substance. I refused to accept their decision of a four-year ban. I intend to appeal to The Court of Arbitration for Sport."

An independent tribunal, which heard evidence from Halep, the winner of the 2018 French Open and 2019 Wimbledon singles titles, met in London on June 28-29. On September 11, the tribunal —which also heard evidence from scientific experts and sifted through some 8,000 pages of evidence — confirmed it had found Halep had committed intentional violations under tennis's anti-doping programme.

One of these was the use of Roxadustat discovered in her urine sample at the 2022 US Open, with the other breach based on collection and analysis of 51 blood samples provided by Halep as part of the ABP programme. Roxadustat is a substance that can be used legitimately to treat anaemia.

But it is also on the World Anti-Doping Agency banned list as it is considered a blood-doping agent, which increases haemoglobin and the production of red blood cells. The biological passport system is designed for the long-term monitoring of an athlete's blood indicators with the aim of identifying irregularities that could indicate doping.

Halep has claimed experts found she had accidentally taken a contaminated supplement. But the ITIA said Tuesday that while the tribunal accepted Halep had taken a contaminated supplement, they also "determined the volume the player in-

gested could not have resulted in the concentration of Roxadustat found in the positive sample". ITIA chief executive Karen Moorhouse said: "After a complex and rigorous hearing process, we welcome the independent tribunal's decision."

She added: "The ITIA has followed the proper processes as we would with any other individual — in accordance with the world anti-doping code — fulfilling our purpose and responsibility to uphold the principle of fair competition, on behalf of the sport. "The panel recognized that appropriate procedure had been followed within the written decision." Moorhouse said that, given "the significant public interest", the full decision in Halep's case "will be published in due course". — AFP

However, Hilton says whilst they bring a lot to the squad in terms of top tier experience and skills the Tongans have not sacrificed their identity. "We represent Tonga, we do it a Tongan way and that is a really important thing as a group," said Hilton.

Rubiales insists Hermoso kiss was mutual, consented

BARCELONA: Former Spanish football federation president Luis Rubiales continued to insist his kiss on Jenni Hermoso's lips after the Women's World Cup final was "a mutual act", in an interview broadcast Tuesday in the United Kingdom.

World Cup-winning Spain midfielder Hermoso, 33, says the kiss was not consensual and a Spanish judge has summoned Rubiales to appear in court on Friday in a sexual assault investigation. Rubiales, who stood down from his post on Sunday, three weeks after the incident during the final medal ceremony following Spain's Sydney triumph, maintains his version is the "truth".

"What we had is a spontaneous act, a mutual act, an act that both consented to, which was driven by the emotion of the moment, the happiness, so I maintain that that is the truth of what happened," Rubiales told TalkTV show Piers Morgan Uncensored. The 46-year-old described the kiss as "non-sexual", having previously compared his behavior to how he would act with his daughters.

"My intentions were noble, enthusiastic, 100 percent non-sexual, 100 percent, I repeat, 100 percent," said Rubiales. The former federation chief, who was provisionally suspended by FIFA before he resigned, said the kiss occurred in a moment of jubilation. "You can imagine if you win the lottery or hopefully soon one day the war in the Ukraine finishes, I mean celebrations will go on up and down the globe," said Rubiales. "People don't ask permissions, it's just a happy, happy time and people celebrate."

However Rubiales reiterated that he had asked permission for the kiss, which he described as "a peck", and accepted that as president of the federation, the act was wrong. "Of course, I have said it from the beginning, I made a mistake, and I apologized in a sincere manner," he said.

"A president can give a hug, but needs to act in a more diplomatic and colder way." Rubiales faced unprecedented criticism after the kiss and his initial refusal to resign. Over 80 women's players went on strike from the national team and controversial coach Jorge Vilda was sacked.

The former chief said Sunday he was now stepping down to help Spain's 2030 men's World Cup bid, as well as his family who had come under pressure following his actions. — AFP

Messi, who has had a hectic schedule with his club Inter Miami, watched his teammates from the bench but was not listed as a substitute, having complained of tiredness after scoring the winner in Thursday's 1-0 victory over Ecuador.

Despite the absence of their talisman Lionel Scaloni's side had too much firepower for Bolivia with goals from Enzo Fernandez, Nicolas Tagliafico and Nicolas Gonzalez securing an impressive victory. Chelsea midfielder Fernandez went fort from 30 yards close with a wonderful efout superbly saved by Guillermo Viscarra, who then did well again to keep out a

Emotional release as Germany beat France

DORTMUND: Despite responding to coach Hansi Flick's sacking with a 2-1 victory over neighbours France in Dortmund on Tuesday, pressing questions remain for Euro 2024 hosts Germany. Usually a bitter rivalry between two of Europe's proudest footballing nations with six World Cups and five European Championships between them, France did not bring their usual intensity to Tuesday's friendly.

Manager Didier Deschamps made six changes from their last outing, a 2-0 win over Ireland, including benching star striker Kylian Mbappe. With France trailing 1-0 for most of the second half, Deschamps left Mbappe on the bench as his side chased the game, the manager later revealing "we didn't want to risk him in this game".

The France manager admitted his changes were made with the future in mind, including leading the line with Randal Kolo Muani who "hasn't played for a while, hasn't trained (and) isn't in top form right now". Calling Flick's caretaker successor Rudi Voeller a "unique and rare coach", Deschamps congratulated his "old friend", telling reporters "I'm not happy we lost, but nevertheless I'm happy for him."

Immediately after the game, interim coach Voeller described the win, Germany's first since March and only the second since the disappointing group stage exit at the Qatar World Cup, as an "emotional release". "What I liked most was that we brought good energy onto the field", telling the post-match press conference "it's not just about the result, but the style and manner of the performance".

Veteran Germany striker Thomas Mueller, who was named in the starting XI for the first time since Qatar, scored after just four minutes. The 2014 World Cup winner said the win was an "emotional liberation" for his side, but told German TV "it was fun, but we don't need to overstate -we still have a long way to go". — AFP
