

## Kuwait opens Gaza air bridge

First Kuwaiti relief plane arrives in Egypt • Panel debates law banning dealing with Zionist entity

KUWAIT: The first relief plane took off from Kuwait's Abdullah Al-Mubarak airbase and arrived at Egypt's Al-Arish Airport on Monday carrying humanitarian and medical aid for Palestinians in the Gaza Strip. Ministry of Social Affairs Spokesperson Ahmad Al-Enezi stated that these efforts are as per directions of political leadership and in cooperation with various state bodies and charitable organizations. Enezi stated that these planeloads would continue to deliver provisions to the Palestinian people in an affirmation of Kuwait's stance in providing aid to people all over the globe.

Kuwait Red Crescent Society (KRCS) envoy Khaled Al-Zaid told KUNA the airplane is carrying various medical supplies, ambulances and essential needs required in these conditions. Zaid said the aircraft is loaded

with 40 tons of aid from KRCS and Kuwait Society for Relief as per directions of Kuwait's political leadership in response to the call of the Palestinian people in cooperation with the ministries of defense and foreign affairs.

Zaid mentioned there is direct coordination between the Egyptian and Palestinian Red Crescent Societies to facilitate the entrance of those supplies into the country. He added KRCS is the first to provide aid inside Gaza by distributing meals in shelters and by providing diesel from the local market to a number of hospitals. Zaid expressed his appreciation to donors in Kuwait, including citizens, residents, institutions and banks from the private sector, for their support towards KRCS' efforts to relieve the Palestinian people who are being subjected to crimes against humanity committed by the Zionist occupation forces.

"What we hear from the mouth of the occupation leaders on preparations for a land invasion means more crimes, atrocities and forced displacement," Shtayyeh said.- AFP



### More than 5,000 Gazans killed in **Zionist strikes**

GAZA: Gaza's Hamas-run health ministry said Monday that more than 5,000 people have been killed in the besieged Palestinian enclave since the Zionist entity launched its withering bombing campaign more than two weeks ago. Alarm has surged about the spiraling humanitarian crisis in Gaza amid the war sparked by the Oct 7 Hamas attack that, Zionist officials say, killed more than 1,400 people. Hamas also took more than 200 captives.

On a day when the Zionist entity's army reported more than 300 new strikes within 24 hours, Gaza's health ministry said the death toll had surged above 5,000, more than 2,000 of them children. Thousands of buildings have been destroyed and more than one Continued on Page 6

### Kuwait-Manila labor talks to begin in Nov

KUWAIT: Official meetings between Kuwait and the Philippines are scheduled to begin at the start of next month on facilitating the return of Filipino workers to Kuwait, in line with discussions held between HH the Crown Prince Sheikh Mishal Al-Ahmad Al-Jaber Al-Sabah and Philippine President Ferdinand Marcos during the recent Gulf Cooperation Council and ASEAN summit in Riyadh. Sources revealed the Philippines,

which had imposed a ban on sending Filipino workers to Kuwait, saw in response Kuwait taking stringent measures to prevent the entry of Filipino workers, even those who had already obtained work visas before arriving in Kuwait. This situation adversely affected both countries, and now they are eager to resolve the issue.

Kuwait, in particular, is in need of Filipino domestic workers due to a shortage in the domestic labor market, resulting in increased recruitment costs

for families. This is exacerbated by Kuwait's inability to secure new labor agreements with other countries.

The sources further noted that the Filipino labor market was negatively impacted by the halt in recruiting their workers in Kuwait. It affected remittances from Filipino workers in Kuwait, while there is a significant number of Filipinos who wish to work in Kuwait and oppose the ban on their departure to the country.

The meetings between Kuwait and the Philippines are set to begin next month, with the Kuwaiti Embassy in the Philippines engaging with relevant authorities in the Philippines to establish the procedures for resuming Filipino labor recruitment.

Additionally, the two countries aim to implement recommendations that emerged from a prior informal meeting between labor recruitment agencies in the Philippines and Kuwait Union of Domestic Labor Offices. These recommendations include a review of the labor agreement between the two nations to safeguard the rights of both employers and workers. It was emphasized that the Philippine embassy is committed to complying with Kuwaiti laws, especially in relation to issues like providing shelter to runaway workers.

### Saudi to organize eSports World Cup

RIYADH: Saudi Arabia said on Monday it would organize an eSports World Cup starting next year, the latest boost to a sector Riyadh hopes will create tens of thousands of local jobs. "The eSports World Cup is the natural next step in Saudi Arabia's journey to become the premier global hub for gaming and eSports," Crown Prince Mohammed bin Salman said in a statement.

Saudi Arabia has invested heavily in the sector. Last year, the crown prince announced a \$38 billion investment strategy for the kingdom's Savvy Games Group, owned by the deep-pocketed sovereign wealth fund. The goal is to create 39,000 eSports-related jobs by 2030. Officials also want to

make Saudi Arabia "an Eden for game developers' that can produce new titles "promoting Saudi and Arabic culture", according to the national eSports strategy, targeting 30 globally competitive games produced in domestic studios by 2030.

The first edition of the eSports World Cup is expected next summer, taking the place of the eight-week Gamers8 festival of eSports tournaments, which this year featured a prize pool totaling \$45 million. "You can look at Gamers8 as a dry run for the eSports World Cup," said Ralf Reichert, CEO of the newly formed eSports World Cup Foundation.

Tourism falls off considerably during the summer in Saudi Arabia when temperatures in the capital Riyadh clear 40 degrees Celsius on a daily basis. But the eSports World Cup "will be complemented with a diversified set of activities and events that will draw visitors and tourists to the capital, transforming it into a gaming capital", Monday's statement said. ## Kuwait University organizes rally to support Palestinians

Arab envoys, EU officials meet on Gaza



**KUWAIT:** Kuwait University (KU) organized a rally on Monday in collaboration with the KU Faculty Association and the National Union of Kuwaiti Students (NUKS) in support of Palestinians in Gaza. Acting Director of KU Dr. Fayiz Al-Dhafeeri and large crowds of students, faculty members, and university workers joined together to denounce the Zionist occupation's aggression against Palestine and Gaza, which led to thousands of deaths and countless injuries, especially during the recent bombing of Al-Ahli Arab Hospital.

In order to demonstrate Kuwait's stances in its various entities and institutions, Head of the KU Faculty Association Dr. Ali Al-Kandari told KUNA that the institutions are sending a message to the global academic community to establish human rights in Palestine, stop unjustified attacks, and adhere to the laws. **Envoys, EU officials meet** In another development, a delega-

tion of Arab ambassadors held intensive meetings with officials from European Union institutions in Brussels during the past couple of days to discuss the dangerous escalation in the Gaza Strip. In a statement on Monday, the ambassadors noted that some European statements and positions send "wrong messages to Zionist forces, the occupying power, who may feel encouraged to increase their attacks, their killing of civilians, and their targeting of public and private facilities and infrastructure in the Gaza Strip."

They pointed out the harm resulting from the adoption by "certain European officials and political institutions of an unbalanced and unacceptable approach of double standards when speaking about and describing the reality of what is happening in Gaza and the real reasons that led to the deterioration of the situation." They stressed the necessity of look-

ing at the real reasons behind the current outbreak, including the absence of a political horizon and failing to address the root causes of the conflict, highlighting the importance of pressuring Zionists to stop the cycle of violence, put in place a ceasefire, bring urgent humanitarian aid into Gaza, and prevent the internal or forcible displacement of Palestinians in or out of the Gaza Strip.

In their meetings, the Arab ambassadors stated that there can be no peace nor stability in the region without the implementation of the relevant UN resolutions of international legitimacy, the withdrawal of Zionist occupation from all occupied Arab territories, and the establishment of a sovereign independent Palestinian state with East Jerusalem as its capital, in line with relevant international resolutions, international legitimacy, and the Arab Peace Initiative.

They also stressed the need to stop targeting Rafah border crossing from the Palestinian side and for humanitarian aid to enter safely, while expressing absolute rejection of any Zionist plan to internally or forcibly displace or transfer the residents of the Gaza Strip, as this constitutes ethnic cleansing and is contrary to Zionists' legal obligations as the occupying power in accordance with the four Geneva Conventions and international humanitarian law.

The delegation condemned occupation army's continuous incursions into the West Bank, unacceptable settler violence against defenseless civilians, and violating holy Muslim and Christian sites including East Jerusalem, warning of widening the scope of the conflict and of the dire consequences it will have on the entire region. The ambassadors conveyed the Arab position as reflected in the resolution issued by the Extraordinary Session of the Council of Ministers of Foreign Affairs of the Arab League, held in Cairo on October 11, condemning the targeting of civilians and highlighting the urgent need to stop the current aggression on the Gaza Strip.

The group met officials from the European Council, the European Commission, and the European Parliament, as well as the European External and Action Service (EEAS), as well as officials from Belgium, Luxembourg, and NATO. Mandated by the Council of Arab Ambassadors in Brussels, a delegation of Arab ambassadors, including from Palestine, Egypt, Saudi Arabia, Jordan, Lebanon, and the Arab League, held intensive meetings over the past few days with officials of the European Union institutions. — KUNA

### 'Regulate Your Pulse, Protect Your Heart'

**KUWAIT:** Salman Al-Dabbous Heart Center at Adan Hospital organized a seminar on atrial fibrillation with the theme "Regulate Your Pulse, Protect Your Heart". The seminar aimed to provide information about the symptoms of atrial fibrillation, potential treatments and how to manage the condition. Samah Al-Kharji, Head of Heart Diseases at Al-Dabbous Heart Center and a member of the Kuwait Heart Foundation, said the prevalence of atrial fibrillation in Kuwait is approximately 4.2 percent. In the broader Middle East region, this figure stands at around 8 percent, while among patients who have experienced acute heart attacks, it's nearly 2.4 percent.

Kharji explained that a preliminary study involving approximately 500 patients under treatment at the center revealed that the average age of these patients is 65 years, with an average BMI of 31.7, indicating second-degree obesity. Among these patients, 41 percent are experiencing myocardial failure, 50 percent have diabetes, and only about 60 percent regularly seek medical attention. She further noted that atrial fibrillation (AF) is the most common electrical heart defect, affecting around 43 million individuals worldwide.

Approximately one out of three people aged 55 and older develop AF. AF is a heart rhythm disorder that may initially occur sporadically, and in some cases, progress to become a permanent condition. Kharji added that the symptoms of AF may not be apparent to the patient, who could experience unexplained fatigue, extreme tiredness, difficulty breathing, dizziness or even loss of consciousness. She emphasized that AF increases the risk of strokes by five times compared to individuals who do not have AF. small and medium businesses, which serve various markets from F&B to clothing and accessories, home ware, perfumes, and more.

**KUWAIT:** The Contemporary Art Platform (CAP) hosted an art exhibition on Sunday featuring Palestinian, Kuwaiti and international artists in support of the Palestinian resistance. "This exhibition was created in just one week, and it is remarkable how it was executed with such beauty and intensity in such a short period.

Dr Askari said that one of the artworks in the exhibition is a drawing of the Dome of the Rock, inspired by passages from Fairuz's song "I am Al-Quds", and it will be auctioned to benefit the people of Gaza through the Kuwait Red Crescent Society. Ibrahim Farghali, Cultural Program Officer at CAP, said: "The

The exhibition primarily features works by various Palestinian and international artists, along with contributions from Kuwaiti artists, including sculptors Saad Hamdan and Abdulwahab Al-Awadhi. ### Kuwait charity societies send urgent aid to Gaza

**KUWAIT:** Kuwaiti charity societies continue to rally up efforts to address the deteriorating humanitarian situation in Gaza as the Zionist occupation aggression left thousands of casualties and a large number of families with no homes or provisions. The latest data showed that Zionist occupation airstrikes, since October 7, have killed more than 4,600 people and injured over 14,000, while residential areas and infrastructure were left in rubble.

Al-Salam Charity Chief, Dhari Al-Beijan, told KUNA that since its establishment, the charity has focused its work on central Asia, but due to the continuing tragic events in Gaza, Al-Salam Charity has redirected its efforts. The charity, affirmed Al-Beijan, is in contact with official organizations in Palestine approved by the Kuwaiti Ministry of Foreign Affairs to deliver urgent aid to the people of Gaza. ## GCC regrets UNSC's failure to adopt Gaza resolution

### A broad Arab response to assist Palestinians

**RIYADH:** Gulf Cooperation Council (GCC) foreign ministers regretted the failure of the UN Security Council (UNSC) to adopt a resolution aiming at ending the Zionist occupation aggression on Gaza. This came in a letter sent by Omani Foreign Minister and President of the Current Session of the GCC Ministerial Council Bader Al-Busaidi to Brazil's Permanent Representative at the UN, Sergeo Danese, whose country holds the current rotating presidency of the UNSC.

GCC Secretary-General Jasem Al-Budaiwi said the letter covered a recently announced GCC pledge worth \$100 million to offer relief aid to the Gaza Strip. He voiced the council's willingness to continue working with the UNSC to adopt a resolution that would put an end to international resolutions, treaties, and laws, including UNSC Resolution 242/338, which reflects international consensus on the bi-state solution.

He quoted the GCC foreign ministers as having expressed readiness to meet with Brazil's permanent representative and UNSC members in New York in this regard. He also quoted him as having underlined the necessity of ceasing hostilities, observing international law and international humanitarian law, and immediately releasing hostages and detainees.

Meanwhile, the Arab League, the Arab Crescent Organization, and the Red Cross revealed on Sunday a broad Arab response to provide humanitarian assistance to the people of the Gaza Strip, praising the efforts of Arab countries in this framework to help Palestinians. This came at a joint press conference held by the assistant secretary general for social affairs at the university, Dr. Haifa Abu Ghazaleh, with the secretary general of the Arab Red Crescent and Red Cross organization, Saleh Al-Tuwaijri, to discuss how to provide humanitarian assistance to the Gaza Strip.

Abu Ghazaleh said that the Arab League is in contact with international organizations to try to find a way out and an outlet to deliver aid to the Gaza Strip, expressing appreciation for the efforts of Arab countries and Egypt. Abu Ghazaleh called on all Arabs to respond to the donation campaigns launched by the Red Crescent and Red Cross societies in the member states to support Palestinians.

that this has been facilitated by the Foreign Ministry and the Social Affairs Ministry.

As for Najat Charity's Abdullah Al-Shehab, he told KUNA that over 34,000 people benefited from the urgent aid sent by the charity as part of the "For Palestine" campaign launched towards the beginning of escalation. Al-Shehab mentioned that they are preparing to send new batches of assistance, as they have also launched another campaign for the sponsorship of 1,000 orphans. Tanmeia Charity official Musab Al-Otaibi told KUNA that the Gaza Strip is in dire need of necessary provisions as the people are suffering from severe shortages and the collapse of the health system.

He affirmed that despite tough conditions and obstacles in delivering aid, Tanmeia Charity would continue to send support to Palestinians. Kuwaiti Relief Air Bridge launched on Monday with its first planeload and will continue to do so on a daily basis this current week. The planeloads, consisting of urgent supplies and medical necessities, are heading to the Gaza Strip through the Al-Arish area in the Sinai Peninsula in Egypt.

She pointed to the efforts made by the league to disseminate the needs of Palestine to the member states, pointing to moves with the Egyptian Ministry of Health to provide the support previously announced by the Council of Arab Health Ministers, which is estimated at half a million dollars of medicines. She expressed hope that this aid will enter the Gaza Strip through the Rafah border crossing, noting that the entry of relief materials was stopped after the Zionist occupation allowed the entry of 20 aid trucks.

The estimated number of Palestinians displaced as a result of shelling and supply cuts in Gaza is one million, in addition to the 513,000 who took refuge in the facilities

of the United Nations Relief and Works Organization for Palestine refugees (UNRWA). The shelling of the occupation forces has killed about 4,733 martyrs, in addition to other martyrs under the rubble, 600 missing children, and more than 15,000 injured.

According to UN statistics, about 70 percent of the number of martyrs in the Gaza Strip are children, women, and the elderly. The Gaza Strip is suffering for the 16th consecutive day of an unprecedented humanitarian disaster as a result of the escalation and the blockade imposed by the unjust and inhumane Zionist occupation, cutting off electricity, water, and fuel and preventing relief and humanitarian supplies to civilians. — KUNA

## Aid entering Gaza not enough

'Humanitarian pause' needed to allow support to reach those in need: Borrell

**EL-ARISH:** Under the roar of military aircraft, workers were rushing to offload supplies at Egypt's El-Arish airport as aid trickles into the stricken Gaza Strip after more than two weeks since the Zionist occupation declared war on Hamas. Officials barked orders and forklift trucks revved their engines, swerving at speed on the tarmac as they carried items including vital food and medicine for the Palestinian enclave.

Planeloads of aid have been landing for days at El-Arish, about 45 kilometers from the Rafah border crossing, the only route into Gaza that's not controlled by the Zionist occupation. But it was only over the weekend that the first supplies were allowed to reach Gaza, where 2.4 million people have been under blockade for years and complete siege by the Zionists for two weeks.

The Zionist occupation has been relentlessly bombing Gaza since October 7, killing more than 5,087 Palestinians, mainly civilians. The escalated attacks came following the infiltration of hundreds of Hamas fighters into occupied areas near the Gaza border which left 1,400 people dead. Three convoys of aid totaling about 50 trucks have cleared the Rafah crossing since Saturday. The United Nations estimates Gaza requires about 100 trucks a day to meet the needs of residents, almost half of whom are believed to have been displaced by the Zionist bombing campaign. WHO chief Tedros Adhanom Ghebreyesus issued a new appeal on Monday for "sustained safe passage" for medical essentials and fuel to keep health facilities open. "Lives depend on these decisions," he said on social platform X. Mohammad Maher, 40, who has fled to the south from Gaza City in the north, told Reuters: "We don't want food or money. We want this war to end. We want death to stop and we want this blind bombing of civilians to stop." He described the amount of food aid that had arrived as "pathetic" and accused the Zionist occupation and the United States of seeking the starvation of Palestinians. "Shame on the world," he said.

#### 'Pause' needed

EU foreign policy chief Josep Borrell on Monday urged faster aid deliveries to Gaza, and said the bloc was debating calling for a "humanitarian pause" in the Zionist bombing on Gaza. Borrell said that the few dozen trucks of humanitarian aid that had been allowed into Gaza from Egypt was "not enough" and said fuel to produce power and drinking water was particularly needed. He said ministers would discuss calls from United Nations' secretary-general Antonio Guterres for a "humanitarian ceasefire" and the issue would be on the table at an EU leaders summit on Thursday. "Personally, I think that a humanitarian pause is needed in order to allow the humanitarian support to come in and be distributed, seeing that half of the population of Gaza has been moving from their houses," Borrell

said. He said "the attacks of missiles, rockets from Hamas, from Gaza, has to stop and the hostages, people who have been kidnapped, have to be released". "It is part of any step towards de-escalation."

Borrell said a pause would be a less ambitious objective than the "humanitarian ceasefire" called for by United Nations secretary-general Antonio Guterres. Despite Borrell's assessment, a European official, who asked to stay anonymous, warned there was not yet a clear agreement among the 27 EU nations on issuing a call for a pause in the fighting.

#### No fuel

On Sunday, the UN said the lives of at least 120 newborn babies in incubators in Gaza's hospitals are at risk as fuel runs out in the Palestinian enclave under renewed Zionist blockade in the wake of the October 7 Hamas attack. The first batch of 20 trucks carrying humanitarian aid entered Gaza via Rafah crossing with Egypt on Saturday, but the occupation continues to block fuel and electricity supplies critical to running hospitals and support several other essential services, such as bakeries. Palestinians to move south, it had not previously told them they could be identified as "terrorist" sympathizers if they did not. World Health Organization Director-General said on X that "It is impossible for these overcrowded hospitals to safely evacuate patients." "They must be allowed to perform their lifesaving functions. They must be protected," he added.

#### Tons of aid waiting

In less than an hour on Sunday, two Qatari planes and one Indian aircraft, all carrying aid, touched down at El-Arish, with scores of Egyptian Red Crescent workers scrambling to unload them. Youssef al-Mulla, a humanitarian aid worker with the Qatar Development Fund, said the Gulf emirate had supplied over 100 tons of aid destined for Gaza since the start of the crisis. "This is the fourth flight that we have sent to El-Arish," he told AFP at the airport, explaining the first deliver had been "27 tons in two flights and

Leaflets dropped by air and marked with the Zionist military logo automated phone messages sent to people across Gaza on Sunday delivered one message. "Whoever chooses not to leave north Gaza to the south of Wadi Gaza might be identified as an accomplice in a terrorist organization," the leaflets said. Although the occupation has previously warned the first delivery had been "37 tons in two flights and these two flights have around 86 tons of aid".

While Mulla, who accompanied one of the flights from Qatar, was hopeful all the supplies would reach Gaza, he said only two trucks of aid from Qatar had crossed at Rafah as of Sunday. The delays meant further aid earmarked for Gaza had remained in Doha, he said. "It's ready to be sent at any time," he said. As the first Qatari aircraft departed El-Arish on Sunday to return to Doha, the aid it brought stood carefully stacked and waiting on the runway's apron. — Agencies

### More than 19,000 flee in Lebanon as tensions escalate

**BEIRUT:** More than 19,000 people have been displaced in Lebanon amid an uptick in tensions between the Zionist occupation and Hezbollah at the country's southern border, figures released Monday by a United Nations agency showed. "An increase in cross-border incidents" has resulted in the displacement of 19,646 people in Lebanon, "both within the south and elsewhere within the country", said the International Organization for Migration.

"We expect the numbers to rise as the cross-border tensions continue" or if there is an escalation in violence, IOM spokesperson Mohammedali Abunajela told AFP in a statement. The Zionist occupation has been relentlessly bombing Gaza since October 7, killing more than 5,087 Palestinians, mainly civilians. The escalated attacks came following the infiltration of hundreds of Hamas fighters into occupied areas near the Gaza border which left 1,400 people dead.

### Gaza students in Egypt fear worst for families

**CAIRO:** The last time Saja Samy heard from her family in Gaza, they were sheltering, along with thousands of others, at a hospital compound under threat of Zionist air strikes. In her dorm room in Egypt, the 20-year-old medical student clutches her phone, desperately scrolling for any clue as to whether her family is still alive.

"I can't think straight. I don't know where my family is. I don't know if they're okay," she told AFP. "Every time I talk to my mom, she tells me that she doesn't know if they'll survive this and how I have to take care of myself. But what am I supposed to do on my own?"

Like 6,000 other Palestinians studying in Egyptian universities, Samy has been forced to watch the war in Gaza from afar. Dozens of them sat in an exam hall last Zionist entity, raising fears the group intends to open a front from Lebanon in support of ally Hamas. The Zionist entity has carried out cross-border strikes and bombardments on Lebanon, while Palestinian groups have also launched limited infiltration attempts into occupied Palestine.

Dozens of communities have been told to evacuate in occupied Palestine, while thousands of civilians in Lebanon have fled, many heading to other parts of the south or areas in or outside the capital Beirut. Lebanon, grappling with political paralysis and a four-year-long economic crisis, has not implemented an evacuation plan, but Prime Minister Najib Mikati has said the country was developing an emergency response "as a precaution".

The IOM's Abunajela said that "amidst a deteriorating economic situation and the significant rise in poverty across all populations in Lebanon, internal displacements may add additional stress to the resources of host communities". Most of the displaced are currently "sheltered in host and family settings, while there are three designated schools, managed by local authorities that are also used as shelters", Abunajela said.

An AFP correspondent last week saw families taking refuge in public schools converted into shelters in the southern city of Tyre, where authorities said they were looking for a place to open a fourth center. At

week, willing themselves to focus on a test — and not their families suffering barely a five-hour drive away.

When her mother last spoke to her from Shifa hospital in northern Gaza, she said she was afraid that "if the air strikes don't kill them, the children will die of fright". Samy doesn't sleep, thinking of her six-year-old sister lying awake on the ground in the hospital courtyard, shivering in the cold. Every time she sees news of a bombed-out hospital, her heart stops.

#### Panicked group chats

Like Samy, 21-year-old Ghaidaa Jaber stares endlessly at her phone screen, begging for her messages to go through. The last message from her mother on October 12 said she was leaving their home in northern Gaza to head south with Jaber's four sisters and three brothers in a desperate attempt to flee the relentless bombardment. "I haven't heard anything since," she told AFP.

In panicked group chats, Jaber and other students try to triangulate information. "We're trying to see on social media where they've bombed, what's nearby,

least 40 people have been killed on the Lebanese side of the border, according to an AFP tally — mostly combatants but also including at least four civilians, one of them Reuters journalist Issam Abdallah. Lebanon's crisis has crippled basic services, from electricity to health care and education. "The country's

what roads our families could be on, going through lists of martyrs and families that have been killed." "All you can do is pray" and hope you don't come across your own surname, she said.

Haya Shehab, 21, learned from an Instagram post that her extended family's home had been bombed, killing 45 people — dozens of them cousins. "Just like that, 45 of us gone," said Shehab, who studies at a private university in Cairo.

Jaber was six when she first felt her home tremble under the force of Zionist air strikes, and remembers clutching onto her family for dear life as bombs rained down from above. "I know what it's like, but this time is so much worse," she said.

The formative memory of Jaber, Samy, and countless others' childhoods was the war on Gaza in 2014, when Zionist occupation forces killed around 2,250 Palestinians. "That was 50 days. There were as many martyred now in the first week of the war," Jaber said.

For years, Samy's father insisted the family stay put despite the violence, reminding them "our home is all we have". But on October 7, as Zionist Prime Minister health system is facing severe resource shortages, including medicines" and medical personnel, Abunajela said. "In this context, responding to large-scale displacement and health causalities that might occur ... may overwhelm the already fragile health system," he warned. — AFP

Benjamin Netanyahu declared "a long and difficult war", the family packed up and left their home which within days was reduced to a smoldering pile of rubble. "We always used to say they don't bomb western Gaza, but this war proved to me that nowhere is safe," Samy said.

Shehab also thought her family's home in the southern district of Khan Yunis was relatively safe, where "bombings were limited". "But not this time." The occupation's assault has hit residential buildings, roads they had designated as safe escape routes and southern Gaza, where more than a million Palestinians have fled after the Zionist authorities ordered them out of the north.

And for the terrified students who are unable to go about their lives, there is also the overwhelming sense of guilt. "How dare I be so far away? How can I eat when they're hungry? How can I sleep?" wonders Jaber who has been locked in her room for two weeks. Samy has also been blaming herself. "I hate this feeling, knowing I'm safe and they're not. I wish I was with them, I would rather be with them and die with them than feel like this." — AFP

## **Pakistan ex-PM Khan indicted** in leaked documents case

### More than 100 rioters to be prosecuted in civilian courts: Supreme court verdict

RAWALPINDI: Jailed former Pakistan prime minister Imran Khan was indicted on Monday for allegedly leaking classified documents, a charge set to keep him in custody in the countdown to national elections due early next year. Since being ousted in 2022, Khan has been tangled in a slew of legal cases he says are designed to stop him from contesting polls in January, while his party has faced a massive crackdown.

A spokesman for Khan's Pakistan Tehreek-e-Insaf (PTI) party said he was charged under the colonial-era Official Secrets Act in a trial "conducted within the court premises with no access to public or media". The case relates to a diplomatic cable the 71-year-old allegedly touted as proof of a "conspiracy" behind the no-confidence vote which turfed him out of office last April. "We are going to challenge it," Khan's lawyer Umar Khan Niazi told reporters outside the jail where the special court was convened. Khan's lawyers say the crime he has been charged with carries a possible 14-year prison term, and in the most extreme circumstances, the death penalty.

Army courts stood down Pakistan's supreme court gave rare re-

spite to PTI on Monday by ordering that man of Khan's PTI party, Shah Mahmood more than 100 supporters accused of rioting in May should not be prosecuted in military tribunals as planned. "Under the Supreme Court verdict all the cases, which were being tried in the military courts, cannot be proceeded. They could only be held in the civilian courts," PTI lawyer Aitzaz Ahsan told reporters. "Today's verdict is highly significant and it will help strengthen the constitution, law, and the civilian institutions of the country." The violence erupted after Khan was briefly arrested, with unprecedented anger aimed at the military. He was later convicted of graft in August and sentenced to three years in prison. That sentence was overturned but he was kept in custody on the far more serious charge of sharing state documents he alleged proved how the army conspired with US diplomats to end his premiership.

The United States and Pakistan's military have denied the claim. "PTI has been bled to death. The current army chief doesn't want it around, if it is around, it's minus Imran Khan," political analyst Ayesha Siddiqa told AFP. "There is an entire movement out there by the establishment to eliminate him politically, at least for now," she said. The vice-chairQureshi, a former foreign minister, was also indicted over the same case.

#### Khan tangled up

Former cricketing superstar Khan enjoys enormous support in Pakistan but his street power has been squashed by the crackdown, which has seen thousands detained. Almost the entire senior party leadership were forced underground, with many abandoning PTI. On Sunday, PTI said about 80 members were rounded up at a convention in Lahore that they reportedly did not have permission for. Pakistan's military has directly ruled the country for roughly half of its 76-year history and continues to exercise enormous power.

The nation is currently led by an interim government, with polls already pushed back several months. Khan's primary opponent, three-time prime minister Nawaz Sharif, returned to Pakistan on Saturday, ending four years of self-imposed exile. Sharif was jailed for graft and barred from contesting the 2018 elections — in which Khan swept to power - but he left midway through his sentence to receive medical care in the United Kingdom, ignoring court orders to return.

### Antisemitism not behind synagogue leader's death: Police

DETROIT: Police probing the stabbing death of the president of a US synagogue said Sunday that no evidence has emerged of anti-Semitism as a motive. Detroit police chief James White said in a brief statement that his force is interviewing "individuals with information that may further the investigation" into the death Saturday of Samantha Woll. He gave no details.

"No evidence has surfaced suggesting that this crime was motivated by anti-Semitism," White said. He said the FBI is assisting Detroit police and he asked for patience as the probe proceeds. "Everything that can be done to bring this matter to closure is being called into service," White said.

### Fake Ozempic pens circulating in Europe, watchdogs warn

PARIS: Fake injection pens of Ozempic, a hugely popular diabetes drug that went viral on social media as a way to lose weight, are circulating in Europe, drug authorities have warned. Ozempic, which involves a once-weekly injection from a pre-filled pen, was originally developed to treat type 2 diabetes.

However, since it became clear the drug was effective for weight loss, massive demand driven partly by "off label" use of the drug has led to stock short-

### 17 dead, over 100 injured in train crash in Bangladesh

DHAKA: At least 17 people have been killed and 100 others injured in Bangladesh after two trains collided on Monday, with officials saying they fear the death toll will rise. The crash in the eastern city of Bhairab saw a freight train smash into a passenger train travelling in the opposite direction, derailing two passenger carriages, officials said.

ages. Now pre-filled pens falsely labelled as Ozempic have been identified at some wholesalers in the EU and UK, according to the European Medicines Agency (EMA).

On Sunday, France's ANSM medicines authority said that "as a precaution, we call on all players in the supply chain to be vigilant" about the fakes. The counterfeit pens have labels in German and originated from wholesalers in Austria and Germany, the EMA said in a statement last week. "There is no evidence that any falsified pens have been dispensed to patients from legal pharmacies and there are no reports of harm to patients in relation to the falsified medicine," the EMA said.


Police and European Union drug regulators are investigating the issue, it added. Germany's drug regulator BfArM released a picture of the fake pens,

trapped under overturned coaches. "A rescue train carrying cranes is on its way," he said.

Local residents and volunteers rushed to the scene after the accident took place at around 4:00 pm (1000 GMT). The crash occurred after one train entered the same line as the other, Rahman said. Video footage broadcast by the private Channel 24 showed hundreds of people crowding the accident site with many in tears as they searched for relatives. "We have rescued at least two people alive from showing that they look quite different to the official version. The counterfeits were first noticed due to inactive serial numbers.

On Sunday, Kuwait's Minister of Foreign Affairs Sheikh Salem Abdullah Al-Sabah announced the launch of relief operations through an air bridge in response to the call of the Palestinian people and as per directions of HH the Amir Sheikh Nawaf Al-Ahmad Al-Jaber Al-Sabah, HH the Crown Prince Sheikh Mishal Al-Ahmad Al-Jaber Al-Sabah and HH the Prime Minister Sheikh Ahmad Al-Nawaf Al-Sabah.

The humanitarian air bridge launched by Kuwait to bring some 40 tons of aid to Palestinians in the Gaza Strip will last for five days, the country's ambassador to Egypt Ghanim Al-Ghanim said on Monday. The initiative aims to "mitigate the misery" of Palestinians in the Gaza Strip, who have been the victims of "(Zionist) transgressions", the envoy said, as he is overseeing the arrival of Kuwaiti aid at Arish airport.

The aid runs the gamut from essential food supplies to healthcare assistance, added the Kuwaiti diplomat, saying it was a testament to Kuwait's "unflinching support" for the Palestinians. It is "incumbent" upon the international community to stand alongside the Palestinians at a time when the Zionist entity has stepped up its vicious attacks against them, he underlined.

Sheikh Salem said Monday official and civilian

agencies are working together for the air bridge to deliver humanitarian aid to Gaza. The foreign minister made the remark while briefing a Cabinet meeting on Kuwait's humanitarian initiative to help Palestinians in the Gaza Strip. During the meeting, he reiterated the initiative, which reflected Kuwait's principled and relentless stance on the Palestinian cause, was directed by HH the Amir, HH the Crown Prince and HH the Prime Minister. He added that the Kuwaiti air bridge would be overseen by the ministries of foreign affairs, defense and health and the air force, in collaboration with KRCS, Kuwait Relief Society and other humanitarian charities.

Meanwhile, the National Assembly's foreign relations committee has debated over two days a draft law that would ban any dealing or normalization of ties with the Zionist entity. The draft law for banning normalization of ties with the Zionist entity also bans dealing with Western and international companies that have links with the Zionist entity. In addition, the draft law also bans residents of Kuwait from sympathizing with the Zionist entity.

Foreign Minister Sheikh Salem attended deliberations of the committee on Sunday and Monday. A final decision of the panel was expected late Monday after it gave its green light the previous day. The National Assembly, which opens its new term on Oct 31, is scheduled to hold a special session the following day to debate Zionist attacks on Palestinians and is expected to approve the draft law banning ties with the Zionist entity.

million people displaced in the territory that has been under siege and largely deprived of water, food and other basic supplies.

About a dozen trucks carrying desperately needed aid — the third convoy in three days — arrived inside Gaza from Egypt on Monday through Rafah, Gaza's only crossing not controlled by the Zionist entity. The United States, which has brokered the entry of the aid convoys, has vowed a "continued flow" of relief goods into Gaza, even as UN aid agencies have said far more is needed.

Gaza's Hamas-controlled government media office said that "more than 60 were martyred in the raids" during the night - including 17 in a single strike that hit a house in Gaza's north - and at least 10 others were killed in new strikes early Monday. The Zionist military said it had hit "over 320 military targets in the Gaza Strip" in the past 24 hours.

Rafah resident Mohammed Abu Sabalah said he had returned home from the local mosque after dawn prayers Monday and that "a quarter of an hour later there was a bombing". "We couldn't see anything because of the thick smoke," he said, adding that "we thank God that we've emerged safe and sound" with "only a few windows and doors destroyed".

Zionist forces are massed near the Gaza border, and smaller units have already carried out limited incursions, targeting Hamas and hoping to rescue captives, whose number the Zionist entity now puts at 222. In one such operation, a 19-year-old Zionist soldier was killed and three others wounded, the army said, adding that the tank operation had aimed "to dismantle terror infrastructure... and locate missing

persons and bodies".

Tensions have been inflamed in the occupied West Bank, where 95 Palestinians have been killed in clashes involving Zionist security forces or settlers since fighting began in Gaza, according to the Ramallah-based health ministry. In Gaza, where thousands have been wounded, the health ministry issued a statement saying "citizens are called upon to immediately go to hospitals and blood bank branches to donate blood".

Alarm has grown about the dire needs of the 2.4 million civilians trapped inside the 40-km long coastal strip that was already blockaded and impoverished before the war. Children killed in a Zionist air strike in the southern city of Khan Yunis were Monday laid to rest in a makeshift grave, while in Rafah men were filling plastic jerrycans from containers with now scare safe drinking water.

US President Joe Biden brokered the passage of aid convoys with Egyptian and Zionist leaders in talks last week — but the United Nations estimates Gaza needs about 100 trucks of relief goods every day. UN aid chief Martin Griffiths said Sunday's delivery of food, water and medical supplies was "another small glimmer of hope for the millions of people in dire need of humanitarian aid". "But they need more, much more.'

The Zionist entity has rejected the entry of fuel into Gaza, fearing Hamas could use it for weapons and explosives. This has sparked warnings that soon Gaza's ambulances, hospital incubators for infants and water desalination plants will soon stop functioning. Around the world the Zionist entity's friends and foes alike have warned against the Gaza war spilling over into a full-scale regional conflagration. The Zionist entity's archenemy Iran has repeatedly warned of an escalation, as have its allied armed groups, including Lebanon's Hezbollah, which has traded cross-border fire with the Zionist entity. - AFP

### **Qatar announces** 27-year gas deal with Italy's Eni

DOHA: Qatar has agreed to supply Italian firm Eni with natural gas for 27 years, the Gulf emirate's state-owned energy company announced on Monday, the latest in a series of major deals. Doha will supply one million tons of gas a year under the deal, QatarEnergy said, following an agreement with Eni for a share of Qatar's huge North Field gas expansion project.

In the wake of Moscow's invasion of Ukraine last year, European nations have rushed to replace lost deliveries of natural gas from Russia. "Today, we are taking another important step in strengthening our partnership with Eni that will foster our mutual cooperation for many years to come," Qatari Energy Minister Saad Al-Kaabi said. "Together, we will continue to demonstrate commitment to the European markets in general, and to the Italian market in particular," he added.

In June last year Eni agreed a deal with QatarEnergy for a 3.1 percent share in Qatar's North Field East project, the first phase of the Gulf emirate's expansion

### **US unveils tech hubs** to push innovation

SAN FRANCISCO: The United States unveiled Monday a list of 31 tech hubs that it will create as part of the vast investment scheme that President Joe Biden hopes will help him win reelection. Commerce Secretary Gina Raimondo said these centers will create jobs and boost both nation-al security and the economy. These investments, she said, "further underpin our ability to compete, and frankly, outcompete the rest of the world."

The hubs were chosen from among 400 candidates and will now compete for grants of as much as \$75 million. They were created under the Chips and Science Act, a law

into the largest gas field on the planet, which extends into Iranian territory. Deliveries of liquefied natural gas (LNG) to Italy's Tuscany region are expected to begin in 2026. In a statement, Rome-headquartered Eni said the deal "strengthens" its partnership with QatarEnergy, adding involvement in North Field East was "in line with Eni's transition strategy, which aims to progressively increase the role of gas".

The deal with Eni follows a quick succession of historically long agreements with European firms for gas supply from Qatar. Last week, Qatar announced a deal for 27 years with Britain's Shell and earlier in the month, France's Total announced another deal of equal length.

Under its North Field expansion, Qatar is set to raise its LNG output by 60 percent or more to 126 million tons a year by 2027. The main market for Qatari gas has traditionally been Asia, led by countries like China, Japan and South Korea. The deals with Eni, Shell and Total are the same length as those agreed by the China National Petroleum Corporation in June and China's Sinopec in 2022. All have set a benchmark as the longest in the LNG industry. US giants ConocoPhillips and ExxonMobil have also signed deals to partner in the expansion. Qatar is one of the world's top LNG producers, alongside the United States, Australia and Russia. QatarEnergy estimates the North Field holds about 10 percent of the world's known natural gas reserves. - AFP


passed last year that freed up \$52 billion in subsidies to stimulate US semiconductor production in America.

"We've lost our edge in semiconductor manufacturing, and investments in earlier stage R&D like this in Texas and Oklahoma will allow us to regain our edge (and) continue to lead," she added. Located across 32 states and Puerto Rico, these tech hubs will specialize in such fields as the transition to clean energy, biotechnology and quantum computing. -AFP

## ECB poised to hold rates as inflation drifts downwards

### Mideast conflict could 'further dampen eurozone growth prospects'

**BERLIN:** For the first time in over a year, European Central Bank policymakers are expected to decide against raising interest rates again when they gather in Athens on Thursday. Once red-hot, inflation, driven by Russia's invasion of Ukraine in early 2022, has started to ease, while the outlook for the economy has worsened. Consumer prices in the 20-nation currency bloc rose at an annual rate of 4.3 percent in September, its lowest rate in almost two years.

The figure remains clearly above the ECB's two-percent target, but the pain of rising interest rates has been increasingly felt across the bloc. The outbreak of the Zionist-Gaza war has added to the potential troubles faced by the eurozone economy, already weathering the impact of the conflict in Ukraine.

The central bank, which holds one meeting outside its Frankfurt headquarters every year, looks set to follow in the footsteps of the US Federal Reserve and pause interest rate hikes for the time being.

All indications since the last meeting in September were that the ECB's current tightening cycle was "over", said Jack Allen-Reynolds of Capital Economics. Currently, the ECB's key deposit rate sits at four percent, its highest mark in the history of the central bank. But after deciding to hike at each of its last 10 meetings, raising rates at their fastest pace ever, "the ECB won't be in any rush to take further action", said ING bank analyst Carsten Brzeski.

The conflict in the Middle East would "further dampen eurozone growth prospects" and, along with rising oil prices, left the ECB in a more "complicated" position, Brzeski said. "With all the new uncertainties, there hasn't been a better moment in the last 16 months for the ECB to take a pause than now," he added. Some eurozone governments, such as Italy and Portugal, have voiced criticism of hard-to-swallow ECB rate increases, while the enthusiasm for more hikes has tempered among the 26 members of the ECB's governing council. The slowing of eurozone inflation had shown that "our current benchmark rates are appropriate", French central bank governor Francois Villeroy de Galhau said. Meanwhile, ECB President Christine Lagarde has acknowledged the "pain" felt by households as a result of aggressive rate hikes, but has cautioned against relenting too soon. Her emphasis would more likely be on monetary policy staying tight for an "extended period", when the ECB shares its decision, Allen-Reynolds said.

Lagarde's colleague on the ECB's board, Luis de Guindos, has warned that work to tame inflation will take time, with the indicator "still expected to remain too high for too long". Under the bank's current set of projections, published in September, inflation is not set to return to the ECB's target of two percent before 2025. The governing council would revisit the question of hikes at its last meeting of the year in December, when they will have a new set of forecasts at their disposal.

There was every possibility that the eurozone could see a "further worsening of the economic outlook" before then, Brzeski said. Economic indicators



### **Qatar Airways** chief Al-Baker to step down

Oatar Airways did not immediately respond to requests for comment from AFP. Baker has been widely credited with transforming the fortunes of the fledgling airline he took control of in 1997, building it into an internationally recognized carrier. On Sunday it was announced by Qatari authorities that Baker had been removed from another role he also held as chairman of the gas-rich emirate's tourism body. No reason was given for the decision. The circular also confirmed that Badr Al-Meer will be the company's new CEO. Al-Meer is currently the chief operating officer of Doha's Hamad international airport, according to the airport's website. It was not immediately clear why Al-Baker, who helmed the state-owned carrier for over two decades, is retiring. He was appointed CEO in 1997, three years after the airline launched. Qatar Airways representatives could not immediately be reached for comment. It was announced on Sunday that Oatar's Amir Sheikh Tamim bin Hamid Al-Thani had replaced Al-Baker as the country's top tourism official. No reason was given for the decision.-Agencies

DOHA: Qatar Airways' longstanding chief executive Akbar Al- Baker is to step down from his role at the state-owned airline, Oatari local media reported on Monday. Aviation analyst Alex Macheras wrote on the social media platform X, formerly Twitter, that the outgoing Qatar Airways chief told staff "it has been an incredible privilege to lead such an exceptional global team, and the honor of a lifetime to serve my country".

### French IT group Atos slides on nationalization call

PARIS: Shares in French IT consultancy group Atos slumped more than 10 percent on Monday after some lawmakers proposed temporarily nationalizing the firm in whole or in part on national security grounds.

A week after Bertrand Meunier stepped down as chairman amid growing opposition to splitting up the firm and sale of part to Czech billionaire Daniel Kretinsky, Atos shares tumbled 13 percent to fall to an historic low of 3.97 euros. The stock recovered slightly, but remained almost 50 percent off its year high. Small shareholders and some politicians have criticized the planned restructuring and sale, including Kretinsky taking a stake in the Eviden unit that includes cybersecurity, supercomputers and cloud services operations.

Two amendments concerning Atos have been submitted into parliament, including one by Socialist lawmaker Philippe Brun, who called the firm crucial to France's national security.

The planned restructuring of the group "runs the risk of a loss of sovereignty on activities such as supercomputers, security systems integration and cybersecurity," Brun was quoted as saying by the Le Parisien daily. In August, 82 Republican lawmakers urged that Atos be kept under French stewardship, seeing its supercomputer operations as essential for nuclear test simulations and deterrence.

Last week Atos insisted the splitting of the firm into two groups was "the best available solution" but added the planned sale to Kretinsky had been postponed until the "second quarter of 2024."-AFP

### **Taiwan defends Foxconn over** China tax probe

TAIPEI: Taiwan defended tech giant Foxconn on Monday after China launched an investigation into several of the firm's sites, saying that Taiwanese businesses should not be subjected to "political interference". Chinese authorities are inspecting Foxconn's sites in southern Guangdong province and Jiangsu in the east, as well as carrying out on-site investigations into the company's land use in central Hunan and Hubei provinces, China's state-run Global Times reported Sunday.

It did not specify what authorities are looking into, nor any offences that Foxconn may have committed. Taiwan-based Foxconn is one of the world's largest contract producers of electronics, and a key supplier for Apple's iPhones. The investigation comes as selfruled Taiwan-which Beijing claims as its territory and has vowed to seize one day-prepares for presidential elections in January. Taiwan's Deputy Premier Cheng Wen-tsan said on Monday that Beijing's aim is to "distort Taiwan's democracy".

"In a democratic country, choosing leaders and presidents should be done in an environment that is free from threats, incentives, interference, and distortion to freely express one's will," he said. "We do not want Chinese factors to influence the elections." He also voiced support for Foxconn, telling reporters: "We believe that all Taiwanese businesses' investments in China are in compliance with the law." "They should not be subject to political scrutiny or political interference."

Premier Chen Chien-jen adding that in the run-up to Taiwan's upcoming elections, "the government will continue to pay attention to the needs of Taiwanese businessmen and continue to support them".

Foxconn, also known by its official name Hon Hai Precision Industry, is China's largest private-sector employer, with more than a million workers nationwide. The company said on Sunday that it will cooperate with relevant authorities "for the operations concerned", without providing further details.—AFP





## India eyes 'win-win partnership' with Kuwait in IT sector: Envoy

KCCI keen on boosting bilateral ties • CITRA official underlines 'cloud first policy'

KUWAIT: India is looking for a win-win partnership with Kuwait in the information technology sector, Indian Ambassador Dr Adarsh Swaika said on Monday. Delivering his opening remarks at the 'India-Kuwait Information Technology Conference', he said: "Through its 'Vision 2035' economic diversification plan and the new Government Plan 2040, Kuwait is keen to modernize and digitalize its economy and become a smart commercial hub in the region."

The presence of a large number of government and private sector entities at the conference, including CAIT, CITRA, KNET, Public Authority for Industry, KPC, etc speaks of the importance Kuwait attaches to its digital transformation objectives, he said. "The leadership of both India and Kuwait has also identified this area of cooperation as one of mutual interest. This is, therefore, a sector where we can consult, cooperate and collaborate for win-win partnerships," he pointed out.

'India-Kuwait Information Technology Conference', a collaborative event, was organized by the Indian Embassy in association with the Indian Business and Professional Council, Kuwait and the National Association of Software and Ser-

ers from both countries face to face to explore greater collaborations between them," Swaika said.

Giving a snapshot of the exponential growth in India's IT sector, he said: "Revenue of India's technology industry is estimated to be \$245 billion in financial year 2023, with IT exports estimated at \$194 billion and expected to grow at 9.4 percent. It contributed to 53 percent in India's service exports in FY 2023.

India is the third largest and the fastest growing hub for technology startups. With 23 new unicorns, India became the 2nd highest country in terms of number of unicorns added in 2022. Indian industry is consistently strengthening its digital capabilities by adopting deep technologies and focusing on deploying emerging technology solutions such as AI, cybersecurity and IoT, he mentioned.

#### **Bilateral trade**

Addressing the conference, Kuwait Chamber of Commerce and Industry (KCCI) Board Member Wafa Al-Qatami said India is one of the major trading partners of Kuwait, ranking as the top fourth exporter in 2021, with the value of commercial exchange amounting to \$2.362 billion in 2021. "We aspire to advance these relations further and exert more efforts to raise the bilateral trade volumes and reinforce the joint economic ties between Kuwait and India," she stated. She said KCCI is keen on extending all possible cooperation towards achieving the economic goals of Kuwait and India.

has achieved in its ICT sector, value of which is estimated at \$245 billion," she said, emphasizing the significance of the sector. "Companies operating in banking, finance, insurance, telecommunication and many other sectors are keen to be aligned with advanced technologies in order to offer proper digital services. Definitely with the help of India's ICT sector, we can develop the ecosystem in Kuwait and further build our economic relations, he said, adding that the country can build a bridge that could harmonize the entrepreneurial system in the ICT sector. Talking about Kuwait's digital transformation strategy, Altura said: "As a

### **Equities drop, oil** prices ease amid **Mideast crisis**

PARIS: Stock markets slid on Monday, extending last week's sell-off Monday on fears of a regional conflict in the Middle East and worries that US interest rates will remain elevated for longer than initially thought.

The concerns about US interest rates have also been affecting bond markets, with the yield on 10-year US government bonds rising above 5.0 percent for the first time since 2007 during the height of the subprime mortgage crisis. It stood at 5.02 percent in midday European trading according to Factset data. "The trajectory of US Treasuries is not merely a question; it is the only question for financial markets," said Stephen Innes, managing partner at SPI Asset Management, in a note to clients.

"US government bonds are the critical benchmark reference point against which virtually all other global assets are ultimately priced off," he added. US Federal Reserve officials have indicated that interest rates may need to stay higher for longer than previously thought to push down persistent inflation as the US economy remains buoyant.

"The rise in long-term yields is due in part to the resilience of the US economy and the fact the Fed, even if it plays the prudence card, continues to emphasize the possible need of further tightening of monetary policy," said Sebastian Paris Horvitz, director of research at LBP Asset Management.

Innes said that investors have also been worrying about the substantial US federal deficit, the Fed's withdrawal from the government and corporate debt markets, as well as selling pressure from China and other large holders of US government debt. "Hence, the latest leg higher in yields has been driven by factors beyond improving growth expectations, making the carnage in the bond markets far more challenging for businesses to absorb," added Innes. -AFP

### **British Steel** planning to cut 2,000 jobs

LONDON: British Steel is preparing to axe up to 2,000 jobs as part of a cost-cutting program, according to a report, even as its Chinese owners seek large subsidies from the UK government. The potential staff cuts, reported by the Sunday Times, are said to be a key plank of plans to replace its coal-powered blast furnaces with electric arc furnace (EAF) technology producing "greener" steel.

The switch could unlock new funding for Chinese group Jingye, which has owned British Steel since 2020, including up to \$300 million of taxpayer funding, according to the report.

A spokesman for British Steel said the firm was committed to "providing long-term, skilled and well-paid careers for thousands of employees and many more in our supply chains".

But he added it was "continuing to assess our options". "As part of our journey to net zero, it is prudent to evaluate different operational scenarios to help us achieve our ambitious goals," the spokesman added. The GMB union has said in response

#### that it does not accept that "mass job losses are the way to decarbonize the steel industry".

"There are a myriad of options available and a fair, just transition for workers must be at the centre of any plan," it added in a statement to AFP.

The Sunday Times story noted no final decision had been made over the 2,000 possible job losses. British Steel is battling losses believed to be running at £30 million (\$36 million) a month, according to the Guardian. The cuts would decimate its 4,500-strong workforce at its Scunthorpe plant and headquarters in northeast England, it noted.

The UK government said its "commitment to the UK steel sector is clear", noting a funding boost to facilitate greener steel production by Tata Steel at its Port Talbot site in south Wales. "We continue to work closely with industry, including British Steel, to secure a sustainable and competitive future for the UK steel industry," a spokesperson added. Jingye declined to comment. It announced in February plans to cut up to 260 jobs in Britain after being hit by soaring energy costs.

British Steel has also said it plans to shut the coke ovens at its Scunthorpe plant to help the group "build a green and sustainable future". The UK government revealed in September it would provide

£500 million (\$621 million) to fund a new electric arc furnace at Tata Steel's Port Talbot site. However, 3,000 layoffs still loom there. The Labour Party, widely tipped to win the next UK general election, said steel would play a key role in its plans for clean power in 2030.

Labour leader Keir Starmer said during a visit to Port Talbot on Monday that he had "productive" talks

with union leaders about the transition to "green steel". "If we are able to put in place our mission for clean power 2030, that will require more steel-and therefore we want the demand for steel to go up," he said.

"Of course, we need to transition to green steel. But we must do this transition very carefully, protecting the jobs and the skills and the history that we have here in South Wales."-AFP

### Japan PM promises focus on 'economy, economy, economy'

TOKYO: Japanese Prime Minister Fumio Kishida promised on Monday tax cuts as part of a new economic program that he hopes will shore up his sagging popularity. Kishida has seen his ratings plummet to the lowest levels since he took office two years ago, and over the weekend his ruling Liberal Democratic Party (LDP) lost a by-election.

In a legislative policy address to parliament, Kishida listed his economic achievements and pledged to continue fuel subsidies and steps to energize local economies in broad efforts to prop up the flagging Japanese economy. "Economy, economy, economy. Above all, the economy is my priority," he said.

His government has been working on a fresh stimulus package expected in the coming weeks which aims to ease pressure on Japanese households from rising prices. He said Monday the program would include tax cuts for households, encourage corporate investments, and wage growth.

"For the next two to three years, we will intensify support measures that will contribute to strengthening supply capacity including large investments related to national security, such as semiconductors and decarbonization," Kishida said. Kishida, 66, can govern until 2025 but there has been speculation that he might call a snap election ahead of a likely tough internal leadership vote in the LDP next year.

On diplomacy, he said he aimed to achieve stable, constructive relations with China. But he called on Beijing to stop its import ban on Japanese seafood, imposed after Japan started releasing waste-water from the crippled Fukushima nuclear reactors in August. Kishida also reiterated his willingness to meet with North Korean leader Kim Jong-un to work on emotional issues related to Japanese nationals kidnapped by Pyongyang agents during the Cold War. — ÂFP



### Oil giant Chevron to buy rival Hess for \$53bn


**NEW YORK:** US energy giant Chevron will buy its rival Hess for \$53 billion in an all-stock deal, the companies announced in a joint statement on Monday. The mega-acquisition is the latest consolidation in the US energy sector, coming less than two weeks after the announcement that ExxonMobil would acquire Texas shale producer Pioneer for about \$60 billion. Chevron's deal values Hess's equity at \$53 billion, while the total enterprise value of the transaction, including debt, is \$60 billion, according to the statement.

The acquisition will further diversify Chevron's interests, with Hess's assets including an offshore exploration scheme in oil-rich Guyana and a major shale project in North Dakota, along with assets in the Gulf of Mexico and Gulf of Thailand. The deal "positions Chevron to strengthen our long-term performance and further enhance our advantaged portfolio by adding world-class assets," Chevron chairman and CEO Mike Wirth said.

Hess CEO John Hess also welcomed the deal. "This strategic combination brings together two strong companies to create a premier integrated energy company," said Hess, who is expected to join Chevron's board of directors. "I am proud of our people and what we have achieved as a company, which has one of the industry's best growth portfolios including Guyana, the world's largest oil discovery in the last 10 years, and the Bakken shale, where we are a leading oil and gas producer," he added. With the deal, Chevron will acquire 30 percent ownership in more than 11 billion barrels of oil equivalent expected from the block in Guyana, along with holdings in the North Dakota Bakken shale field, according to the statement. The deal comes at a time when crude is trading above \$87 per barrel, a historically high level, which is boosting the profits of oil majors.—AFP

### French geeks plan world's biggest video game museum

rench gaming nerds are planning to open the world's biggest video game museum near Disneyland Paris. The Odyssey Project-named after the first ever console designed by Magnavox in 1972 -- will house one of the biggest collections of games ever assembled. The complex, which will also include a "Japanese village" dedicated to the country's popular culture and cuisine, is the brainchild of collector Ludovic Charles and YouTuber Benoit Theveny, better known to his million followers as Tev.

Charles, 49, has amassed a collection of 2,200 consoles over the last two decades, with every imaginable version of Nintendo, Sega, Sony, Microsoft and other game systems. "I do not want them to sit pointlessly on the shelves any longer," he told AFP at the warehouse where he stores them in southern France.

"Gathering them all was what interested me," he added, "but the goal was always a museum" with an exhaustive overview of the evolution of video games. The pair have already crowd funded more than one million euros to get the project off the ground. They put their heads together last year when Charles put the collection up for sale online for around one million euros.

#### Real part of culture

Theveny, who lives in Tokyo and has been producing popular videos on Japanese and geek culture there, said

the idea was to create an all-encompassing survey of video game history. "The philosophy is not to leave anyone out... from kids of three who play Minecraft to the oldies of 50 or 60 who were there at the beginning and started on the first Pongs," the early tennis-like computer game. He said that video games deserved to "have their own museum and be recognized as a part of our culture, and I think more and more people would agree with me on that." The museum, called "Projet Odyssee" in French, is planned for an extensive greenfield site in the eastern Paris suburb of Bussy-Saint-Georges, not far from Disneyland Paris.

Previous attempts to cash in on video game culture have a chequered history in France. The Pixel Museum in a suburb of Strasbourg close to the German border closed in 2020 after three years and a museum of video games in La Defense, the Paris financial district,

only lasted 10 days. "We have learned from these attempts," insisted Theveny, saying they had the full support of the local mayor who was already working on an e-sports project which will also be accommodated in the complex. They hope construction will start in 2025 with the museum and entertainment village opening the following year. - AFP

### North Korean defectors meet world in 'Beyond Utopia'

arning your subject's trust is never easy for a documentary filmmaker -- but it is even harder when they think you want to kill them.

That was the challenge faced by US director Madeleine Gavin, whose movie "Beyond Utopia" follows newly escaped North Korean defectors as they flee. These include the Roh family and their elderly grandmother, who Gavin met just weeks after they bolted from their deeply repressive, reclusive homeland, and lifetimes of being fed propaganda.

and suspicion" from the family. But despite the powerful brainwashing they had endured in North Korea, even the 80-year-old grandmother's attitude quickly began to shift as she saw the outside world with her own eyes. "She was having none of it... She'd always been told that relative to the rest of the world, North Koreans are the luckiest people on Earth," said Gavin.

"Then to be seeing a world where there are animals, and life, and toilets, even! We were a piece of that puzzle."

Korea to face punishment. Filming the mother's anguish "was really the most difficult thing," said Gavin. "What she has gone through and continues to go through is the worst thing that anyone can go through."

#### 'Guilt'

The other part of the film follows the Roh family as they embark on their harrowing, 3,000-mile overland journey toward Thailand, and freedom. One slipup could see them also repatriated to North Korea, lending the documentary a dramatic tension more associated with Hollywood thrillers.

But Gavin also set out to make something "experiential and present tense," which gives a "voice to actual North Koreans," whose country is mainly known to the rest of the world for its nuclear arsenal and terrifying politics. Even as they flee, the Rohs express a complex mixture of emotions, from wonder and excitement, to anger at what they have long been deprived of, to shame. Despite witnessing prosperity unthinkable back home, the grandmother "did not let up on the idea that Kim Jong Un was this incredible person, with the most difficult job before him," said Gavin. "She had enormous guilt for leaving, and that anyone who defects is basically abandoning him, and how heartbreaking it is for him.'

Perhaps more powerful still is the family's homesickness for the friends, neighbors, traditions and land they left behind. The movie includes -- and ends with -- footage secretly shot inside North Korea and smuggled out by the pastor's network, showing everything from the country's barbaric gulags, to the bleakness of everyday life.

"As Grandma says at the end of the film, 'we're so lucky, but it keeps me up at night thinking about the people who are still there," said Gavin. "And so I wanted to leave the film remembering those people. Because those people are there, and they need us to help bring their voices forward."-AFP

### Coin tosses are not 50/50: **Researchers find a slight bias**

ant to get a slight edge during a coin toss? Check out which side is facing upwards before the coin is flipped --- then call that same side. This tactic will win 50.8 percent of the time, according to researchers who conducted 350,757 coin flips.

For the preprint study, which was published on the arXiv database last week and has not yet been peer-reviewed, 48 people tossed coins of 46 different currencies. They were told to flip the coins with their thumb and catch it in their hand -- if the coins fell on a flat surface that could introduce other factors such as bouncing or spinning.

Frantisek Bartos, of the University of Amsterdam in the Netherlands, told AFP that the work was inspired by 2007 research led by Stanford University mathematician Persi Diaconis -who is also a former magician.

Diaconis' model proposed that there was a "wobble" and a slight off-axis tilt that occurs when humans flip coins with their thumb, Bartos said. Because of this bias, they proposed it would land on the side facing upwards when it was flipped 51 percent of the time -- almost exactly the same figure borne out by Bartos' research.

While that may not seem like a significant advantage, Bartos said it was more of an edge that casinos have against "optimal" blackjack players. It does depend on the technique of the flipper. Some people had almost no bias while others had much more than 50.8 percent, Bartos said.

For people committed to choosing either heads or tails before every toss, there was no bias for either side, the researchers found. None of the many different coins showed any sign of bias

either. Happily, achieving a fair coin flip is simple: just make sure the person calling heads or tails cannot see which side is facing up before the toss.

#### 'It's fun to do stupid stuff'

Bartos first heard of the bias theory while studying Bayesian statistics during his master's degree, and decided to test it on a massive scale. But there was a problem: he needed people willing to toss a lot of coins.

At first he tried to persuade his friends to flip coins over the weekend while watching "Lord of the Rings". "But nobody was really down for that," he said. Eventually Bartos managed to convince some colleagues and students to flip coins whenever possible, during lunch breaks, even while on holiday. "It will be terrible," he told them. "But it's fun to do some stupid stuff from time to time." The flippers even held weekend-long events where they tossed coins from 9am to 9pm. A massage gun was deployed to soothe sore shoulders.

Countless decisions have been made by coin tosses throughout human history. While writing his paper, Bartos visited the British Museum and learned that the Wright brothers used one to determine who would attempt the first plane flight.


Coin tosses have also decided numerous political races, including a tied 2013 mayoral election in the Philippines. But they are probably most common in the field of sport. During the current Cricket World Cup, coin tosses decide which side gets to choose whether to bat or field first.-AFP

"I'll never forget the way that she would look at me," Gavin told AFP. In their minds at the time, "Americans practically only exist to make North Koreans miserable and to kill and attack North Koreans. "We aren't even human beings... that's what they've been taught." Soon after the Rohs sneaked across the closely guarded border into China, a local farmer connected them to an "Underground Railroad" for defectors, run by a South Korean pastor whom Gavin happened to be filming.

The pastor arranged for the family to travel in secret through Communist-ruled China, Vietnam and Laos, braving police checkpoints and a treacherous jungle border crossing.

The movie uses footage shot in China by the pastor's "brokers," before Gavin was able to meet and film them face-to-face herself in south-east Asia.

## Hats, rights and letters: From empire to Turkish republic

n October 29, Turkey marks the 100th anniversary of the birth of its modern republic. A century ago, Mustafa Kemal Ataturk proclaimed the country's status as a republic in the wake of the collapse of the 600-year Ottoman Empire-which at the height of its power ruled much of the Middle East, north Africa and eastern Europe. The empire had started to crumble in the early 20th century, when it became widely referred to as the "sick man of Europe". Ataturk was elected president in 1923, and served in that role until his death in 1938. Seen as a national hero, Ataturk-whose name means "father of the Turks"-led a modernization drive in the war-weary nation. His sweeping reforms included a drive to secularism, a new alphabet, and the abolition of the Ottoman fez hat in favor of Western-style clothing.

#### Latin Alphabet

Ottoman Turkish script-a version based on Arabic script-was replaced in 1928 by the Latin alphabet. The use of a 29-letter Turkish alphabet helped improve literacy rates in the early years of the republic. Ataturk was heavily involved in the national campaign to teach the new alphabet, and crisscrossed the country to introduce it, town by town. A widely circulated black-andwhite picture shows him standing next to a chalkboard, teaching new letters during one of his stopovers.

#### Secularism

In 1928, Turkey amended its constitution, removing a provision that stipulated "the religion of the state is Islam".

#### Women's rights

The modern republic drastically transformed women's status in society. Turkish women were given the full right to vote and to stand in elections in 1934, earlier than in France or Switzerland. The reforms sought to break women's traditional role in society and pushed them to have access to education, to enter universities, and have professions including those dominated by men. Ataturk said women would "walk together with men in social life to support each other".

#### Dress code

The reform was seen as an ostentatious break from Islam, and a visible sign to show those who were supporting Atat-

### Did a computer write this? Book industry grapples with AI

rom low-quality computer-written books flooding the market to potential copyright violations, publishing is the latest industry to feel the threat from rapid developments in artificial intelligence. Since the launch last year of ChatGPT, an easy-to-use AI chatbot that can deliver an essay upon request within seconds, there have been growing worries about the impact of generative AI on a range of sectors.

Among book industry players there is "a deep sense of insecurity", said Juergen Boos, director of the Frankfurt Book Fair, the world's biggest, where the topic was in focus last week. They are asking "what happens to authors' intellectual property? Who does new content actually belong to? How do we bring this into value chains?" he said. The threat is plain to see-AI writing programs allow budding authors to produce in a matter of day novels that could in the past have taken months or years to write. A flood of titles that list ChatGPT as a co-author have been offered for sale through Amazon's e-book self-publishing unit.

Still, critics say the works are of low quality and sense little threat from AI for now. British author Salman Rushdie told a press conference at the fair that recently someone asked an AI writing tool to produce 300 words in his style. "And what came out was pure garbage," said the "Midnight's Children" writer, to laughter from the audience. "Anybody who has ever read 300 words of mine would immediately recognize that it could not possibly be by me." "So far I'm not that alarmed," he added, during a rare public appearance since a near-fatal stabbing attack last year in the United States.

#### 'Still not great'

Jennifer Becker, a German author and academic, echoed his sentiments, telling a panel discussion that the results when it comes to AI writing fiction "are still not that great". "There is a lot of potential to use it—to use it collaboratively. "But I still don't see the point where we really hand over the writing work to AI completely autonomously. That wouldn't make for an interesting book."



Industry players stress however that in some areas there is more openness to dealing with artificial intelligence. "It depends a bit on the genre," said Susanne Barwick, deputy legal adviser of the German Publishers and Booksellers Association, who has been in discussion about Al with publishers. "The field of science and specialist books is already further along and has already dealt with it more." These areas were "easier than the field of fiction, where I think at the moment people still tend to look a bit more at the

risks", she added. Artificial intelligence's relationship with publishing threatens to throw up a host of legal problems, with one major "grey area" being who owns copyright of Al-generated content, said fair director Boos. "Then you get into a real mess, and it is a huge theme. There is also really a lot of money involved," he said.

#### Legal clashes

There are already AI-related legal clashes involving top writers. Last month, "Game of Thrones" author George RR Martin, John Grisham and Jodi Picoult were among several writers who filed a class-action lawsuit against ChatGPT creator OpenAI over alleged violation of copyrights. Along with the Authors Guild, an organization representing writers, they accused the California-based company of using their books "without permission" to train ChatGPT's "large language models", algorithms capable of producing human-sounding text responses based on simple queries, according to the lawsuit. Translation is another thorny area, with some industry players feeling artificial intelligence would miss the nuances and subtleties needed to render complex literature into other languages.

Efforts are being made to make it clearer when AI has been involved in producing a book. Amazon recently released new guidelines that require authors who want to sell books through its self-publishing unit to tell the company in advance if their work includes material generated using artificial intelligence.-AFP

### Spain seizes ancient gold jewelry stolen from Ukraine

panish police said Monday thev have seized centuries-old gold artefacts worth over 60 million euros (\$64 million) that were stolen and taken out of Ukraine illegally. The 11 pieces, including necklaces, bracelets and earrings, were displayed at a Kyiv museum between 2009 and 2013, and were smuggled out of Ukraine before 2016, police said in a statement. "The seized pieces-gold jewelry of great historic and economic valuehad been stolen and exported illegally from Ukraine and were going to be sold in Madrid," the statement added, noting items dated from between the 8th and 4th centuries BC.

Three Spanish and two Ukrainian nationals-one of them an Orthodox Church priest-were arrested as part of the operation, which was carried out with

the help of the authorities in Ukraine as well as Albania, Bulgaria, Cyprus and North Macedonia. Police said the artefacts had forged documents in English, Ukrainian and Spanish to make it look as if they belonged to the Ukrainian Orthodox Church. "These are pieces that cannot be sold through the usual legal channels, such as auction houses," said police spokeswoman Ana Ramon.

Police began their investigation in 2021 after one of the pieces-a gold belt with rams' heads-was sold to a businessman in a private sale in Madrid. This led investigators to the other 10 artefacts which police seized last month from the suspects. The pieces are being studied by Spain's National Archaeological Museum and the country's Cultural Heritage Institute.-AFP





## Kohli hits 95 as unbeaten India down New Zealand at World Cup

Virat misses equalling Sachin Tendulkar's record of 49 one-day international centuries

**DHARAMSALA:** Virat Kohli hit 95 to lead India to a four-wicket victory over New Zealand and a fifth win in five matches at the World Cup on Sunday although the superstar batsman just missed equalling Sachin Tendulkar's record of 49 one-day international centuries.

Fast bowler Mohammed Shami returned figures of 5-54 to help bowl out New Zealand for 273, a total India overhauled with 12 balls to spare in Dharamsala. The Kiwis, who rode on Daryl Mitchell's 130 to post 273, suffered their first loss in five matches and are second behind leaders India in the 10-team table.

India, who lost to New Zealand in the semi-final of the 2019 edition, ended a 20-year wait for a win against the Kiwis in an ICC event after they last beat them in the 2003 World Cup. An in-form Kohli, who hit 103 not out in the previous victory over Bangladesh, put on key partnerships including a 78-run stand with Ravindra Jadeja, who hit the winning four in his unbeaten 39.

"He (Kohli) has done this for us so many years. He backed himself to do the job," India captain Rohit Sharma said of his star batsman after the win. "Kohli and Jadeja pulled us back when we lost a few wickets in the middle."

Kohli fell to Matt Henry in an attempt for the glory shot which would have given him another century. He leads the tournament batting charts with 340 runs. Rohit (46) and Shubman Gill (26) provided a strong start in a stand of 71 before

fast bowler Lockie Ferguson struck in his first two overs to remove the openers.

Kohli and Shreyas Iyer, who made 33, attempted to rebuild and did a good job despite fog descending from over the Himalayas and halting play for about 10 minutes. Left-arm quick Trent Boult sent back Iyer in his second spell, coming around the wicket with a bouncer and having the batsman caught out in the deep. Kohli and KL Rahul, who made 27, then ploughed on before left-arm spinner Mitchell Santner broke through and had Rahul trapped lbw.

Suryakumar Yadav was run out for two in his maiden World Cup appearance after a mix up with Kohli and New Zealand sensed a turnaround. But Kohli kept his calm and along with the left-handed Jadeja saw the team home.

#### Shami stars

Shami, who returned to the XI, set up victory with his second five-wicket haul in World Cups after he helped restrict New Zealand despite Mitchell's fifth ODI ton. "Got a lot of confidence after taking a wicket on the first ball," Shami said after being named man of the match. "It was important to pick those late wickets, you always want your team to be the top side. Very happy that I got those wickets and India is on top of the table." New Zealand lost their openers early after being invited to bat first but Mitchell and Rachin Ravindra (75) put on 159 to get the innings back on track.

### Garcia grand slam sets up Houston, Texas MLB showdown

**WASHINGTON:** Adolis Garcia smashed a grand slam home run and the Texas Rangers beat defending champion Houston 9-2 on Sunday to force a winner-take-all showdown in the Major League Baseball playoffs.

The Rangers pulled level at 3-3 in the bestof-seven American League Championship Series and will try to reach their first World Series since 2011 by winning on the road again on Monday. "Going to be a tough game," Rangers manager Bruce Bochy said. "It's a big game for both sides. It's going to be exciting." The AL champion will open the World Series on Friday against the winner of the National League Championship Series, which Philadelphia leads 3-2 over Arizona with game six on Monday in Philadelphia.

The Astros will seek their third consecutive World Series and fifth in seven seasons, having taken the title in 2017 and last year in the dynasty run. "We've got to come in ready to go," winning pitcher Nathan Eovaldi said. "We don't worry about the World Series. We worry about winning that game. "We knew they weren't going to roll over. We knew it was going to be a dogfight. Now we have to come out tomorrow and be ready." Garcia was ejected from game five on Friday and had to be restrained by teammates after becoming upset when he was hit by a pitch from Houston's Bryan Abreu, who was also ejected. Garcia had struck out four times on Sunday, the last when Abreu retired him in the eighth inning without hitting him, but the 30-year-old Cuban outfielder returned to the plate in the ninth with the bases loaded and crushed a dramatic four-run blast to secure a Texas triumph. "He certainly helped things out," Bochy said. "Garcia, that's him sometimes. He has got the ability to put those at-bats behind him, face a tough pitcher and hit the ball out of the ballpark. "It's about bouncing back, not dwelling on what happened." That's a summation of the season for a Texas team that has been tested. "They are amazing,' Bochy said of his players. "They just don't let adversity get to them. We've had injuries, tough streaks and they keep getting up. Got to bounce back and be resilient.' After tensions boiled over into a melee during game five, the Astros and Rangers faced more intense moments in game six. "We handled it really well," said Eovaldi. Abreu was in the Astros lineup after he appealed a two-game suspension issued by MLB for intentionally hitting Garcia to spark a benches-clearing melee. A hearing on Monday will decide his fate but he could be sidelined for game seven. Jose Altuve, whose three-run homer in the ninth inning brought Houston a game-five triumph, opened the scoring in the first inning of game six when he singled, stole second and raced home on Yordan Alvarez's single.

Both Ravindra and Mitchell tackled the Indian spinners with aplomb by using their feet to perfection and Jadeja went wicketless in his 10 overs. Mitchell, who survived dropped catches on 59 and 69, stood firm despite losing Ravindra and then skipper Tom Latham for five off Kuldeep Yadav, the left-arm wrist spinner who took two wickets. – AFP

### India laud 'Ferrari' Shami after match winning WCup spell

NEW DELHI: India's Mohammed Shami was on Monday described as being "like a Ferrari" following his performance in the World Cup victory over New Zealand as a career which has witnessed a series of professional and private highs and lows took anoth-er twist. Shami claimed 5-54 as India made it five wins in five with a four-wicket victory over the Kiwis in Dharamsala to move closer to the semi-finals. The 33-vear-old sat out the first four games of the tournament but seized his opportunity when all-rounder Hardik Pandya missed Sunday's match through in-jury. Shami remains India's most experienced quick in a fast bowling pack which includes Jasprit Bumrah and Mohammed Siraj. "Mohammed Shami is like Ferrari. Whenever you take it out of the garage it will give u the same speed thrill and joy to ride every time," former India seamer Irfan Pathan wrote on X, formerly Twitter.

**NEW DELHI:** Indian cricketing hero and spin great Bishan Singh Bedi has died aged 77, sports minister Anurag Thakur said Monday, calling it a "huge loss" to the sport. "Former captain of the Indian Cricket team, a bowler who was always remembered by the nation, Bishan Singh Bedi, is no more," Thakur, former president of the Board of Control for Cricket in India, told reporters.

"It's a deeply sad news and a huge loss for cricket. The whole of cricket world stands with his family in this hour of grief." Bishan, who was part of the famous spin quartet of Erapalli Prasanna, Srinivas Ven266 wickets in 67 Tests in an illustrious international career between 1967 and 1979.

Bedi, a left-arm spinner, also played 10 oneday internationals for India between 1974-79. Bedi was often blunt in his criticism of peers, cricketers, and faltering administrators of the sport. With a big turban and a smiling face, he was a regular at cricket events in New Delhi, but his failing health over the past couple of years kept him away from an active social life.

Bedi is survived by two sons and two daughters, a pair each from his two marriages. His younger son Angad is married to Neha Dhupia, an actress and model crowned Miss India in 2002. Former Pakistan captain Intikhab Alam said he was "sad" at his death.

"I had a very cordial and friendly relationship with him, he was a great spinner and human being", Alam told AFP. "It's a great loss for cricket in general and Indo-Pak cricket in particular." – AFP

### Hamilton, Leclerc disqualified from US Grand Prix: FIA

**AUSTIN:** Mercedes star Lewis Hamilton and Ferrari's Charles Leclerc were both disqualified from Sunday's US Grand Prix after their cars failed post-race inspections. Former world champion Hamilton had finished second behind Max Verstappen in Austin while Leclerc came in sixth.

Both drivers saw those results scratched, however, after a technical team found excessive wear of their cars floor planks. The disqualification came following a hearing that took place approximately four hours af-

ter Verstappen, who has already clinched the driver's championship, powered to victory in Sunday's race.

A statement by motorsport's governing body, the FIA, said both teams had acknowledged the findings of the inspection report, stating that the irregularities were likely caused by the bumpy track and the tight turnaround for Sunday's race after Saturday's sprint.

"The Stewards note that the onus is on the competitor to ensure that the car is in compliance with the regulations at all times during an event... therefore the standard penalty for a breach of the technical regulations is imposed," the statement said.

Hamilton's disqualification means McLaren's Lando Norris was promoted to second, with Leclerc's Ferrari teammate Carlos Sainz, who finished fourth, bumped to third. Mercedes driver George Russell moved up to fifth from seventh following Leclerc's disqualification. — AFP

#### Garver sparks Texas

Mitch Garver's solo homer lifted the Rangers level and Garver's two-out single in the fourth set the stage for Jonah Heim's two-run homer to put Texas ahead 3-1. Houston pulled within 3-2 in the sixth when Alvarez singled, advanced on an Altuve single and a Kyle Tucker ground out then scored on Mauricio Dubon's sacrifice fly.

On Sunday, Shami's first ball rattled the stumps of New Zealand opener Will Young who inside-edged the delivery onto his stumps. However, it was his bowling at the death that allowed India to restrict New Zealand to 273 all out after a strong start by Darvl Mitchell, who hit 130, and Rachin Ravindra, who made 75. Shami was so relentless that he was even on a hat-trick in the 48th over. Lockie Ferguson denied him that particular moment. Former India batsman Mohammad Kaif joined in the Shami salutes. "The legend of Mohammed Shami grows with every ball, every innings and every game. Shami you inspire. Congrats on fifer," wrote Kaif on social media. Shami now has 19 wickets in his last five World Cup games and said "everyone should enjoy each other's success" when asked about his feelings on sitting out of the first four matches. Since making his debut in 2013, he has taken 176 wickets in 95 ODI matches with a strike rate of 27.

#### Hate messages

Shami's performance on Sunday came almost two years after the Indian hero faced vicious social media attacks. As a Muslim in Hindu-majority India, he was the prime target for blame when the team was defeated by arch-rivals Pakistan at the 2021 Twenty20 World Cup. Thousands of hate messages described Shami as a "traitor" and trolls made wild accusations of match-fixing.

Superstar teammate Virat Kohli, who was captain at the time, came out in support of Shami and launched a blistering attack on his team's critics, terming them as "spineless" and "pathetic". Shami is no stranger to controversy after a feud with his wife made national headlines following which the Board of Control for Cricket in India withheld his contract in 2018. His estranged wife has levelled allegations of domestic violence. Shami has denied any wrongdoing. Shami later admitted to battling depression and overcoming suicidal thoughts due to weight gain during an injury layoff. — AFP

## Aston Villa thrash West Ham to close on Premier League top four

'We need to play really well to keep it up with the top six teams'

BIRMINGHAM: Unai Emery urged Aston Villa to chase their dreams this season after thrashing West Ham 4-1 on Sunday to close within two points of the top of the Premier League. Douglas Luiz scored twice, while Ollie Watkins and Leon Bailey were also on target as Villa recorded an 11th consecutive home Premier League win.

Villa have been transformed in just over a year since Emery took charge, with only Manchester City and Arsenal having won more Premier League points in 2023. Victory takes Villa up to fifth in the table, but within striking distance of leaders City.

Captain John McGinn has spoken of harboring ambitions to qualify for the Champions League and Emery is focused on at least securing European football for a second consecutive season. "One of our dreams is to be with the top seven teams and to do something in Europe," said Emery, whose side are in the Europa Conference League this season.

"To get European football is very important and that is the work we need to try to do. We need to be consistent in what we are doing." Luiz is just one of a number of players that are performing at a different level under the Spaniard and continued his scoring streak at Villa Park.

The Brazilian became the first Villa player to score in six consecutive home Premier League games when his strike from the edge of the box had too much power for Alphonse Areola in the West Ham goal on 30 minutes. Luiz then took the chance to double his side's advantage from the penalty spot early in the second period after Edson Alvarez tripped Ezri Konsa.

Jarrod Bowen reduced West Ham's arrears just five minutes later when his shot spun off Pau Torres into the far corner for his 100th career goal. However, any hope of a Hammers' fightback was snuffed out by the in-form Watkins on an afternoon that proved a reality check for David Moyes' men.

"I see the players every day and know the levels. We need to play really well to keep it up with the top six teams," said Moyes. "The players are good players but as you can see, if this is the level we need to reach, then we need to improve greatly."

Fresh from scoring the winner against Australia for England in a rare run out at international level as Harry Kane's understudy, Watkins blasted in his eighth goal of the season from a narrow angle. Bailey then exemplified the impressive attacking arsenal that Villa have amassed in recent transfer windows.

The Jamaican was left on the bench as Nicolo Zaniolo started despite being the subject of an investigation from Italian prosecutors over a betting scandal. But Bailey made the most of his 15 minutes on the field as he cut inside Nayef Aguerd with a stepover and fired into the top corner. — AFP

### Dynamic duo Martinez, Thuram leading Inter's **Champions League charge**

MILAN: Lautaro Martinez and Marcus Thuram have rapidly struck up a formidable attacking partnership which will lead Inter Milan into Tuesday's Champions League Group D clash with Salzburg. With 16 goals already scored between them so far this season, Inter's dynamic striking duo have made fans forget former idol and Martinez's one-time strike partner Romelu Lukaku.

The pair have also made last season's losing finalists one of the Serie A title favourites after an uncertain summer in which they were forced to let go key players in attack and defence. Both were on target in Saturday's 3-0 stroll at Torino which gave Inter the temporary lead in Italy's top flight and took Martinez's all-competitions tally to 12 in 11 matches.

Since the departures of Edin Dzeko and Lukaku in the summer Martinez has taken on the mantle of attacking focal point for Inter who are also the highest scorers in Serie A with 24 goals. striker Martinez is already fr ahead of Victor Osimhen, his nearest rival at the top of Italy's scoring charts, and at his current rate of 11 strikes in nine league matches he would smash the record single-season haul of 36 set by Gonzalo Higuain in 2016. "He's a great player, one of the best strikers in the world. Playing with him makes everything easier," said Thuram after last month's 5-1 hammering of AC Milan, in which the France forward scored with a sumptuous strike. Martinez stepping up in such a decisive fashion has made Thuram's return to the country of his birth from Borussia Moenchengladbach that much simpler.

### Verstappen hails 'incredible' 50th career win in Texas

AUSTIN: Freshly minted triple world champion Max Verstappen completed a hat trick of Texan victories on Sunday when he claimed the 50th win of his career in a tense and strategic United States Grand Prix. The 26-year-old Dutchman, who started sixth on the grid in his Red Bull car, worked his way through the field to take control before he came home 2.225 seconds ahead of resurgent seven-time champion Lewis Hamilton, who was disqualified hours after the race when his Mercedes car failed a technical inspection.

Verstappen, who won his third straight title last time out in the sprint at Qatar, said: "Starting from sixth position made things a little more difficult. "Fifty wins is incredible and to do it here I am very proud. Now we keep on pushing for more." Lando Norris, in his 100th Grand Prix, was promoted to second after Hamilton's disqualification following a thrilling race in which he had out-started pole-sitter Charles Leclerc, who like Hamilton was disqualified for failing a technical inspection following the race.

It was Verstappen's third consecutive victory at the Circuit of the Americas and brought him level with last season's record tally of 15 wins. His runaway lead in the drivers' championship now stands at 228 points ahead of Sergio Perez.

"I think the whole race I was struggling with the brakes," added Verstappen, who was booed by sections of the crowd. Norris commented: "Leading the race, we controlled it a lot, but just not enough today. I. just couldn't hold on." George Russell, also in his 100th race, finished seventh but was promoted to fifth following the disqualification of Hamilton and Leclerc. The race began with 16 cars on the grid and four in the pitlane, Aston Martin and Haas having made overnight set-up changes. The temperature was 29 degrees Celsius with the track at 40; tough for tyres.

Norris, with a perfect start, took the lead from pole-man Leclerc in Turn One and a near-frantic opening lap saw Carlos Sainz pass Hamilton for third and Verstappen rise to fifth from sixth. Norris was two seconds clear by lap three as Russell, after falling from fifth to eighth, regained seventh from Perez before Hamilton passed Sainz on the back straight to regain third at Turn 12.

He repeated the move to pass Leclerc for second on lap six and began pursuit of Norris, who led by 3.2 seconds as Verstappen, pacing himself conservatively, overtook Sainz for fourth. On lap 11, Ver-

stappen forced his way inside Leclerc at Turn 12.

Verstappen was first to pit after 16 laps, taking mediums to re-join ninth. Norris reacted by pitting for hards, handing the lead to Hamilton as a strategic battle unfolded. Norris re-joined fourth. Hamilton pitted on lap 21 for hards and re-joined fifth behind Verstappen – a clear signal that Mercedes were risking ceding the initiative by off-setting their stops. — AFP



## Teen striker Marc Guiu snatches Barca win over Athletic Bilbao

**Catalans host Shakhtar Donetsk in Champions League on Wednesday**

**BARCELONA:** Teenage debutant Marc Guiu snatched champions Barcelona a 1-0 win over Athletic Bilbao just seconds after coming on from the bench on Sunday in La Liga, taking the Catalans up to third. Xavi's Barca will face leaders Real Madrid next Saturday in the Clasico just one point behind their bitter rivals, and second-placed Girona, who beat Almeria 5-2 earlier on.

For a long time it seemed like Barcelona would not find the breakthrough against their Basque visitors but striker Guiu, 17, netted under a minute after being thrown on by Xavi. The forward was slipped in by the silky Joao Felix and slotted past Unai Simon, who got a hand to his shot but could not keep it out.

Guiu became the latest on a conveyor belt of youths to make their debuts for Barca as their La Ma-

Tearful Locatelli sinks 10-man Milan as Juve close in on Inter

**MILAN:** An emotional Manuel Locatelli fired Juventus to within two points of Serie A leaders Inter Milan with the only goal in Sunday's 1-0 win at 10-man AC Milan, the Italy midfielder's boyhood club. Massimiliano Allegri's side prevailed at a packed San Siro thanks to Manuel Locatelli's long-range strike in the 62nd minute, seven years to the day after scoring the winning goal for Milan against Juve.

Juve, who like Milan were missing a clutch of firstchoice players from their starting XI, stay third but are closing in on Inter and a point behind Milan who have surrendered top spot to their local rivals.

Milan youth product Locatelli broke down in tears at the final whistle but his shot wouldn't have got past thirdchoice goalkeeper Antonio Mirante had it not been for a massive deflection off substitute Rade Krunic.

"It's always special playing here," said Locatelli to DAZN. "Life took me on another path and I'm playing for the team I should be. But it's amazing that it was my goal which won it. It was emotional." Mirante, starting his first match in over two years, hadn't had a single save to make up to that point, even after Malick Thiaw was sent off five minutes before the break for rugby tackling Moise Kean.

Italy forward Kean then missed a golden opportunity to put Juve ahead on the stroke of half-time when he pushed Adrien Rabiot's deep cross wide from inches out. Milan started the second half stronger but Locatelli's goal deflated the hosts and led to the rest of the match being almost a non-event, as Juve were content to simply control the match rather than press home their advantage.

Mirante did make his presence felt late on, neatly tipping over substitute Dusan Vlahovic's drive with five minsia academy continues to produce gems. "He's been training with us for the whole season, it's important that everyone who comes brings something," Barcelona defender Inigo Martinez told DAZN. "We're happy for him, for the goal, and above all, for winning."

Xavi started Martinez against his former club and 20-year-old Fermin Lopez on the left of the attack, another academy product, with Barcelona down to the bare bones. Several regular starters, including key striker Robert Lewandowski, are out injured.

Felix clipped the top of the crossbar with a shot from Ferran Torres' cut-back as Barcelona looked to get started quickly ahead of a tricky week. The Catalans host Shakhtar Donetsk in the Champions League on Wednesday before welcoming rivals Madrid to Montjuic.

Stephan El Shaarawy pushed Roma to within touching distance of the Champions League places when he lashed the only goal of a 1-0 win over Monza at the Stadio Olimpico in Rome. Roma, who also struck the woodwork late on through Romelu Lukaku and Sardar Azmoun, are seventh following their third straight league win and three points behind Napoli and fourth-placed Fiorentina who face Empoli on Monday.

El Shaarawy's first goal of the season came in the final minute of a tough match against 11th-placed Monza who had to play the entire second half with 10 men following Danilo D'Ambrosio's harsh sending off for two bookable offences four minutes before half-time.

"When I saw Azmoun's shot, more than Lukaku's, hit the post I thought, 'Bah, if that doesn't go in'... but Stephan has a feeling for goals and scoring late so he won the match for us," said Mourinho to Sky Sport.

Mourinho was sent off in stoppage time as tensions flared between the two dugouts after El Shaarawy struck, the Portuguese making a crying motion at the Monza staff. Defeat for Monza was harsh as the away side put up a brave fight despite being a man down for half the match, El Shaarawy's winner the first goal they have conceded from open play since being thumped by Atalanta at the start of September.

Roma were briefly sixth but were bumped down a place by Atalanta who squeezed to a 2-0 win over promoted Genoa which took them up to 16 points, two ahead of Mourinho's team. Bologna are nestled behind Roma on goal difference after beating promoted Frosinone 2-1 while Filippo Inzaghi's new team Salernitana and Cagliari drew 2-2 in a frantic match between two struggling sides. — AFP However the hosts were negated by former Barcelona coach Ernesto Valverde's Athletic, who took the sting out of the game and occasionally sprang forward with both Williams brothers threatening from the flanks. Marc-Andre ter Stegen tipped over an Inaki Williams effort and then parried a strike from the Ghana international, with Martinez producing a sublime block to deny his sibling Nico from the rebound. Approaching the hour mark Barcelona carved out their best chance, when Simon brilliantly denied Lopez from close range, after initially saving from Felix's low strike.

Another followed when Felix fed substitute Lamine Yamal in the area but the 16-year-old starlet dragged his shot wide of the near post.

### Man Utd cannot afford brotherly love from Hojlund in Copenhagen

**MANCHESTER:** Manchester United have no time for sentimentality from Rasmus Hojlund as he faces his younger twin brothers and former club on Tuesday when FC Copenhagen visit Old Trafford. The Red Devils desperately need a win to keep their Champions League campaign alive on what is sure to be an emotional evening in the wake of Bobby Charlton's death. Arguably the club's greatest ever player, Charlton passed away at the age of 86 on Saturday, with tributes planned to the man who scored 249 goals in 758 games for United.

Erik ten Hag's men need the highly-charged atmosphere to inspire them after losing their first two games of a Champions League group stage for the first time in the club's history. Hojlund has been the one beacon of hope from defeats by Bayern Munich and Galatasaray as the Dane has scored three times in his first two Champions League appearances.

A  $\pounds64$  million (\$78 million) move to United from Atalanta in August capped a meteoric rise for the 20-yearold, who Copenhagen sold for just  $\pounds1.7$  million to Sturm Graz in January last year. His father criticized the lack of game time he was afforded by the Danish champions before leaving his homeland.

"He wasn't really given a chance," Anders Hojlund, himself a former professional player, told Danish media outlet Frihedsbrevet. "He only spent six months in the first team... where he mainly had 10, 12 or 15 minutes where he was asked to run everywhere."

But there are still two members of the Hojlund family at Copenhagen as 18-year-old twins Emil and Oscar look to follow in their big brother's footsteps. Midfielder Oscar is expected to be included in the visitors' squad The teenager's arrival helped Barcelona gain the upper hand and Joao Cancelo was the next to draw a save from the watchful Simon.

Xavi brought on Guiu in the 79th minute and with his very first touch he broke into the area and then with another confidently fired past Simon. Full of energy, the striker was soon booked for an attempted slide tackle which caught the goalkeeper as he tried to stop him clearing his lines, as he was roared on by the jubilant home fans.

Barcelona's victory takes them above Atletico Madrid, fourth, while Valverde's Athletic are sixth. "I'm annoyed because it went just past me and maybe I could have done a bit more," Simon told DAZN. "We really wanted to get three points to make a big gap above seventh place." — AFP

at Old Trafford having already made his bow in the Champions League against Galatasaray.

Emil is more akin to his older sibling as a physical forward, but might have to wait for his opportunity to face Rasmus after featuring more regularly for the under-19s. Despite arriving in Manchester as a precocious talent with "still a lot to learn" in his own words, United are reliant on Hojlund to help turn a troubled season around.

Only holding midfielder Casemiro has scored more than Hojlund's three goals this season as the rest of Ten Hag's forward line has misfired. Marcus Rashford has netted just once and looks a shadow of the player that scored 30 times last season, putting more pressure on his new teammate.

Hojlund is also yet to score a Premier League goal, but has shown flashes of the combination of strength and speed that lured United into splashing out on him rather than target a move for Harry Kane as their new number nine. "What I see in Rasmus is completely unique," said Peter Moller, head of the Danish Football Federation. — AFP
